My dear Daniel: I had looked forward so much to seeing you in Boston today on my way to Providence, but as I wired you, trains were not running East last night, and so I had to cancel my engagement in Providence. I am looking forward eagerly to seeing you on the 21st of this month when I will preach in the Harvard Chapel. We have had very heavy snows here and a very cold New Year. I don't recall so heavy a snow in many years. We spent a rather quiet New Year's Day, and a wedding anniversary the next day - mostly at home. Clemmy Lazaron has returned home. 

Dear Dr. Silver:

You will recall that when I last saw you in New York (it was the day after the famous meeting of the emergency council), I extended to you an invitation to spend a vacation with my family at my home here in Miami Beach. This is official confirmation of my invitation which is extended to you and Mrs. Silver and it has the wholehearted concurrence of Mrs. Goodman.

Knowing full well how badly you are in need of a period of rest after the strenuous events that you recently went through, it was not my intention to allow any special engagements to interfere with your vacation. However, this apparently is unavoidable. This morning the Executive Director of the Greater Miami Jewish Federation called me. Somebody apparently told them of my warm friendship for you and it was suggested that I add my word of urging to induce you to be the principal speaker at the dinner of the Federation scheduled on the evening of February 18th. Being now a full fledged citizen of greater Miami, I could not refuse their request.

They have already called the UJA in New York and spoken to Mr. Coons to have him induce you to come to Miami for this dinner. Mr. Coons suggested to them that this be done through some resident in Miami who is a personal friend of yours. This is why they have called on me to do the asking for them.

So, first of all, I sincerely hope that you will accept my personal invitation. This does not bind you to accept the invitation of the Greater Miami Jewish Federation. However, it is likewise my sincere hope that you will not consider it too much of a burden to accept their invitation at the same time. Please be good enough to indicate your acceptance by telegram, not so much for my sake as for the sake of the Federation. They obviously want to set their plans in motion at the earliest moment.

I will refrain from saying much in this letter about the political situation. All I want to mention at the moment is that willy-nilly

I was forced to bring the situation into the local Zionist district. By the way, it is a very substantial district, accounting for a membership of close to one thousand and consisting of a fine, intelligent and active group of men.

From what I have already observed, there is not the slightest doubt in my mind that the country is in the dark and just waiting for real enlightenment. The result is not subject to any doubt. It will be the same as was accomplished in the Brooklyn region, for which result I claim some credit.

General Montgomery is Honorary Chairman of this worthy memorial project which will mean so much to the industrial development of Palestine.

#### INTRODUCTION

A universal language for mankind has been the dream of ages, and the slowly passing centuries have seen many unsuccessful attempts to bring a common language into use, between the different races and nations of mankind

Latin was somewhat of a universal tongue in the Dark Ages, and scholar and lawyer, from Byzantium to the shores of the Atlantic-the boundary of the world at that time, met and understood each other in that language. Since the Gothic peoples, however, had spread themselves over the face of Europe, they gradually grew their own vigorous dialects upon the foundation of the old Latin. It fell into disuse and became completely and irrevocably dead, for all its the living Romance languages.

Among the modern languages, English has come to be almost universal. If it is true that the sun never sets on British land, it is likewise true that it always shines upon English-speaking people. Yet it is not a universal language, for its appeal is only the appeal of modern trade and enterprise. Another and subtler appeal draws us to the language of France, which breathes the art, the beauty and the genius of the Gaul. And the language of Germany is the voice of Science, dispassionate and logical. And now comes a thunderous voice from the East, the language of the Russian, full of rustic, undeveloped vigor. We cannot choose among these one common tongue; they are all needful to create the sympathy of tones and moods that we call civilization.

An effort has been made to "build a language" for universal use. As a result, Volapuk and Esperanto came into existence as artificial languages. They did not take root for they lacked all the rich background that gives vitality to a language. They lacked the fragrance of tradition, that slowly evolves speech as it evolves customs. They lacked a people, for no breathing, human men and women had ever put their burning thoughts into these words. In brief, they sprang into life armed and fullgrown and were denied by the world.

Man was ever given to gazing skyward while the thing he most sought was at hand and within easy In seeking a universal language he ranged that language of the ancient and yet living people that world. had given him religion and enriched his spiritual and intellectual life through untold ages-the language of the Hebrew People.

By Dr. ABRAHAM ZUCKERMAN

An eminent French philosopher once made the illuminating remark that the Hebrew language is like the Hebrew people: ancient, and yet essentially modern. But he did not say-perhaps he did not look deeply into the subject-that the Hebrew language possesses the potentialities of being a great factor in the social and economic intercourse of the world as the Hebrew race is today.

Those who have delved to a great depth beneath the surface of the Hebrew language and have studied it to find its relationship to the languages now studied or spoken by the civilized world, have begun to see that that language above and, in fact, alone of all the other languages is qualified to become a "universal tongue."

There are four different meanings constituted in the virility and grace had been absorbed and inherited by term "universal tongue." Firstly: one method of spoken or written expression understood and used by all the people of the world, therefore the ideal language for man's social relations. Secondly: an auxiliary language to those already established by national sentiments, which would serve in international commercial intercourse, like the proposed Esparanto. Thirdly: a language that should unite the academic world, as Latin in the middle ages; or Hebrew itself which unites the learned Jewish world today. Fourthly: a living language that would incorporate to a great extent most of the prevailing languages, and thus facilitate its study and use.

> Various languages have been considered for the above-mentioned purposes: these had their advantages, but their disadvantages were such that not one has really become significant as answering to those purposes. Hebrew alone possesses all the advantages and least of the disadvantages and therefore is qualified to become the universal tongue.

> Hebrew is the greatest international language in existence because it is the language of the Old Testament which is the foundation of the entire Christian and Hebrew world. As a tongue it is very closely related to the language of the Koran which unites all of the adherents of the Mohammedan religion. On the whole, it embraces the entire civilized world, or the greater and better part of it, about eight hundred million peo-Hebrew has international authors, international teachers, and students and international institutions, namely, all the Christian seminaries of the world, all the prominent universities, and an international people, the Jewish race which is scattered all over the world.

Hebrew is a universal language in more than one through the whole scheme of existence but overlooked sense. It is the common vehicle of the Jewish academic

> Some more or less potent difficulties stand in the way of making Hebrew the universal language, and one of them is the difficult grammar. But, by the compilation of a simplified grammar, these obstacles can be overcome, which is not only feasible but has already been

done. After careful and complete study of modern and Hebrew words have in the course of thousands of years ancient languages I hae arrived at the conclusion that a native of any country need not go outside of his own language to get a fairly good smattering of Hebrew.

As regards the difficult and easy sides of the Hebrew language, one need delve somewhat in the Bible, the Talmud, Midrash, Yalkut and the Chassidic-Cabalistic literature, as well as the codifiers and commentators, particularly the greatest commentator, Rashi. The Hebrew books which have a bigger proportion of "easier" expressions are more widely read, understood and loved, as the Agadoth, Midrashim and Rashi.

For my own pleasure and edification, I compiled two Hebrew grammars; one for that part of the language which is most commonly used ,and the other for academic Hebrew. I showed these grammars (both together consist of no more than fifteen typewritten pages!) to Prof. Malter of the Hebrew Union Seminary, Dr. Hurvich, of Columbia, N. Sokoloff, the leader of the Zionist movement, Ben Jehuda, the greatest student of modern and ancient Hebrew, and other great authorities on the Hebrew language, and the simplicity of my works surprised them. The grammars are so easy they can be mastered in a few weeks. The historic development and the present conditions of the Hebrew language in the various countries and the methods of teaching it, show me that all the difficulties are partly the result of prejudice and partly the result of stubbornness which have no substantial value in the light of historical facts. The language is easy and can be made still easier.

Hebrew was a wide-spread language in the world of antiquity, in the very center of the old world, that is, on the boundaries of Asia and Africa ,and in the vicinity of Europe; and in the middle ages it was a "lingua franca." The language came with Father Abraham into Canaan, and thousands of years later crossed the Alps with Hannibal the Phoenician-Phoenician is only a dialect of Hebrew. She was probably the absolute universal language before the "Confusion of Tongues" at the Tower of Babel (Genesis XI). Abraham com-menced his wanderings with her, and to this very day the Persian and Arabic Jew uses Hebrew in his wanderings over the world. She was also the helpmate in the traffic of the middle ages and served to join the Orient with the Occident, to transfer the precious intellectual treasures of Greek classics and philosophy as those of Socrates, Plato, Aristotle, etc., for these were eventually translated into Hebrew.

Hebrew is thus the only language which for a period of four thousand years has orally and literally pioneered, pilgrimaged and conquered the whole world. History has not only given her the first place as a universal language but has shown that she alone is the universal language. Her remarkable power of resistance for so many years is the best testimonial to that.

I cannot lay too much stress upon the internationalism which the Hebrew language possesses in the Christian and Mohammedan world through the Bible-from the intellectual and moral as well as from the linguistic standpoint. been incorporated into the European languages; if those words were picked out they would be almost sufficient for use in ordinary conversation. It is contrary to reason and to nature to think that the Ten Lost Tribes that were absorbed by the Asiatic nations did not exert an influence over the languages of those countries, for the Ten Lost Tribes were five, or perhaps even ten times as numerous as the Judeans who settled in the Western countries. The living language which they brought with them could not be extinguished without leaving traces. How many years does it take such powerful nations as Russia and Germany have been to forget their languages? It has required many different forces, for about a century, to make the Jews in Germany forget their Yiddish dialect. Did not Moses Mendelsohn for this purpose translate the Bible into German?

And these are the reasons why philologists very often find Hebrew words in the Asiatic languages, even in countries as remote as Japan. The linguistic influence of Hebrew is thus universal. The single words, the "torn off members" of the language must be found somewhere. Nothing is lost in the world. The form of an object may be destroyed but the thing itself cannot be annihilated. The combination may cease but the integral parts which are its natural elements always remain. The same is true of language.

Thus we see that the Hebrew language-elements are spread and scattered all over the globe. The language is therefore in the world, useful to the world, and it is to the interest of the world to choose for its own benefit the very best that history indicates-and history shows us no other language which for a period of four thousand years has struggled so against the greatest difficulties and triumphed so effectually as the Hebrew. The test of four thousand years recommends Hebrew to the world as the only vehicle for its social and economic progress.

#### NOTES

It can be logically supposed that the Jews were called Hebrews because they came from the other side of the Euphrates, the word "Hebrew" is probably derived from "eber" meaning "the other side." Again, the father of "eber" meaning "the other side." Again, the father of Peleg (Division) of the period of the "Division of Languages," was called "eber"-therefore the Hebrew language dates back from before the Tower of Babel

The Hebrew language is an international language, a great part of the literature of every country is composed of works on the Hebrew language-and most of them by Gentiles-the best of the Hebrew dictionaries were compiled by non-Jews; since Reuchlin and at present as Parker, Haupt, here and above all, Gesenius, and the famous Concordance was written by Buckstorff. Muck of the writings of the Prophets were done outside of Palestine. Ezekiel wrote in Babylon; Daniel, Ezra and Nehemia in Persia and under Persian influence; Ieremiah in Egypt.

From the Indiana Jewish Post Friday, January 12, 1945 CHARGES RABBIS, CONGREGATIONS BREAK FAITH WITH CHAPLAINS, WANT PULPITS To the Editor: It was with a great deal of pleasure that I read your editorial of Leceliber twenty-second. It is encouraging to know that there are some laymen who are thinking of the retu turning chaplains and what they will be doing after the war. You, yourself, however, summed up all our thinking in the matter when you wrote, "although words will be appreciated what the chaplains really want and are concerned about are pulpits when they return home after the war." espite some idealistic and glowing promises which were made at the beginning of the war, there have been events and incidents which have been disheartening to chaplains in the ser ice. It the beginning of the war, Habbis entering the chaplaincy were given to understand that the Central Conference of American Rabbis and the congregations would uphold two basic principles. First, they would protect his pulpit, and his right to return to it would be protected; secondly, it would be considered unethical for any pulpit with a vacancy to employ a .aboi on a permanent basis, or for a Rabbi to accept such a pulpit. In short, pulpits were to be frozen for the duration. Generally speaking, the Chaplaincy Committee of the Central Conference of American Rabois has tried to do its. level best to abide by its decision, i.e., that no Rabbi entering the chaplaincy shall suffer the loss of his pulpit. although there have been instances of a breach of ethics where they might have acted with greater force and determination. The second promise, while not officially adopted was a promise nevertheless, and has been apparently forgotten by both Labbis and congregations. Not a congregation with a vacancy was willing to hold its pulpit open till the end of the war!! Further, any Rabbi who for one reason or another did not enter the service profited from the shortage of Rabbis and the vacancies which existed in pulpits. In other words, it paid well to be an "ulcerated Rabbi!" Now there are suggestions being made that consideration be given to Rabbis for secular posts, such as jobs with JDC, UNRRA, etc. However, I think most of us are interested in pulpits, and pulpits only. Would it be too much to suggest that congregations with vacancies in their pulpits instead of rushing to pick up the first available Rabbi, select a chaplain for its Rabbi and hold the pulpit for him until his return? - 1 -

A ..... To the Editor: (cont'd) The congregation would be in no different position than many others who granted their Rabbis leaves of absence to enter the chaplaincy. It would be encouraging to know that there are congregations and lay en who are conscious of our contribution, however small it may be, to our country's cause and the spiritual welfare of their own sons and daughters in the service. Some of us have had many a "shmoos" session on this subject, and I believe that most of my colleagues feel as I do about these matters. Sincerely, BURTON E. Levinson, in this issue is more then a tinge of bitterness and resentment against the American Jewish community. That this feeling is justified is beyond question. Although those rabbis going into the chaplaincy were promised that this sacrifice would not entail the further sacrifice on their part of their chances for successful careers. such has not been the case. Led by the example of Beth Israel Congregation in Houston. which replaced its rabbi over the head of the Assistant, who was in the service, congregation after congregation has employed rabbis in direct disregard of an implied promise. The chaplains know that in most cases, once a pulpit is filled, that pulpit is removed from them as far as they are concerned forever. For the tenure of most rabbis is long enough that successors come from the younger men, and the opportunity once having been lost, is almost never offered again. although there is nothing that will remove the guilt from those congregations, and the rabbis who are now in new pulpits perhaps because there was not the competition of the men in the Chaplaincy, the situation points to more drastic remedy. - 2 -

Like other religious bodies, the Jewish group must evolve a system of placement, so that a congregation in need of a rabbi is furnished the rabbi from a central office. Those who have studied the problem, and know the terrific abuses of the present system where rabbis must compete with one another, with emphasis placed on false values, all agree.

At present, the rabbi looking for advancement, (1) must have married the president's daughter, (2) have some other friend who is a large contributor in the congregation, (3) have the gall to present his name for consideration, (4) be a power-house orator, (5) be in danger of losing his own job for incompetence.

These are not the values on which the choice of a new rabbi should be made. Congregations at one time were made up of men of learning, who placed the emphasis on scholarship, but today's ignoramuses who control congregat ons have nothing in their repertoire of accomplishments to enable them to be wise selectors of new rabbis.

I hardly know how to begin to express my very deep sympathy in the death of your son in action. The story you told about his experience was as a distressing a record as I have ever read, and I do not wonder that you feel as you do.

It is beyond my understanding how a boy, who was half sick most of the time, could have been kept in the Infantry and put into action. I served in the first war for two and a half years, but I never knew of anything like that.

Last summer, through our combined efforts, we were able to get the Army to stop putting 18 year old boys in the Infantry for about six months. The change in policy came too late to help your son and now the young boys are going again. Two 18 year old boys who were graduated last summer from this school were inducted in September, and are now in France, probably at the front.

I have been trying to do all I could to bring about another change, but, as you say, high Army officers just say they need these boys and Congress lets them have them. My correspondence with most Senators and Congressmen has been most unsatisfactory. Unfortunately, these boys, as you say, cannot vote, and there are not enough of their parents to be an active political force.

While it is too late to help your own boy, I sincerely hope you will keep working as I intend to do in the hopes that other parents may be spared this great sorrow. My own 19 year old boy is about to go, or it may be he is on his way now as we have not heard from him for sometime.

I sincerely hope your letter will attract some attention and bring about a change, for if anyone has a right to speak, you have. I know there is little I can say to help you except to let you know you are much in my thoughts. My heart is with you.

In my judgment UNCONDITIONAL SURRENDER is as great a MYTH as "THE FOUR FREEDOMS" and "THE ATLANTIC CHARTER". Any student of history

knows that.

Chief Justice Maxey of the Pennsylvania Supreme Court said in his Washington's Birthday Address in Philadelphia a year ago that anyone who would guarantee the people freedom from fear was either"An ignoramus or a fraud".

20/70 without glasses".

When we realized that the inevitable was at hand we let him enlist, while yet seventeen, on the express and implied promises that he, along with some 450,000 other teen age boys, was to have forty-eight weeks technical training in the Army Specialized Training Corps before being called to active duty. When he became eighteen he was ordered to report. Near the end of his first cycle of basic Infantry training (during which cycle he was forced to march many miles in Size 9 "C" G.I. Shoes when his correct size is 112 "D" ) A.S.T.P. (for him) was abolished. We have seen him once at home since the 4th day of last November a year ago.
In my opinion not one European Nation wanted us upon its soil but

was glad to be relieved of the yoke of British dominance. They want to determine for themselves the kind of government they shall have. They want us to get out now. NOW is the time to withdraw from Europe and



My Dear Rabbi Silver,

I can't resist the impulse to convey to you the following report. I am in receipt of a press release from the Eighth Air Force in England that my son, Lt. Alvin, a bombatdier on a B.17, was awarded the Air Medal "for meritorious achievement while participating in aeriel flight". I know of no finer gift that I could receive at this festival of Purim.

Alvin is your boy too. You doubtless recall him and his brother Robert at the pulpit last October during the harvest festival, assisting you with the Torah.

After his first missions in December he was withdrawn from his regular crew and assigned to the 385th Bombardment squatron. This is a veteran group that holds the Presidential citation for shuttle bombing late in 1943. He was assigned to a lead B 17. And it was while serving in that capacity that he directed the bombing of some very important targets over Germany. Photograps revealed the success of the mission and the award was the consequence. He wrote nothing about this in his letters which we have received two and three times a week. The information came to us in the official release.

You will pardon my natural pride in his achievement. But I know how deeply interested you are in what our Jewish boys are doing at the battle front. So I wanted you to share the exhileration this event has brought to my wife and myself.

Alvin has been in the service two years. Upon finishing his work at high school, he refused to consider college at that time and went to work at an optical factory in Rochester. During the first few months he did photograpic work for the company. But during the last eight months he did precision work on prisms for bombsights. He had already made up his mind that he was going to become a bombardier. When he was eighteen he gave up his work, came home and enlisted as an aviation cadet. When he appeared before the board for his final classification, he was asked whether he cared to change his preference to that of pilot. Believe it or not he said he prefered to drop the eggs. We pray that God will watch over him and bring him safely home. His brokher, Robert, in the service two and one half years has been assigned to M.Intelligence and been training in Japanese, etc. for over a year.

Mr. James Wolf, who has offices in the National City Bank Building, is the manager of the National City Bank Building, the Guardian Building, and the Citizens Building. About two weeks ago he instructed Mr. Palmer, the resident manager of the Citizens Building, to show us four rooms on the sixth floor of that building. Since that time Mr. Wolf has decided he will not rent to us because we are Negroes. Mr. Wolf, as I understand it, is a member of your Temple and the thought occurred to me that a word from you to him might persuade him to rent us the space. Our situation is indescribably desperate and I am certain that, because of our experiences in this connection, you cannot understand our feelings and our thoughts. 

This note is being written by Hope Griswold Curfman and Marvin Krichman. Perhaps you will not remember Hope Griswold. About twenty years ago you were very nice to a little girl on a train when her father, James H. Griswold, found that you and she were both boing toward Chicago on the same car. Now she is married to Captain Curfman and he is stationed here in Topeka along with Marvin Krichman. After finding that we were both from Cleveland and knew you, we began to reminisce in the fashion of people away from home. We found that about ten or twelve years ago Hope and her father went to hear one of your sermons. As far as Hope can recollect, the title of your sermon was, "The Ten Greatest Men in History". We were most interested in your selection of men. but she wondered at your omission of Jesus in the list. Perhaps after a lanse of so many years. Hope's recollection is erroneous, either as to the exact title of your sermon or the list of men included.

When Hope discussed this with Marvin, his position was that Jesus would have been included in your sermon about the ten greatest men in history, unless religious teachers were excluded from the score of the sermon, or the basis for determining the ten greatest men was their deeds during their lifetime rather than the influence they have had in history. Marvin predicates his position on what he believes is the attitude of reformed Judaism toward Jesus: that is that he was a great religious teacher, but not divine.

I was with him again last evening at a dinner at the Wade Park Manor convoked to raise funds for the expansion of the Institute of Technology in Haifa. Your dad is taking a leading part in this enterprise which, from all indications, will be very successful. Dr. Wickenden, of Case School of Applied Science, and Dr. Samuel, of the Haifa Institute, addressed the meeting.

I am sure that if you will follow, as I know you will, the clear teachings of Judaism when explaining to your children some day the tenets of our faith, you will not have to resort to forcing upon them the acceptance of miracles. Our belief in God is not based upon miracles, but upon a contemplation of the Universe which God created which reveals Design and Intelligence, upon the manifestation of God in the evolutionary processes of history and upon the profound experiences of the inner life of man. There is no conflict between Religion and Science. The conflict is between superstitution on the one hand, and materialism which parades as Science, on the other.



I want to state a situation and I hope that you will understand the spirit in which this letter is written.

Sometime ago, we wrote to you asking if you would be willing to exchange your bulletin for our paper. This arrangement has proven of untold benefit to The Post, not alone in the fact that we have found your bulletin interesting and often a source of news, but, just as important, in the fact that you were thereby able to become acquainted with The Post.

Now, however, we have decided to ask for a paid subscription from every rabbi on our complimentary list.

I do not want to hide behind the paper shortage, and I want to state the case frankly. We have been spending a lot of money on expanding our news coverage and probably now have a larger budget for news than all the other Anglo-Jewish papers combined and must be somewhere near to spending as much for actual news as the Jewish Telegraphic Agency, and certainly more than the independent Jewish Press Service.

This has been a great strain on us, especially since our advertising department has not been able to bring in enough revenue to warrant this kind of expenditure, and since we do not seem to be able to get any national advertising to speak of, we have been forced to check into every possible additional means of income.

We could, of course, cut down on our news, or cut down on the number of pages in the paper, but I think you will agree that this would be unwise, for any number of obvious reasons.

Dear Dr. Silver,

May I ask an especial favor of you. I know that your time is taken up with many important things, but if it is at all possible I should like to have you give me a few minutes of your time to discuss a personal problem.

Briefly, my problem is one of a mixed marriage that will not take place until early in Nineteen hundred and forty-six (1946). The young man involved is an Englishman, a research scientist, who is at present working on the problem of malaria in a remote district of Northern Rhodesia.

I, as you may have gathered, am Jewish, extremely proud of my background, and with strong Zionist tendencies.

When Mr. Robinson comes to the United States, on his very limited leave, we want to get married as soon as possible under the sanction of Jewish Law. The difficulties are, of course, that Mr. Robinson is not confirmed in our faith, and living in the deepest jungle gives him no chance to contact a rabbi in Africa for instruction.

This is essentially the whole story, except that I may add that we are both much concerned over what can be done. This, in view of the fact that Mr. Robinson, being both liberal and pro-Zionist, wants more complete instruction than just the merest details that will make him acceptable to our Jewish Faith and People.

If you don't consider it too presumptuous of me, may I ask you to grant me an appointment this week. A friend of mine, who knows my story, and upon whose suggestion I am writing to you, will be leaving Cleveland this forthcoming Saturday, and I should like to have her with me at this meeting..

I write you this note on the eve of Passover. We are preparing here for the celebration of the Seder service tonight. I hope that you, too, will be able to participate in the ancient and beautiful ceremony of the Seder.

The war news which has been pouring in during the last few days has been very thrilling and exciting. The air is full of all sorts of rumors on the eve of our Festival of Freedom and it looks as though the final defeat of the worst enemies of freedom of our generation is near at hand. The sooner the better.

I trust that you are well. I have not forgotten the long letter which you sent me some time ago. I have taken the liberty of sending on your suggestions on what the servicemen in the armed forces can do in the matter of combatting anti-Semitism to the Anti-Defamation League of the B'nai B'rith and to the Jewish Welfare Board. I think there much substance to your suggestion. Something along the line which you suggest is already being worked on. A great deal is being done of course here on the home front in the matter of good public relations and the elimination of frictions between religious and racial groups. Much more of course needs to be done. A good deal will depend on the economic conditions which will prevail in our country after the war and how smoothly our economic life will be re-adjusted to peacetime pursuits. If there is no large-scale unemployment and depression after the war, the problem of anti-Semitism is not likely to be very serious.

Here at The Temple we are all busily engaged in the customary religious and educational activities and the added war responsibilities and tasks.

With all good wishes and hoping to see you when you return home, which I hope will be soon, I remain
