Dr. Millis, Front and Center

TO MANY of you alumni Dr. John Schoff Millis, new president of the University, is still just a name.

This will be an attempt to add flesh and substance to the man you will grow to know better in the coming years. That you will know him and grow to know him well is the personal desire of the educator and scientist who in September became Reserve's tenth president.

"I am anxious to see, meet, and come to know as many of our alumni as is humanly possible in the shortest time," Dr. Millis said as he revealed the following proposed itinerary for his visits with alumni chapters this academic year:

Cleveland alumni will have the opportunity to hear Dr. Millis at the October 19 luncheon meeting.

This may seem like a fairly rigorous tour, but for Dr. Millis it is merely a continuation of the practice he followed during his eight years as president of the University of Vermont and State Agricultural College—that of scheduling annual "one-night stands" over a two-week period. During that time he met with every alumni group from the Atlantic to the Rocky Mountains, to give them a chance to hear an annual report explaining what was being done at their university and why.

Trim and athletic the new president takes these barnstorming tours in his stride. And his stride is a long one, as might be expected of a man over six feet tall. An outdoor sports enthusiast, the jovial educator likes to relax after a heavy day of administrative duties with bowling, a swim or a game of tennis. Hunting and fishing vie for top honors should there be any free days in his busy calendar.

Strict scientific training and his eight years in Vermont have instilled in President Millis the characteristic of appraising the facts before "sticking his neck out."

Rapidly acclimating himself to Cleveland and the Reserve campus, the genial 45-year-old Millis considers his position at the University a "very challenging" one. One thing which has impressed him particularly, in his short time here, has been Reserve's unique ability to preserve the invaluable method of



individual instruction. The close relationship between faculty and student body is an ideal situation, he feels, and to be able to keep education on this basis rather than to give way to mass production methods as the University has grown is a miraculous undertaking which, in his opinion, Reserve has mastered.

Maintaining the belief that Reserve practices what it preaches, the president observed that it is almost a universal conviction that education is a continuing process from the cradle to the grave but "very few institutions have the courage to meet their obligation."

In point, Cleveland College is distinguished by the flexibility of its adult education program. Here is a case where the institution accommodates itself to the needs of the student. In this, he observed, Cleveland College is distinct from the majority of America's educational institutions which have a fixed pattern into which the student fits himself.

As there is "no single road to an educated man," Dr. Millis believes "education must be as varied as a man's makeup demands."

Turning from the president's impressions of Reserve, it is interesting to consider Dr. Millis' impressions on others.

Lawrence C. Spieth, chairman of the committee that recommended Dr. Millis' appointment says of him, "He is in the prime of life, has a delightful family, has had splendid educational preparation, is experienced and has been highly successful in university administration, and he has the energy, the vibrant personality and the understanding of present-day problems needed to make him a strong and constructive leader for our university, as well as to win for himself the respect and loyalty of our faculty, students, alumni and of the public at large."

It might be pertinent to introduce the Millis family at this point. Literally it consists of the University head's slim charming wife, Katherine, their older daughter, Jean, their younger daughter, Alice, and the youngest member of the family, Harry; but no

George Can't Do It for You!

If you have chronic respiration the chances are pretty good that you also have public relations.

From the corner newsstand to U. S. Steel everyone has public relations.

The problem is: Are they good?

Much has been committed and omitted in the name of public relations since there are endless definitions of the term.

Twenty years in the field, combined with experience in the editorial rooms of two Cleveland daily newspapers, bring me to this evaluation of the two words when applied to the profession and the practical daily functioning of practice: It is the application of common sense to the building, creating and maintaining of goodwill. It is as simple as that to define and almost as simple to practice.

This may come as a surprise to many who still confuse publicity with public relations. The mistaken notion that public relations is only a flossy label for press agency is still in evidence. The observation, and the application of that kind of thinking, are shallow indeed.

Public relations is "what you do."

Publicity is "what you say."

DOING COMES FIRST

Obviously the "doing" is the first consideration. Without that premise all is but "tinkling of brass." Good publicity methods and technique make you articulate, but actions speak even louder.

The simpleton fools only himself in whitewashing a coal pile. The first rain shows up his stupidity.

There is a very close correlation between the balance sheet item of "goodwill" and the attention a company pays to its public relations.

Today, and in the days immediately ahead, there is and will be greater appreciation of the importance of relations with the public. And the "public" is in reality a composite of many special and separate publics when you are thinking as a company, a university, an association, a movement, or a group which lives in the world and not in a vacuum (intellectual, that is!).

PUBLIC OPINION

James Russell Lowell once sagely observed that "the pressure of public opinion is like the pressure of the atmosphere; you can't see it—but all the same, it is 16 pounds to the square inch."

Friedman served on the editorial staffs of the Cleveland Times-Commercial and the Cleveland Press, being magazine-section editor of the latter paper and assistant science editor of the Scripps-Howard Newspapers, prior to entering the public relations field. He was special correspondent for the Cleveland Press and Cleveland News in Paris, and served as director of public relations of the Brush Foundation at the Medical School of the University, before establishing his own public relations firm.

Let's translate all this philosophy into the practice of the work-a-day world: What do people think about your company, your university, your organization? Why do they think that way? How are their impressions formed? Why do they prefer doing business with you OR your competitor?

Sometimes the answer is found in so simple a thing as the way your telephone is answered or in the attitude of a representative of the company in handling a matter of either great or little import.

All the tons of rhetoric in the world will not create a feeling of goodwill on the part of your public if your actions do not coincide with your words.

Good public relations is something everyone can practice—and should. In terms of an industry, a company, or an organization, professional assistance and counsel are often required. All the counsel available, however, will mean little unless those engaging such service practice good public relations and have it uppermost in their policy-making.

As has been the case of other professions, public relations has been evolving to a status and competence that is giving it increasing importance and appreciation in the daily functioning and thinking of society.

Toward providing the training for a career in public relations, several colleges and universities have been providing courses. Boston University has the distinction of being the first of our universities to have a School of Public Relations. In addition to a complete faculty, experts in the field are brought in for special lectures from time to time.

NO FEATHERBED

Lest the reader be led to vision this profession as something idyllic,

officed in a silvan bower, surrounded by all the world's sweetness and light—with a series of cocktail parties and a bevy of beautiful girls thrown in for good measure—let him stop right there. This is no dream-world career. For the conscientious practice of public relations is an around-the-clock job.

Here is a career that demands much of those who seriously practice it. Interest in people, endless questioning, reading, study, stamina, good health, and a top-grade olfactory apparatus are basic requirements. Experience, as in any area of usefulness, is invaluable.

THE NEW PROFESSION

It has been wisely observed that any practitioner of public relations should "be ready to resign for a principle. If he isn't, there's no use of his talking of the new profession of which he is a member, because he is already a member of the oldest."

The need for trained, competent people is being more keenly appreciated every day, and by top leadership in many fields. It is only logical to look to great educational institutions for that training. Established public relations firms and the departments of companies and

organizations can provide further training and practice. They will look to the colleges, in fact, as a good source for personnel.

A LOOK AHEAD

The recent special courses in human relations in industry, which are being provided by Harvard's School of Business Administration, have been attended by business executives from every section of the country. I have talked with many who have attended the courses and they are enthusiastic and appreciative. The planning radars of other important universities, ours included, should be set in that direction.

Cleveland's position in the nation and in the world gives added reason for the look-ahead by Western Reserve University.

Panaceas and "planned economies" are not the answers to the problems affecting our way of life and its future. Tinkerers abound and experts are all too few. Sound public relations has a real contribution to make in the basic business of living and working together.

Training men and women for that job is an assignment worthy of the best efforts of our universities. A world still wearing the bandages and scars of the recent struggle to maintain decent human values can use such help.

And it all adds up to "what we do" and not "what we say."

Dear Harry:

The long finger of coincidence is again at work. Just as I contemplated writing you a note to tell you how much I appreciated your review of Morris R. Cohen's autobiography, which I read last night, comes your letter.

You do me honor in wanting me to join those who are competent to write about Harry Sheffer. The word "saintly" is seldom used with even approximate relevance to a mere mortal, but you do no violence to language in drawing on it for Harry. And the fact that despite the cruelties to which the fates have subjected him, he has manifested shrewd humor hardly detracts from saintliness. Strange also - but not too strange - that you should use the word "seminal" in regard to Harry. That is the word I have often used in talking about him - of course not by right of my own judgment which, to my knowledge, men like Bertrand Russell and Whitehead, have expressed.

Really, I have no business in the company of those who are entitled to write about Harry. At best I could only manage a few words about him as a person and convey some sense of the influence he exerted at Harvard. Would it be appropriate for me to write a foreword or something like that?

From this you will gather that I do not know a half dozen men to whom I would be equally eager to pay the tribute of respect due to a consecrated thinker and a pure spirit.

What you wrote about Morris pleased me enormously. I quite agree with you in thinking that his autobiography is the most important of his writings and will most effectively perpetuate his memory.

The colleagues, pupils and friends of Prof. Harry M. Sheffer of Harvard University are planning to get out a volume of essays in his honor. He is close to retirement and his work has been so seminal and his influence so deep-lying that those who are aware of it want to make a gesture of acknowledgment and recognition. Most of the essays are already in hand. Among the very many distinguished contributors are Mr. Justice Frankfurter, Bertrand Russell, Ralph Barton Perry, and Norbert Wiener. The Department of Philosophy is providing a subvention of \$500 toward the publication of the book. About \$2,000 more are needed. Knowing your interest in the progress of the mind and your awareness of the originality and importance of Sheffer's work, I turn to you, not for the first time, for help in raising the remaining \$2,000. I know how burdened you are with many generous responsibilities, but I feel that this undertaking is one that merits your particular interest.

Dear Mr. Fels:

I am enclosing copies of two self-explanatory letters: (1) from Felix Frankfurter to Horace Kallen (May 27, 1949) and (2) from Kallen to me (October 4, 1949).

Professor Harry Sheffer holds the Josiah Royce Chair of Philosophy in Harvard, the only Jew ever to occupy such an important post. His specialty is Symbolic or Mathematical Logic, a subject of which I am as ignorant as the Theory of Relativity, but I have known Sheffer for over a third of a century and am just as enthusiastic about him as are Frankfurter, Kallen, Bertrand Russell, Irwin Edman and as was our friend, the late Morris R. Cohen.

In his letter to Kallen, Frankfurter refers to the cruelties to which the fates have subjected Sheffer. In the middle twenties he had a severe mental breakdown and spent eighteen months or two years at Johns Hopkins under the care of Adolf Meyer, the renowned psychiatrist. At that time Julian W. Mack and I raised about \$10,000 to salvage Sheffer's mind. Among those who contributed to the Fund were Julius and Lessing Rosenwald, Louis Marshall, Mortimer L. Schiff, Jules E. Mastbaum, Felix M. Warburg, you and others.

In recent years Sheffer has had periodic relapses; but continues to exert tremendous influence; so much so that though Sheffer has reached the retirement age, President Conant has asked him to remain on the staff two or three years longer.

Notwithstanding the fact that I am involved in many causes and have not yet completely recovered my full strength, I nevertheless considered it a great privilege to accept Kallen's assignment to raise the sum necessary for the Festschrift which is bound to have great therapeutic value.

Hoping you can see your way clear to contribute to the Fund, I am, as ever

Dear Rabbi Silver:

This is by way of our reminder that it was in the month of November last year that you sent in your generous contribution of \$50 for the League. I am writing now to express our hope that it may be possible for you to renew this contribution for 1949.

As you well know, since you were our chief leader in the movement, the Consumers' League of Ohio initiated the campaign for Unemployment Insurance in this state in 1930. Two new issues in the field of Social Security are now demanding our attention: (1) health insurance, which is being so badly misrepresented, and on which we will continue a program of public education; and (2) the proposal to provide disability insurance for Ohio workers who are not able to earn because of illness.

We are planning to cooperate with the commission recently authorized by the Legislature to recommend legislation in this field. In addition, we expect to push ahead on the campaign to get minimum wage orders for the women workers in the local retail and service trades in Ohio, many of whom are badly exploited.

Here's hoping that all is well with you and Virginia, and the boys, and that you may have a chance in your busy life to still remember our League and send us a check.



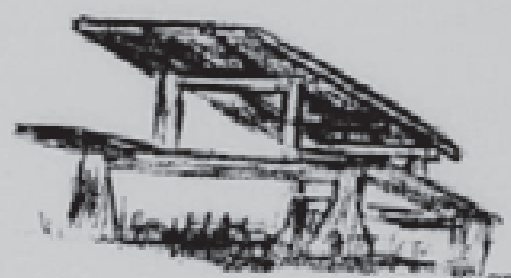

By setting the machines the width of the factory, we were able to increase our aisle space 12" and the storage bins between the machines from 16" in width to 18". (Pictures 1 and 2)

IMPROVEMENTS A MADE ON SECOND

Here is a picture explanation of the improved changes made on Second Floor, at PRINCESS PEGGY, INC. during the vacation period.

Our main object is to give each operator a comfortable working space and to solve our ventilation problems.

We feel that these changes are most helpful. However, we are anxious to have any additional suggested improvements which our workers may have to offer.



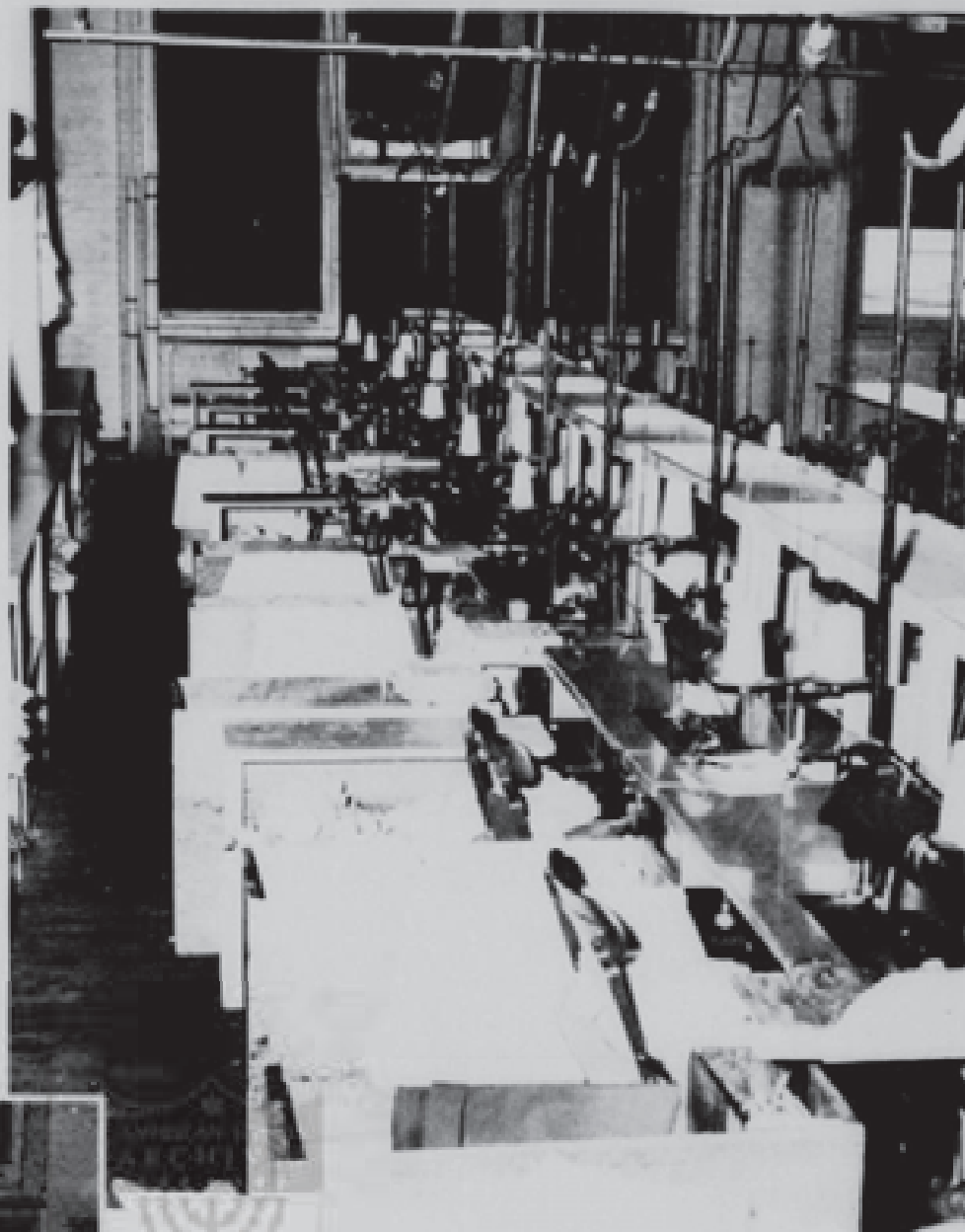
In our skirt and waist joining department, we added an 18" extension to each machine board and placed storage bins in front of each machine so that finished work can be dropped away. (Picture 3)

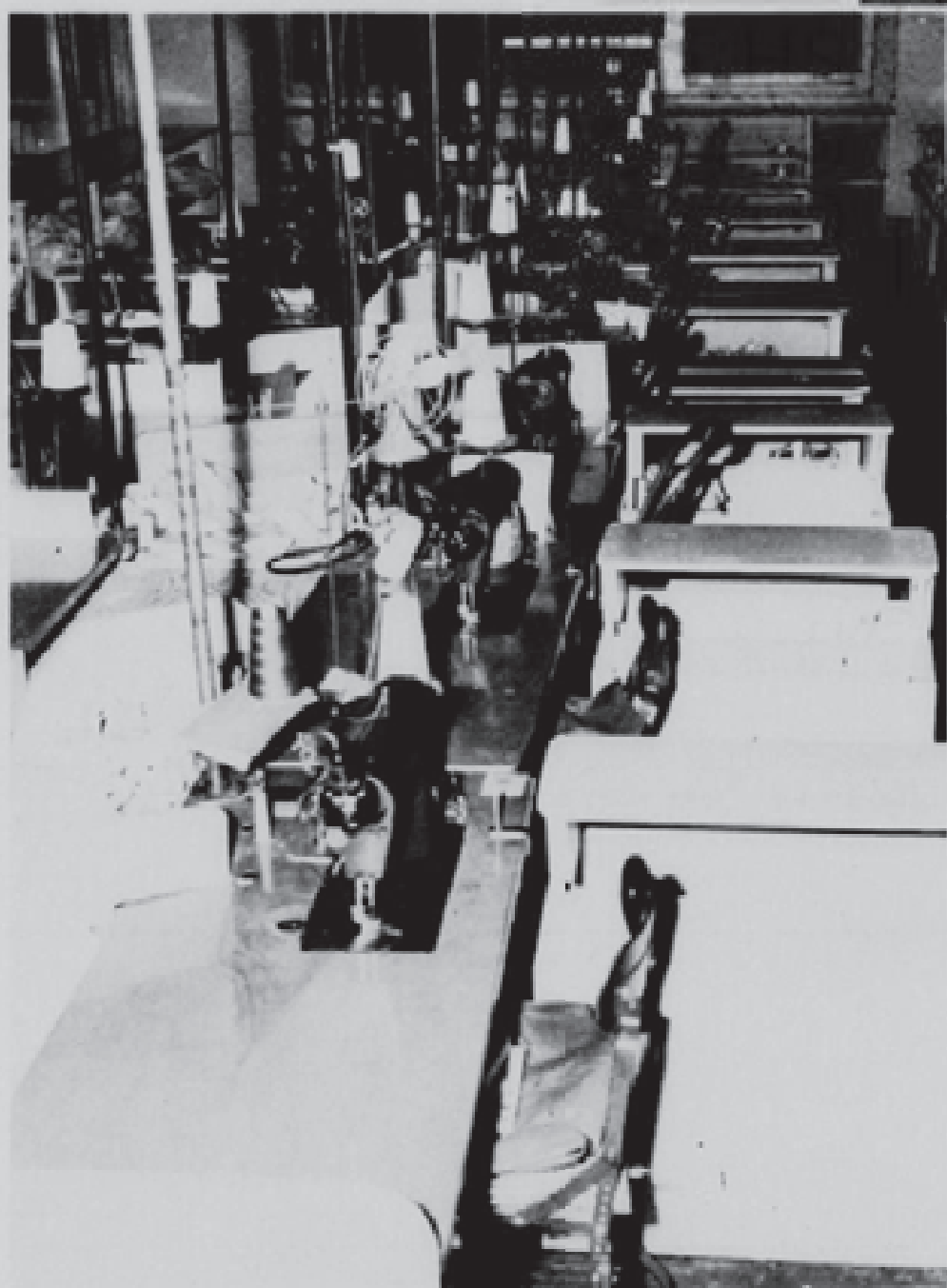
ITS AND CHANGES COND FLOOR . . .

VENTILATION

We have installed at the head of each line of machines a 24" intake fan and have turned the 16" oscillating fans so that all fresh air brought in is moved directly across the factory to where we have four 48" exhaust fans. (Picture 4)

In addition, we have installed a 120-volt feed rail the length of the building, with drop cords and extension plugs at each line of machines. If a worker so desires she can connect her individual fan as shown in Picture 5.

ואולם אין ברצוני, כסובן, להטרידך בהשתפכות הנפש שבכתב משום זה שלא הייתה לי האפשרות לשוחח אתך על עניינים אלה בפאריס. הפעם, רצייתי לנגוע דוקא בעניין ממשי, שיש בו חשיבות חמרית ורוחנית כאחד. זה הוא מפעל "בית סוקולוב", שכידון לך, החלטנו להקים בתל-אביב, בתוך בית העיתונאי היהודי אשר בישראל ובתפוצות. כמדומה ששוחחתי אתך פעמים אחדות על חכניה זו, בימי שהותך בארץ. יש לנו מגרש גדול לבנין זה (4 דונמים, שהם בערך יחסי לשטחי אמריקה כמו כמה מאות אקרים) ברחוב מרכזי ובמקום יפה (ליד הקריה, סול המגרש, שעליו יוקם הבית האמריקני מטעם Z.O.A.) ויש לנו כבר חכניה הבנין, שעלו לנו בשעתן ל-1600 ל"י. ואולם הוצאות הבנין, לפי המחירים של היום, יעלו פי ארבעה מן הסכום הנמצא עתה בידנו לצורך זה, ושהוא מגיע רק לחמישה-עשר אלף ל"י. אני רוצה להצביע, כי לפי החכניה לא יהיה בית זה רק *Pure Club*, לפי המושגים המקובלים, שהוא נחוצ כאן מאד, סחמת ההתעניינות העולמית בפינה זו שלנו, וסחמת העבודה האינטנסיבית הסרובה של העתונות המקומית. ושאיפה ליצור בתוך תל-אביב הסואנת והצפופה מין טריטוריה חפשית, בלתי-תלויה, אצילית ברוחה ובהליכותיה (לולא דמיסתפינא הייתי אומר מעין ווטינן ספרותי) - שחיה גם יפה-נוף סבחינה טבעית, בצורת גן נרחב ומרשאות וגם בית מועד לכל אמן, עיתונאי ואיש ציבור הרוצה להשתהדר סטסגרת הספלגו שלו לזמן קצר - וכאלה רבים הם ביחוד כאן, בארץ המפלגות. במסעדות עתונאי הם יכולים לפשוט את השריון החיצוני-המפלגתי שלהם, הואיל שגם ביחסים שבינינו, העיתונאים עצמם, למרות הבדלי ההשקפות, עשינו את המועדון שלנו לנייטרלי, ולמקום שבת-אחים. בבית זה ימצאו גם חדרים לאיכסון אורחים עתונאים מתו"ל, יהודים ולא-יהודים, יהיה אולם לכינוסים בינלאומיים, ויהיה מרכז לקשרים בין העיתונאים היהודים שבכל העולם.

העובדים למען עם ישראל בכל הלשונות ובכל הכתיבות. כיון שלפי דעתי, ההכרח באיגוד כזה של עהונאים יהודים מכל העולם, מתברר יותר ויותר.

כדי שלא יאבד בתוהו חזון יקר כזה, שכבר הוסצא לו בטיס מעשי די מוצק בצורת מגרש והון מסוים, הריני פונה אליך, ד"ר סילבר היקר, בבקשה לתת לנו יד בהגשמתו. חושב אני, כי תראה לך לזכות להיות האיש המרכזי בסיסוס חזון זה, אשר יהווה סציאות סונוסנטלית ונשגבה בלבה של חל-אביב. אם אפשר היה לגייס אנשים ואמצעים ענקיים בארצות הברית לשם הקמת סכונני-סדע ברחובות, לא סן הנסנע לגייס אמצעים קטנים פי סאה סאלה לשם הקמת סרכז כזה בחל-אביב, אשר סטבע ברייתו יהיה שזור יום בתיי הסדינה הישראלית ויעסוד בסרכז ההתענינוח העולמית ההולכת וגדלה.

ובכן אפוא: הרי הזמנתי הפשוטה לפניך: לעסוד בראש הפעולה וסיסוס הקמתו של "בית סוקולוב". אין כל ספק, שכלי עזרה בארה"ב לא נוכל כאן לזוז לקראת הגשמת הספעל, אבל עזרה זו אינה יכולה להיות בצורת סגביה, כי אם בצורה של התססרות סצרו של חוג סצוסצם הכולל בעלי-שם ובעלי יכולה. וסציאותו וארגונו של חוג כזה הוא, לפי דעתי, הכשרון שלך. אחת הוכל בנקל לתת לאותם האישים גם את הסעוף, וגם את ההתלהבות, וגם את דרכי הארגון. אם הסצא, כי סן הראוי וסן הסועיל יהיה, אם אני או שניס-שלשה חברים ססלנו יבואו לעזור לך בפעולה זו, אנו נכוניס לבוא לארה"ב לשבועות אחדים. אבל עיקר השאלה הוא: אם תסכים לתת יד לביצוע ספעל זה, אשר ערכו התרבותי, הצבורי והסדיני, לא יסתיים עם הקמתו של הבית, כי אם להפך, יתחיל לצסוה ולהתפתח ולגדול סיוס ליום סיר לתנוכתו.

לחשובתך החיובית והסידית אנו סתכים, ואני בסוה, כי אחרי שיקול-דעת רציני הסצא את העוז וההתלהבות להרתם יחד עם אבור העהונאים בישראל בספעל יפה זה.

I had the pleasure of coming in contact with you at the Zionist Actions Committee and also through my visits in this country. Now I would like to have that pleasure again.


The purpose of my mission here is to settle certain important matters regarding the activities of my movement.




It is a pity that certain group--say about 100--were not at that dinner and of course did not hear the address nor are they even willing to read it even if it was available.

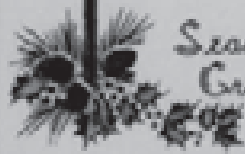
