ESTABLISHED 1804 UNIVERSITY CENTER CLEVELAND 6, OHIO Our 157th Year March 9, 1961 Mr. Bertram Krongold President of The Temple East 105 Street and Silver Park Cleveland 6, Ohio Dear Mr. Krongold: I am writing to you at the suggestion of Rabbi Daniel Silver. Panks-Baldwin Law Publishing Company wishes to erect a modern two-story office building to the rear of our present offices. We hope to commence construction during the early part of the summer. A major problem is the fact that the new building would substantially eliminate our present off-street parking area. It is necessary for us to secure other parking space (12 car maximum) for our employees before going ahead. If at all possible, we hope we may effect some arrangement with The Temple for the use of a portion of your parking lot in the area adjacent to our rear property line. This area would be used only for employee parking and would not be used for other access to our offices, or deliveries. The new structure would be entirely separate from and additional to our present offices. It will scarcely be visible from East 105th Street or The Temple Area -unless and until the adjoining apartment building to our north might be razed. The structure would be a modern two story building with full basement, entirely air conditioned and completely fireproof. Although of a modern style of architecture it would harmonize with the present offices and adjoining structures. Our architect is Willard Hirsh. The new offices will provide additional space which we shall require in the years ahead. Prior to use of all space, we have an allied publishing operation (owned by me) which will occupy the second floor. Upon completion of the new building we would raze our present frame garage and landscape the rear yard extending approximately 54' to our rear lot line (and your parking lot). To give you an idea as to our property, with the location of present buildings and the new structure, we are enclosing: (1) A survey plat (the proposed structure in red).

We love our present location and intend to stay here for the foreseeable future. We are wide open to your thoughts as to an arrangement for our use of your parking space. Here are several suggestions as to the type of arrangement we might effectuate: (1) An agreement, subject to cancellation by either party on thirty day notice, whereby Banks-Baldwin would have the use of space to accommodate up to 12 vehicles in the area at our rear lot line in return for paying a stated amount toward expenses for upkeep of your parking area. A similar arrangement where Banks-Baldwin has the use of such areas for a token payment of \$1.00 per year, with the understanding that Banks-Baldwin will try to reciprocate for The Temple's generosity. Any agreement or understanding could include the following provisions: Our use of the specified area would be limited to day time office hours Monday through Friday, exclusive of Jewish holidays or any other date when The Temple notifies us they require the area. Banks-Baldwin will not use The Temple's areas for deliveries, or other general access. (3) Banks-Baldwin will carry insurance to protect The Temple and itself for any use of the area. Banks-Baldwin will bear all costs for gates, fencing and landscaping at our common lot line. In making this request we are somewhat desperate to obtain necessary off-street parking. I approached Rabbi Daniel Silver approximately one year ago concerning our plans, before you purchased and paved the area immediately behind our property. At that time he indicated that an arrangement might be worked out with you, but we both agreed that there was no point in proceeding further until our plans were more definite. We like to feel that we are an asset to the neighborhood, and our new structure should contribute to the long term stabilization and improvement of the If at all possible, we would like to work out an agreement which could be approved at the April meeting of your Board, or very shortly thereafter. To work toward this end I would appreciate any opportunity to meet with you or other representatives of The Temple to furnish further information and shape up a concrete proposal in a form you might desire for consideration at the April meeting. This is to acknowledge receipt of your letter under date of May 1st with regard to our recent meeting with your Mr. Louis Wernick, Area Director.

It was suggested that we would be willing to endeavor to work out a 10% proportional dues plan on basic dues with strict limitations regarding a solicitation of supplemental individual contributions from our members.

Our membership is broken down into the following categories:

Approximately 1,850 senior members at basic dues of \$120.00 \$222,000.00

Approximately 300 members, widows, senior citizens, etc. at reduced rates which average \$46.00

I do not stand in need of your approval. I would suggest that you look closely into the real motives behind your own"philosophy". But references in your letter to your parents make me aware how different was their consistent friendship and loyalty to me and to the Temple, through the years, from those of yours.
