ABSTRACT OF ADDRESS BY DR. ABBA HILLEL SILVER OF THE TEMPLE, CLEVELAND, OHIO AT CONVENTION OF UNION OF AMERICAN HEBREW CONGREGATIONS IN NEW ORLEANS ON SUNDAY EVENING, JANUARY 17, 1937

The major concern of the Synagog in its relation to the non-Jewish world was always not anti-Semitism, but the task of reconstructing society according to the plan of its basic religious and ethical ideals. It was tacitly assumed that as a by-product of a courageous and vigorous championing of its prophetic ideals of monotheism and social justice, it would incur resistance, resentment and persecution. The Synagog hoped and labored for a diminution of this hostility, but never at the price of muting its prophetic voice or of compromising with those ideals which it regarded as basic to any civilization worthy of the name.

It is difficult in these days when the Jewish cople is being subjected to such terrific pressure in so many parts of the world to keep this fact dominantly in mind. The Synagog is not primarily an agency for fighting anti-Semitism. It is an agency for preaching and teaching those religious and ethical ideals which it has evolved through long centuries of living and contemplation and upon which it has placed the imprint of its characteristic genius.

Anti-Semitism is only one of the forms of intolerance, all of which die hard. Anti-Semitism recedes or advances, as civilization recedes or advances. In our day, civilization has sharply receded; therefore anti-Semitism has sharply advanced.

The solution of anti-Semitism is bound up with the triumph of the fundamental values of brotherhood, equality and international justice.

The correct attitude which Jews should take twoard anti-Semitism should be one of quiet dignity, moral earnestness and strong faith . Jews must regard prejudice as a more or less constant factor in their group experience for a long time to come.

They should not try to run away from it. That is impossible. They should not make it central in their thinking.


In quiet pride they should accept it as a byproduct of a great

racial experience covering centuries, which has won for them powerful friends and powerful enemies.

The Jewish people would appreciate a little privacy at the hands of writers, journalists and publishers who have found anti-Semitism to be profitable. We dislike to be taken into the dissecting room for anatomical study every other day.

There is much necessary work to be done to regenerate the Jewish home, synagog and religious school. There are the great movements for peace, freedom and economic justice to which thoughtful Jews should give their earnest adherence.

To do all this is to forget anti-Semitism in the urgency and joy of great constructive service, for Israel, for America and for humanity.

MEN rarely live to see their dreams take shape ... but Isaac Mayer Wise witnessed the embodiment of his vision. The founder of American Progressive Judaism forged an instrument with which to make the dream a reality ... he created in 1873 the Union of American Hebrew Congregations to build and preserve a Jewish religious life compatible with the ideals of liberal America.

With the founder's lofty ideals translated into practical endeavor, the frame work of the Union answers the most important needs of American Jewry. Trained religious leaders were lacking: the Hebrew Union College was founded. Educational work among the adult laity, among non-Jews, and among the young was necessary: the Department of Synagogue and School Extension was the product of that need. Reform Jewish men and women lacked a medium of expression for the task of intensifying Jewish congregational and community activity: the National Federation of Temple Sisterhoods and the National Federation of Temple Brotherhoods were called into being.

The Union sends its message into every corner of the far-flung American Jewish Community. Its regional rabbis minister to isolated and remote settlements. In the field of synagogue activities, the Union brings concrete suggestions and stimulating plans to every Reform congregation.

Through these agencies and their many subdivisions, the Union carries on its work. The Union knits together its 289 congregations, 361 sisterhoods, and 120 brotherhoods in the task of building a healthy, fruitful American Jewish life. It seeks unity with liberal Jews throughout the world through the World Union for Progressive Judaism, it cooperates with our orthodox and conservative brethren through the Synagogue Council of America, and it participates in the good-will movement through the National Conference of Jews and Christians.
