MESSAGE FROM PHILMORE J. HABER

President, District Grand Lodge No. 2

This year marks the 86th Anniversary of Cleveland Lodge and the 96th year since the founding of B'nai B'rith. The oldest of all representative Jewish organizations, it was the first to present an educational program which included a dignified appeal for the preservation and development of civil and political rights.

B'nai B'rith is an American institution, believing fervently in the ideals of America and its form of government. As Americans, we have much to be grateful for. There is vouchsafed to us the same equality granted all other citizens. In America we hear the prevailing chorus of liberty and witness the determination that this country shall not become the victim of those whose wares consist only of hate, duplicity and imported foreignisms.

To these kindred souls we owe the obligation of standing firm, of making effective resistance to those who would destroy our form of government, and of educating those who are being misguided by false charges and promises that the destruction of the liberties of some will increase their own.

B'nai B'rith is confident that the calm, dignified and reasoned approach in meeting our current difficulties will not only appeal to the sense of fair play and sportsmanship innate in the American people, but that it represents the only method by which the current demagogueries can be permanently silenced.

LOCAL BROTHERHOOD WEEK SPONSORED BY LODGE

Brotherhood Week will be sponsored locally by Cleveland Lodge of B'nai B'rith in co-operation with the National Conference of Jews and Christians during the week beginning February 19th, 1939.

Bernard L. Goldman, representing the Order, has made all arrangements for a series of radio programs stressing the importance of better understanding between religious faiths. This is part of a national program being undertaken for the occasion by the Conference. It has been timed to include the birth-date of George Washington, who gave point to the American principle of religious freedom by his friendship to all faiths and by his repeated utterances in favor of religious tolerance.

Three types of program will be broadcast during the week. Religious and lay leaders from each of the three faiths, Catholic, Protestant and Jewish, will participate in a Church program, a Men's program and a Women's program.

Time for the broadcasts is being donated by stations WTAM, WHK and WGAR. Radio columns of local dailies should be consulted during Brotherhood Week for exact time of these programs and further details.
