As a special attraction, music will be furnished at stated intervals by the CCC of Ohio. A folder describing and giving the location of the various exhibits will be distributed, together with the final program of the Conference, when you register.

Regional Conferences

Regional conferences this year have already been held as follows: Northeastern Ohio, Kent; Northwestern Ohio, Bowling Green; Central Ohio, Granville; and Southwestern Ohio, Hamilton. By request of the Program Committee of Southeastern Ohio, the meeting of the regional conference for that section — which will be held in Athens — was deferred until fall. The programs of all regional meetings were de-

voted to a discussion and furtherance of the recommendations and objectives of the White House Conference on Children in a Democracy, with special reference to the needs of Ohio's children.

Conference Courses of Study

The Conference Study Courses begin on Monday afternoon, October 6, and continue through the following afternoon. This makes it necessary for those who participate to come to Akron only one day in advance of the opening of the Annual Meeting. The names of the courses and the leaders are given elsewhere in this program.

Eleven courses are offered, covering various phases of social service and adapted to meet the needs both of the trained experienced executive and of the beginner.

Special General Session

A special general session will be held on Friday afternoon, October 10, beginning with luncheon at 1:00 o'clock. This program will be devoted to a presentation and discussion of the Defense Program of Ohio. Speakers will include state officials responsible for putting this program into effect. The place of the lay group or volunteers will be given special consideration at this time.

Emphasis of the Governor's Committee on the Follow-up in Ohio of the White House Conference

In accordance with the program and recommendations of the White House Conference on Children in a Democracy, the interest of the Governor's Committee is centered on discovering the most urgent needs of the children of Ohio in the fields of Welfare, Health and Education; making plans which will meet those needs most effectively; and determining ways and means to put those plans into operation. On Wednesday, Thursday and Friday mornings, Section meetings on Welfare, Health and Education will be devoted to the presentation and discussion of reports of special studies which have been conducted in Ohio during the past few months.

These are your meetings, and their successful outcome depends upon your attendance and participation in them. In order that the entire Conference membership and visitors may be present, Division and Kindred Group meetings this year are scheduled for the afternoons of Wednesday and Thursday.

Division and Kindred Group Meetings of the Ohio Welfare Conference

Due to the participation of the Governor's Committee on the Follow-Up in Ohio of the White House Conference in our annual meeting this year, our regular Conference routine will not be followed. The resulting "adventure of change", and the enrichment of program content of Division and Kindred Group meetings, will make the Conference reach a new peak in interest and value. Through the cooperation of the various program committees of the Welfare Conference, appropriate Divisions and Kindred Groups are holding joint meetings, thus reducing the number of meetings to be held this year.
