

Dear Friend:

I am requested by the President of the United Jewish Fund to contact you in a matter that is of great importance to our community.

Several years ago, the Jewish community, embrassing all congregations in our city, have formed a joint body to make an Annual Appeal in behalf of all overseas and national institutions who need our support. You may recall that two years ago, I endeavored to secure your visit to Birmingham for the purpose of having you address our united community in behalf of that appeal. Previous engagements prevented your acceptance of my urgent invitation. You also assured me of your willingness to come on some other occasion. This encourages me to renew my former invitation and my urgent request for a favorable answer.

Our Annual Appeal will be held either the first or second week of January 1939. Our plan is to open the Appeal with a large banquet at which you are to deliver the address outlining the situation and the need for wholehearted and generous response for help on the part of the Birmingham community. For your information, I want to tell you that of the funds gathered, we always budgeted the same amount to the United Palestine Appeal and the Joint Distribution Committee. In addition, we appropriate a large amount for the Hadassah work. As the Chairman on the United Palestine Appeal, you will be glad to know of this situation.

We will not set a date for the banquet until we hear from you as to your choice of date during the first ten or twelve days of January.

Please take this invitation as coming not only from myself but from the entire Jewish community who are most eager to have you visit us and come under the spell of your eloquence. Last year our guest-speaker was Rabbi Isserman, and two years ago, was Dr. Freehof, both of whom made very eloquent and forceful appeals. Our community responded whole-heartedly. The situation abroad is desperate and we propose to raise larger funds than in any previous year. We are confident that if you accept our invitation, we will achieve our goal.

Let me appeal to you personally. I would love to have you visit us. You expressed your willingness to me personally that some day you will do it. This is the time when we need you most.

Dear Rabbi Silver:-

In January, 1939, you addressed the Birmingham Jewish Community on the occasion of the opening of the 1939 campaign of the United Jewish Fund (the Birmingham Jewish Welfare Fund.) Those who heard you have never forgotten your address. Some of those in attendance could not grasp your description of conditions in Germany, Italy, Eastern Europe and the Arab countries with their effect on the World Jewish Community. But they know now and have known for a number of years that your vision was clear.

At the close of the meeting I requested that at some near future date you address the membership of the Birmingham Zionist District. Your response was that as soon as possible you would return to Birmingham. But the events that followed convinced us that your time must be spent elsewhere--the British White Paper, the War, the liquidation of millions of Jews, the Anglo-American Committee on Palestine, the United Nations, the Unscop, the U.N. Resolution on Partition of Palestine, the British Evacuation of Palestine, the Jewish-Arab Wars, the Establishment of the State of Israel, the Internal Dissensions on the WZO with the tragic results bringing about your temporary retirement.

I am no longer young and cannot get about much. But I know that the dynamic urge toward the realization of the Basle Program has been spent and a feeling of lethargy prevails among the membership of the ZOA. We are losing ground and are in danger of disintegration. We need a strong "Shot in the arm" as there is much yet to be done. I had contact with most of the able men who led the Zionist Movement in the U.S.--Gottheil, Magnes, Wise, Brandeis, Mack, Lipsky, Friedenwald and those who came later. In my book Rabbi Abba Hillel Silver is, has been and will be the most potent Zionist leader that America has produced. This is not flattery. I have expressed this opinion privately and from the platform.

Now, to the point. On Sunday night, May 14th, Birmingham Zionists will hold their Ninth Annual Zionist Day; also the celebration of the Second Anniversary of the Proclamation of the State of Israel. Aside from the purpose of propaganda we raise the Zionist funds necessary--American Zionist Fund, Brandeis Camp and general Youth Work; and to, and including 1949, J.N.F. May we hope that you will address the meeting on May 14th, 1950? Birmingham Zionists need your presence on that occasion, particularly the new crop of Zionists, many of whom joined because of the philanthropic appeal. You alone can give us a new starting point and direction for the work yet to be done by American Zionists.




Dear Rabbi Silver:-


