Dear Dr. Silver:

Our General Zionist friends who are active in the leadership of the United Jewish Appeal in Buenos Aires, Argentina, are asking whether you would agree to visit Buenos Aires during the month of May in order to open their 1952 U.J.A. drive. According to them, it would require your stay in Argentina for about two weeks.

Our good friend Joseph Lutzky, who is the General Secretary of the campaign, writes me that they did not want thus far to adopt official decisions in their committee concerning an invitation to you prior to knowing your reaction. They say that the Poale Zionists press that an invitation be sent to someone of their people from Israel.


May I ask you, therefore, to let me know your decision concerning the above request.

On my part, I must say that Argentina has now the largest and most important Jewish community on the Latin-American continent (about half a million Jews). From the General Zionist point of view your visit would be of utmost importance.

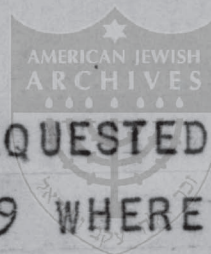
