Dear Rabbi Silver:

I am now able to write you definitely as to the details of our Cedar Point program. After a conference with President Ashbaugh last Saturday morning, we agreed that we should like to have you for the speaker at our opening session on Friday evening and also as the luncheon speaker for the Classroom Department on Saturday at 12 o'clock. We can pay you \$150 as an honorarium and provide your hotel room for Friday night. I wish that we could come closer to your standard figure, but \$150 will be more than we shall pay for any other speaker.

I shall appreciate hearing from you as to your reaction to these arrangements. If you should find it preferable to speak at the luncheon meeting on Saturday noon and at the afternoon session on the same day instead of appearing on the evening session Friday, I think we can make the change.
