Dear Rabbi Silver:

I have your letter of May 19th.

With reference to your leaving Cleveland on December 10th, and returning December 23rd: Frankly, I hardly think you could complete the tour in that period. It would hardly be possible for you to make two cities in one day, and each section prefers an evening lecture. In arranging your tour you will see that the cities in the Southern Interstation Section are too far apart to lecture in two cities in one day.

In connection with the expenses: You mention "Sisterhood", which I presume was a typographical error, as these are sections of the "Council of Jewish Women". It is preferred that your tour be made without interruption, therefore do not think that the period of time in your letter is long enough to reach all sections because since last writing you two more cities have joined, viz: New Orleans, La. and Augusta, Ga., and possibly tri-cities section (composed of Florence, Tuscumbia and Sheffield, Ala.) the lecture possibly being at Florence. It is suggested that you arrange your itinerary from Cleveland, Ohio and return, ascertain traveling expenses of entire tour, so that I can notify each section their prorata of the expense, furnishing me with date you will lecture in each city and subject, if possible. 





Dear Rabbi Silver:

I have wired you a brief outline of the train connections between Chattanooga and Cleveland. I shall repeat the information in this letter.

A through Pullman from Chattanooga to Cleaveland leaves Chattanooga at 11:15 a.m. and arrives in Cleveland by the way of Cincinnati at 7:30 the following morning. You can take this train, therefore, Thursday morning and reach Cleveland the following morning in time for breakfast and in ample time, as I understand, for your Friday engagement.

The sleeper from Atlanta to Chattanooga leaves Atlanta at 9:00 o'clock. If you have finished your address by this time and prefer a Pullman to another means of transportation, you could come to Chattanooga by train. If the Wednesday night program, however, does not release you by 9:00 o'clock, my automobile will be in Atlanta at your service. You could drive for an hour or more after the evening meeting and spend the night in one of the nice hotels between here and Atlanta, making the balance of the trip Friday morning. You could, of course, if you wished, drive all the way through Thursday night. The distance is approximately 120 miles. The road is paved and in excellent condition. We can make the trip in about three hours from Atlanta to Chattanooga.

I hope that this plan will be satisfactory and that you will do us the favor of coming to see us. Our students, our faculty, and many of our citizens are anxious to hear you.


I have been under a terrific strain in the last few months and I must conserve myself.

Dear Rabbi Silver:

This Institute will be held for one week this spring, beginning Monday, April 25th. The Institute of Justice is an Institute for the discussion of social, economic and political problems that affect the welfare of our people and of government. The word justice is used because the philosophy of our Institute indicates the idea that justice must eventually be the basis for the treating and solving of our problems.

I realize that you are a busy man and that I am asking a great favor of you when I suggest that you take the time to visit our community and talk before our Institute. I am so anxious, however, to have you on the program, to have you visit this city and this University, that I cannot refrain from sending you these few lines and hoping that your reply will be favorable.



Dear Doctor Silver:

I have had an ambition for years to have you visit our Jewish Community here, but never was the need for it as great as now.

I recall distinctly your visit to the University of Chattanooga ten or more years ago and the tremendous impression you made here. It has been my privilege to see you in action at a Zionist Congress, many Zionist Conventions, etc. Our local scene is sorely in need at the

present time of a visit by man of your stature. It may be presumptuous for our small community to ask for recognition of this kind, yet, I feel, there are times when it is thoroughly justified, and the time in Chattanooga is now.

Our community is one of the oldest Zionist communities in the Country. One of our problems is that we are a bit overorganized into General, Mizrachi, Labor and Hadassah, also Pioneer Women. Last year we Generals had a membership of 310, against 370 the previous year, whereas, we should have an enrollment of at least 400. Hardly ten of our members can be rated idealists in the full sense of the word. We lack that something to make our District a vital one and it is becoming more difficult as time goes on.

We are having our annual Zionist Day on Sunday, Nov. 27th, in the form of a banquet in the evening. We use this occession to raise funds for Zionist projects and to propogandize as much as possible. In fact, we aim to start with our celebration on the preceding Friday evening.

Your presence here would make it easy for us to pack the house, to raise money, to increase our membership to a very considerable extent, to convince our membership that v the time has not yet arrived for the liquidation of our organization, etc. Our venture this year will not be a success, unless we get a power to come and give us the needed lift.

May we dare ask you to serve as our speaker on this occassion. We would not expect it gratis. Your visit here would make it the greatest day that the Chattanooga Jewish Community has ever experienced and the results would be lasting.

I know you are due in New York on Tuesday, Nov. 29th, to appear under auspices of the Manhattan Region. The 27th is the most suited date for us, to avoid conflict with other 100


