

Dear Rabbi Silver:

Earlier today I sent a telegram to Mr Goldhamer, asking him to get your permission to wire our five local key people -Henry Wineman, Meyer Prentis, Nate Shapero, Sidney Allen and Fred Butzel.

We are having an advance report meeting of our pre-campaign workers tomorrow (Friday) at noon, and I was eager to have your message to these five impress upon them the necessity of securing early announcements of big gifts.

For the time being, only a few of the bigger givers have spoken up, and, for the most part, with negligible increases.

The formal opening of our campaign, which you are to address next Monday night, is a dinner-mesting, scheduled for 6:30 P. M., which means that the dinner service should begin by 7:00 o'clock. Fred Butzel will preside; Dr Leo Franklin will make the invocation; I will report on fund-raising progress to date; Butzel will briefly discuss local aspects of the campaign, and then call on you for the main address, following which the audience will sing America. You will see from the agenda that, except for two or three minor trimmings, the program is yours.

Detroit tradition has given advance assurance to those attending that there will be no solicitation of funds that evening; but an important part of any message that night must be an appeal to the bey persons in the community to re-examine gifts already in. To date we have not one single contributor of \$1000 or over last year, who has doubled his gift. Most of them are renewing in the same amount, or increasing from ten to twenty percent at best. While this is justified in some cases, it certainly



The letter-head on this stationery will tell you the story that at last the happy event, which everybody in American Reform Judaism has been awaiting has occurred. Detroit now has more than one Reform Congregation.

I want to tell you that the organization of Temple Israel which began late in July, and which now already has attracted a membership of 200, has been welcomed by the community as a whole, and accepted in good grace by the leadership of Temple Beth El. The overwhelming majority of our new members are people who had not previously been affiliated with any congregation.

We expect by the time the Holy Days arrive to have a membership approaching 500. The cause of Liberal Judaism, and of religion as a whole, is distinctly being served by the appearance of a new Liberal Jewish congregation in the city of Detroit.

We are planning in the very near future to become members of the Union of American Hebrew Congregations.

So far, the organization of the new Congregation has proceeded quietly through meetings in various homes. Now that we have a substantial membership, the time is ripe for a Service of Dedication of the new Congregation and of the Installation of its Rabbi.

The Dedication and Installation Service is planned to take place in the great Auditorium of the Detroit Institute of Arts, Friday night, September 12, at 8 o'clock. We expect all the leaders of the Jewish community of Detroit to be present.

The Service will be followed by a Social Reception.

I am writing to ask you to deliver the address of the occasion. The members of the Congregation and I feel deeply that you represent that expression of Liberal Judaism toward which our congregation aspires. Many of our members are Zionists who never found themselves at home in Temple Beth El, but who are turning to the Synagog and Liberal Judaism in the form of Temple Israel, believing that its atmosphere will be congenial to their Jewish sentiment.

It will interest you to know that the organization of the new congregation has had the effect of reviving the sentiment for Jewish tradition also, at Temple Beth El. Since members of both Congregations will be present at the Service, it will be, I may suggest, your opportunity to interpret before the leadership of our entire Jewish community the position of Liberal Judaism in the America of Today.

May I invoke both our personal friendship and our sharing of common ideals in Jewish life, to urge you to do our new Congregation this vital service, and to render this occasion, symbolic of the expansion of Liberal Judaism, a memorable one.

Please let me hear from you as soon as possible.

1942- The Jewish Welfare Fund of Detroit will launch its 1942 "Allied Jewish Campaign" on May 10th for a possible goal of \$1,000,000.

Mr. Montor attended a meeting of the Budget Committee last month at which it was voted to recommend to the Steering Committee, for final decision, an allotment of \$550,000 to the UJA, as compared with an actual allotment of \$420,000 in 1941. He reported that although a number of reductions are expected because some people have been affected by certain aspects of the war developments, the general trend, judging from the enthusiasm radiating from the meeting, is toward maintaining last year's giving level, and possibly exceeding it.

The achievements of the Detroit Jewish community have been particularly notable juring the past few years. In 1939, the Allied Jewish Campaign raised \$850,000. In 1940 this was increased to \$736,000, and by 1941, \$835,000 had been reached. The UJA's allocations were increased accordingly - \$318,000; \$350,000 and \$420,000, respectively.

Campaign officers have not yet been appointed. Mr. Abe Srere is President of the Jewish Welfare Federation; Isidore Sobeloff is Executive Director. 

Dear Dr Silver:

I am pleased to be able at this time to send you detailed information regarding the Var Chest of Metropolitan Detroit, in whose behalf you have so kindly consented to visit our city on Monday, November 2nd. The occasion will be designated as Allied Jewish Campaign Day and you will be the guest of honor and speaker at a campaign luncheon at the Tuller Hotel. The luncheon is scheduled for 12:15 P M and the program is being arranged to begin at one o'clock. For a meeting of this kind, a talk running from about fifteen to twenty minutes would allow sufficient time during the latter part of the meeting for a report on campaign progress.

With the possible exception of Boston, Detroit is conducting a united drive for perhaps the largest amount in the country -- \$5,800,000. The major, component services benefiting from the campaign are:

- 1. The local, continuing social services including the eighty organizations of the Detroit Community Fund.
- 2. The United Service Organizations (U. S. O.) for the morale of our armed forces.
- The War Relief efforts including British War Relief, Greek War Relief, Maple Leaf Fund, Russian War Belief, Polish-American Council, United China Relief, War Prisoners' Aid.
- 4. The Allied Jewish Campaign.

I am sure you will be interested in knowing that to date the daily programs for the special War Eelief days also include acceptances by the ambassadors and ministers of Great Britain,



Has provided more than 500 clubs and 200 other units to serve our soldiers, sailors and marines throughout U. S. and overseas bases, and to a limited extent in war industry communities. Last summer the USO served troop concentrations on maneuvers numbering as many as 400,000 men. * GREEK WAR RELIEF

To be spent primarily for freight on 15,000 tons of wheat a month in Swedish ships given right of passage by both Allied and Axis powers. Grain is supplied by Canadian and U.S. Governments. It is estimated that this grain will keep less than one-third of the Greek population from starving to death. Hollow eyes look out over the storied seas around Greece for these ships from America bearing flour and grain to feed the starving people who are descendants of the founders of Democracy. The grain will be distributed by the International Red Cross.



* QUEEN WILHELMINA FUND

Don't look now if you're squeamish! This is what greeted this Metherlands subject when he returned to his bombed-out home after the Bli z. The Queen Wilhelmina Fund, as part of The War Chest, seeks funds to aid the Dutch in their suffering. The Queen Wilhelmina Fund furnishes relief and recreations to Dutch refugees and seamen in Grea: Britain, Australia, Unoccupied France, Spain, Portugal and the United States. The Dutch are doing a heroic job of battling the Japs in the Far East. Let's show them that we of Detroit are in back of them to do what we can.

WAR PRISONERS' AID COMMITTEE OF THE Y. M. C. A.

These are prisoners of war—once the flower of some nation's youth, marching proudly in company front on the parade grounds of Europe. Today, they are beaten, discouraged, distracted over the loss of families and friends. War Prisoners' Aid provides for war prisoners of all nationalities in Germany and most of the prisoners now held in Japan, recreational, educational and religious opportunities, as the means of occupying their leisure. Services of this committee are conducted under the international agreement of the International Red Cross.

* RUSSIAN WAR RELIEF

Behind the lines in Russia, injured civilians are being rescued because Russian War Relief and its medical supplies have reached them. The eyes of Russia turn toward the West and America for alleviation of suffering and the saving of lives. Russian War Relief supplies medicines, surgical supplies and some woolen clothing to heal the sick or wounded soldiers and civilians of Russia. No money is sent to Russia, but only those supplies which are usable for curative purposes and so can be used to help send soldiers and workers back to their places in the total war effort.

* BRITISH WAR RELIEF

Provides ambulances and mobile feeding kitchens for air raid victims. Maintains homes for

bomb-shocked children where special, expert treatment helps them toward recovery. Helps

support homes for children of war industries'

mothers, orphanages for war victims and refugee

children from Allied Nations. Gives equipment

for recreation and convalescent homes; purchases material to be made into garments by volunteers

in this country, and new shoes and clothing to be shipped from the U. S. Supports clubs for English seamen in Britain and the U. S.; and pro-

vides seeds for war gardens in England.



* UNITED CHINA RELIEF

Chinese eyes turn toward us, too. They knew the horrors of civilian war before we even suspected it. Chinese relief is the "bargain package" because American money goes so far in purchasing supplies for the Chinese whose basic wants are so simple. This money helps provide medical and surg cal supplies, child welfare care, educational relief, economic rehabilitation and general relief. The organization includes eight other agencies serving the needy Chinese in various capacities and thus creates the kind of economies possible to united fund raising and co-ordinated relief work.



★ UNITED JEWISH RELIEF

The Allied Jewish Campaign of the Jewish Welfare Federation agencies that have served through war, famine, persecution and dispersion at home and abroad, in the fields of relief, education and reconstruction. Its major war services are the *United Jewish Appeal* which aids distressed refugee Jews scattered by Nazi terrorism; the United Palestine Appeal, through whose help Palestine has been homeland, haven and stronghold of democracy in the Middle East, receiving as many homeless Jews as the rest of the world combined; the National Refugee Service, which renders assistance in America to refugees through emergency aid, and adjustment to life in America.



* DETROIT COMMUNITY FUND

Raises money and disburses it to 80 social work agencies in Metropolitan Detroit. These agencies serve Detroiters in need by providing the following services: Care of children, care of the sick, family services and care of the aged, protective work, community centers and settlements, youth services. The Community Fund will celebrate its Silver Anniversary during 1943, marking 25 years of service to the needy of Detroit. Fund services are the all-time services which help to keep up morale in wartime and to build a strong and healthy nation in times of peace. These services are being streamlined to fit into the war effort and to accomplish as much as possible at lowest cost. Your contribution to the War Chest will assure the continuance of these aids to wartime and peacetime morale.





My dear Dr. Silver:

You have probably forgotten the incident which happened many, many years ago when I tried to convey to you what I thought should be said at a dinner given in your honor in St.Louis, when you turned to me-I was more youthful in those days and more exuberant--and said, "Mendele, do you want to prepare my speech too?" In the hope of escaping just such remark, I hope you will understand the spirit of this communication. You are the master and so I am merely passing on information which I think you should have in connection with the address that you are to deliver on Sanday evening, December 27th in Detroit at the Hotel Book-Cadillac. We know that you have to leave at 11 o'clock so you will speak in ample time. We would like to have your address as the closing one of the evening. We are going to have Dr. Goldstein's presidential address and a few greetings and then your address.

In the opinion of many with whom I have spoken, it would be well for you to speak on the larger problems of the Jews in relationship to the Zionist cause and particularly the place of the Keren Kayemeth in coping with the post-war problems. This it seems to me should be the keynote of your message. To enable us to give your address the widest publicity, for it happens to be Saturday night and the papers go to press early, I am requested by those who are handling the publicity, to ask you to please send us some extracts of your remarks. You can send them on directly to Detroit.

Reservations have been made for you at the Book-Cadillac Hotel so the room will be available as soon as you arrive on the 26th. I am only sorry that you sannot stay with us for the remainder of the sessions. We want to convey the proper picture to the Jewish Community of America in order to bring the whole land problem to the forefront. It is the logic of events that if we are to settle millions of Jews after the war and that is our program. we must have the land and it must be prepared. We cannot wait until it will be too late to prepare the land for this large-scale settlement. The social justice aspect of the JNF, the idea that the land is tilled and cultivated by labor, that the land is leased are worthwhile emphasizing. That in forty years, we have only acquired 600,000 dunams for which we have paid approximately thirty million dollars compared with what the Jews of Germany alone lost as a result of Hitler is worthwhile mentioning to dramatize the need for land, The fact that we are facing a land hunger in Palestine because every inch of land which the Keren Kayemeth acquired has now been exhausted and that thousands are waiting for land upon which to settle, this together with the whole tragedy of the Jewish position I hope you will-for lack of a better word-dramatize for it will convey the proper spiris of what we

are trying to get across not only to the delegates but to the country as a whole.

Your message has been widely publicized and we expect a very large crowd on Saturday night. We have arranged the program so that we will not have a marathon of speakers and so I want you to know we are all eagerly looking forward to seeing you on Saturday. It is the first time that you will be with us since you have come into the leadership of the U.P.A. We are enclosing herewith credential card.



My dear Dr. Silver:



Mr. Isaac Levy, on behalf of the JDC, came to see me this afternoon upon my invitation, so that I might convey to him my reaction to the previous discussion with reference to JNF.

I stated to Mr. Levy that in deference to the UJA, the JNF would be willing to arrange the timing of its campaigns in communities so as not to conflict with the UJA campaigns, if the UJA executives would furnish the JNF office with a schedule of their campaigns.

While Mr. Levy appreciated this suggestion he stated that something additional needs to be done to meet the situation. He suggested the adoption of one of the following proposals:

- 1. that the JNF turn over to the UJA every contribution from an individual or family which is in excess of \$100.
- 2. that the JNF turn over to the UJA at the end of the year all sums in excess of a fixed proportion of JNF income to UJA income, the proportion to be fixed at the rate obtaining for the year 1942.
- 3. that the JNF turn over to the UJA all sums above the amount raised by the JNF in 1942.

I told Mr. Levy that I would have to discuss these proposals first with the JNF Board.

With reference to the status of the UJA agreement for 1943, Mr. Levy stated his position as follows:

December 30, 1942

The JNF discussion does not interfere with the signing of the agreement. The JDC, however, will attach to the agreement a special reservation permitting both the JDC and the UPA to discuss the JNF matter before the Allocations Committee. In the event, however, that one of Mr. Levy's proposals is acceptable to us, the agreement can be signed without any reservations.

I told Mr. Levythat on the question of the signing of the agreement I am not qualified to speak, as that matter was in Dr. Silver's hands and that I had the impression that Dr. Silver had reported that the agreement had already been initialed in its previous form.

Please inform me at your convenience whether it will be possible for you to accept.







Dear Rabbi Silver:

As I address my annual request to you for a visit to Detroit under our Jewish Welfare Federation and Allied Jewish Campaign auspices, I do so with a diffidence that comes from a respect for the full-ness and importance of your schedule. Although I have not had the occasion in recent months to convey my sentiments to you, I have watched with great respect and admiration the significant part that you are playing in Jewish affairs. An appreciation of how busy you are is more than a preliminary bow before making still another request of you. And yet, as you would guess, I do have a request to make of you:

We are now making plans for our 1947 Allied Jewish Campaign. We have accepted a \$4,000,000 UJA goal, and our over-all goal for the entire welfare fund will be \$5,335,000, as compared with only \$2,800,000 raised last year. (We were able to give the UJA \$2,750,000 last year because of the extra funds we had available from the dissolving War Chest.) It is going to be a big job, and we shall be needing all the help we can get.

I had in mind inviting you for one of the following three programs: a special gifts meeting at the end of March or early in April; our annual meeting sometime during that same period; or the opening of our general campaign on the evening of May 6th. We now have word that Herbert Lehman can come to Detroit on the evening of March 25th, and so I would like to time your meeting, if it can be arranged, for sometime in April or May.

However, I have just heard that you are considering coming to Detroit for a ZOA meeting on March 34th, which would be right in the midst of our special gifts campaign period. It would be presumptuous of me to suggest to the president of the ZOA that, if possible, he arrange to come either at an earlier date or a later date, because once our campaign gets going, one date is as valuable to us for community participation as another. What I am bold enough to suggest is that if your date for March 24th for the ZDA is definite, and cannot be changed, that you leave us some time earlier that day for a meeting of some of our top givers whom we would try to line up with your help in preparation for the Lehman meeting the following evening. I am not sure that the crowding of the two meetings, one right after the other, would be mutually helpful, but life is like that and I do want to make the best of your presence in town.

If your date with the Z.O.A. is not firm and final, I would go back to my usual annual request that you let us have some date that you can spare for us in connection with our spring campaign. Anytime in April would be good for big gifts activity and the first week in May, preferably the sixth, would be good for the opening of the general campaign.

I know how many, many matters other than local campaign occupy your mind and attention, but I also know that you would like to help us if you can. Can you?

Dear Abba.

I am writing to remind you of the personal kindness you undertook to perform for me in the fell of 1945.

At that time, you accepted my invitation to speak at the opening Building Fund dinner of my congregation. A short time before the dinner you were compelled to write me a reluctant note to the effect that you could not come because your presence was required in Palestine. My congregation and I understood the situation and accepted it.

Now, we are at the final phase of our Building Fund campaign. Our membership has responded beautifully and generously. We have all but a third of the sum needed to start the construction of the building pictured on this letterhead.

We are confident that we shall be able to raise the balance at a Special Gifts dinner, which we have scheduled for Wednesday night, September 22, at Franklin Hills Country Club. One of the leading philanthropists of Detroit, a member of our board, Mr. Max Osnos, will be chairman of the dinner.

I hope that this time you can fulfil your kind intention of three years ago. It will, of course, not be necessary for you to have anything to do with the appeal for funds. The mere announcement that you are coming to address our Victory Dinner to celebrate the completion of our Building Fund will mean that the subscriptions will be in our hands before the dinner.

I anticipate your thought that it might be as risky for you to commit yourself to a domestic occasion this time as the last time. I know only too poignantly how uncertain still are the effairs of Israel. I am aware that you may at that very date suddenly be called to Washington, to New York, or to Europe or to Israel for a purpose which, I would be the first to acknowledge, carries priority over the building of our temple. If this should occur, let me tell you before hand, that the congregation and I

will understand. However, I know I need not labor the point that the building of synagogues in America is also of decisive importance to all Israel and I need not remind you of the significance of my particular temple --- that it was originally organized by a group of men and women in Detroit who were determined that his labors in behalf of Zionism should not be a disqualification for a Rabbi in a Reform congregation. The building of Temple Israel constitutes a victory for the ideals of liberal Judsism you and I have in common.

The victory is indeed so complete that many others who will be present at the dinner and contribute to the fund will be members and leaders of my former congregation.

I have written "Please Forward" on the envelope of this letter, not only in the event but in the hope that you ere somewhere cut of Cleveland enjoying your well-deserved vacation. I am also hopeful, however, that you will find it congenial to check with your calendar and make the effort to fulfil, this time, the engagement you missed three years ago.




