Dear Rabbi Silver:

I note that you are to be in Chicago and speak both at the University Chapel and the Sunday Evening Club on January 7. I wonder if you would be able, and willing, to remain over until Monday or Tuesday, preferably Tuesday, and address an all-university convocation at Northwestern. We very much desire to have one representative of Judiaism speak sometime during the year, and we should prefer, if possible, that you be the one to do so. I have heard only very fine things converning you and have read, with considerable pleasure, your book, on RELIGION IN THE CHANGING WORLD, and I may say have made use of it somewhat in my History of Religion classes.

We are hoping this year to be able to have our convocation speakers stay on the campus for a couple of days for the purpose of meeting small groups or for individual conferences on questions of religion, possibly taking dinner or luncheon at sorority or fraternity houses, and also conducting an informal vesper service on the second day, at four o'clock in the afternoon.

I have no idea what honorarium you might expect for such service; unfortunately, we are this year obliged to limit our appropriation for that purpose to a sum very much below what we should like to have. We would naturally want to make it as substantial as our limited funds permit. If you find it possible to come, we should be glad to have you suggest what fee you would want.

In case you should find it inconvenient to remain over just at that time, would you be in Chicago at any other time during the year when it would be more convenient for you to spend a couple of days with us?

NORTHWESTERN UNIVERSITY INTERRACIAL COMMISSION SCOTT HALL EVANSTON, ILLINOIS OFFICE OF EXECUTIVE COMMITTEE December 27, 1940 Rabbi Abba Hillel Silver The Temple Ansel Road at 105 Street Cleveland, Ohio Dear Rabbi Silver: In speaking with your secretary yesterday, I learned with dismay that you will be unable to see me before next Thursday, and, as time is of the essence in this matter, I am writing to explain why I wished to see you. The week of February 16-22 has been designated as "Better Understanding Week" at Northwestern University by the Interracial Commission, of which I am Secretary. And plans are progressing for the formation of a national organization of youth to work along the following lines from Northwestern. We view with alarm the fact that a considerable segment of youth opinion is looking toward "isms" other than Americanism for salvation. And it seems to us that youth is suffering from a loss of morale which the stress and uncertainty of the present situation has wrought. This uncertainty is indicative of a tendency toward a disintegration of their ideals at a time when national unity of spirit and morale is of paramount importance. It is our belief that the principles which guide our Commission - creating better understanding between religious and racial groups, of protecting our civil liberties, and of building a basis of understanding and respect for the ideas and ideals of "the other fellow" - will serve to help return misinformed and confused youth to those precepts which only a democracy can guarantee. In other words, we are doing our little bit to develop a greater national unity by stressing the importance of and improving youth's appreciation of tolerance and better understanding of other religious and racial groups. Toward achieving that end, I approach you as a confirmant and graduate of the Temple, and on behalf of the North-western University Interracial Commission to invite you to

speakers on the subject of tolerance. We should like you. one of the greatest and best-known Jewish leaders in America. to speak for twenty minutes on the subject of "Tolerance in Religion", and after the other two members of the panel (tentatively Senator Robert M. LaFollette and Walter White of the N.A.A.C.P.), who will speak on "Interracial (negro)
Tolerance" and "Respect for Civil Liberties", have finished, to respond to questions from the floor.

The audience will consist of approximately 1300 college students, members of the faculty, and townspeople, and the program will take place on February 18 in the beautiful Cahn Auditorium of Scott Hall on the University's Evanston campus. It is very possible that the program will be carried by one of the major radio networks.

This panel will be the high point in a wekk of activities stressing religious and racial tolerance. It is our sincere hope that you will see fit to favor us with your presence on this occasion.
