





Report from

L. L. Goodman, Chairman Jewish Welfare Fund

This is a report of the May 2 meeting at Broadmoor, opening the Campaign. It gives some detailed information for those who could not be present, as well as for those who were.

There were 11h people who made pledges. 87 were increases. The total raised was \$163,000.00 as against \$135,000.00 from the same contributors last year. The increase averaged 21%.

Since this is the percentage of increase we need to reach our quota, it is very clear that it is possible for us to reach our goal this year if the pattern of giving at the meeting continues throughout the balance of the campaign.

There were more individuals who increased their pledges this year than at any meeting within the last 5 years. At the same time there were a number of very substantial pledges where there was no increase because those people were already giving adequately. And, of course, there were the usual number of expected important cuts from people who were unable to give as much as they did last year.

I mention the above so you can see that the 21% increase is a net figure which takes into consideration what should be a representative cross section of all types of giving this year. It is an average increase which we should be able to maintain throughout the rest of the Campaign.

The meeting was one of the finest in spirit that we have had for years. It represented a return to real unity in the community,

The fine address by Rabbi Silver made crystal clear the importance of a strong Federation to support our local and national causes, as well as overseas. I am sure everyone left the meeting a <u>little more proud</u> of the community in which he lives and with a stronger desire to make this community a still better one.

It is interesting that the 87 persons who increased their pledges





About two months have elapsed since we last wrote to you about our State Conference and your acceptance as our luncheon speaker for our closing Conference session. Our program committee has been working toward a conference framework and theme broad in scope and pertinent to the time.

The Conference theme this year will be "Focusing Resources on Needs." Around this our program committee is building a program of some sixteen study courses and sectional meetings. Included in the study courses will be such areas as Protective Services, Alcoholism, Children's Homes, Aging and the Aged, Mental Health, Beginning and Advanced Casework, The Patient and His Care, Group Work Practices, Staff Development, Volunteer Services, and Rehabilitation Services. 
