Dear Dr. Silver:

We are now arranging our program of speakers for 1934-35. You will note by the enclosed folders the programs for both our University Supper Club and our University Lectures on Religion being held during the current year. Our University Supper Club, which meets at 6.00 p. m., is composed dominantly of undergraduates but also includes graduate students, faculty members and a few alumni and friends - a group of about 175. The University Lectures on Religion are given under our auspices at 8:15 p. m. the same evening at the First Methodist Episcopal Church, adjacent to the Goucher College campus. This group includes students, but also interested people from the community surrounding the University; the attendance ranges from 600 to 1200.

We are hoping very much that you will be able to arrange to speak for us one month during the coming academic year. Would it be possible for you to come either March 19th, or May 7th, 1935? We are operating on a very slender budget in these times so we are not in a position to offer you the sort of honorarium we would like to. We would, however, be glad to give you a fee of seventy-five dollars to cover your expenses. Perhaps, if you could arrange to spend a longer time in Baltimore, we could arrange other meetings which would make it possible for us to supplement this fee. I have talked with Rabbi Lazaron about it and perhaps he will also be writing to you.

As we are anxious to complete next year's program just as soon as possible, I would appreciate it if you would wire your reply at our expense.

Johns Hopkins University, cooperating with the Baltimore Round Table of The National Conference of Jews and Christians, is planning the first steps in what we hope will be a School of Religion at Hopkins. A series of lectures will be given at the university next year and sponsored by the university. will be nine lectures on the history of Judaism, Protestantism and Catholicism, and a second series of nine on the religious approach to contemporary problems - three to be given each by a rabbi, a minister and a priest. At a meeting of the committee I suggested your name to give the three lectures in the second series. They will be evening affairs at the university on three successive weeks, perhaps Monday nights. 

You are perhaps familiar with the fact that for two years Johns Hopkins University, in conjunction with the Baltimore Round Table of the National Conference of Christians and Jews, has been conducting the Hopkins Lectures on Religion. These lectures are given under the auspices of the University on the University campus.

The committee in its series of meetings decided that this year we should have the six lectures on Monday nights from October 16 through November 20 and that we would ask a representative of the Catholics, Jews and Protestants to speak one night each on the general subject of Attitudes Toward Other Groups. This may seem to you rather general, but it was the suggestion of the committee that this subject be broken up into a presentation of the attitudes from the theological, historical and contemporary points of view and that we suggest to the lecturers that they deal with these questions as specifically as possible with what might be considered controversial issues. The purpose of this series of lectures this fall will be to present to the general public what are the actual attitudes of the three groups toward each other, in order that we might do away with misinformation and misunderstandings that are based on rumor. Then the committee thought that we might further dramatize the lectures as well as the subject matter, by announcing in our promotional material, as well as on the night of each lecture, that the audience would have the privilege of asking questions, but that these questions would have to be submitted in writing, later edited and classified by the committee, and then presented to the lecturer a week in advance of the second series, when we would ask him to return for the question and answer period three weeks after the lecture was delivered.

The committee is very anxious that you might serve as the Jewish lecturer in this series this year and is in a position to pay an honorarium of fifty dollars for each lecture, or one hundred dollars for the two nights, plus expenses. May I suggest that if this suggestion meets with your approval, you give us the lecture on Monday evening, October 30, and then come to Baltimore again on Monday evening, November 20, for the question and answer period. We very much hope that you will accede to this request and that I may have a favorable reply at your early convenience.

Well-known author, playwright, publicist, social observer and world traveler. Long a dramatist seeking purely entertainment value, he now writes with a social purpose. Has just returned from an extended tour of the Orient. Author of thirty-one plays, among them, "The Fool" and "The Enemy" (a broadside against the folly and futility of war).

NOVEMBER 9— EFRAIM M. ROSENZWEIG

Rabbi of Madison Avenue Temple, Scranton, Pa. Extensive interests, participating intensively in all. Among his activities are mental hygiene organizations, peace groups, civil liberties units, adult education, and vocational guidance. Popular as lecturer at Student Christian Movement Conferences. A favorite of the Hopkins delegation at Eagles Mere (June 1937). Interested in Jewish-Christian Relations. A newspaper columnist on community affairs.

DECEMBER 7— HALFORD E. LUCCOCK

Yale Divinity School Professor of Homiletics, relator of religion to life and literature. Author of such books as "Jesus and the American Mind", "Christian Faith and Economic Change", and "Contemporary American Literature and Religion". Is much sought after as lecturer on the meaning of religion both in personal living and in social problems.

JANUARY 11-NORMAN THOMAS

Prominent American Socialist, a quadrennial candidate of that party for President. Constant worker for the rights of labor and the oppressed. Formerly a Presbyterian clergyman. He is author of many thought-provoking books such as "Human Exploitation", "War—No Profit, No Glory, No Need" and "After the New Deal, What?"
