My dear Rabbi Silver:

The Ohio State Welfare Conference composed of approximately one thousand social workers and socially minded volunteers from all over the state will meet at Lima, October 16 to 19. In arranging the program, the Executive Committee is particularly desirous this year of giving to our evening general sessions, an inspirational character. The section meetings during the day are given over almost entirely to the technical phases of social work. It is our hope to devote the evening session, when the entire conference meets together, to the presentation of topics of national and inter-national interests. With that in mind, we have secured Judge Florence E. Allen of the Supreme Court of Ohio who will speak on "The Outlawry of War. " We are also expecting John Barton Payne, General Chairman of the American Red Cross, to speak on "The Truth of Mexico."

We are particularly anxious that the Conference Dinner which will be held on Thursday, October 18th at 6:30 PM, shall be the climax of the Conference. We want the address of the evening to be one that will send our workers back home with new inspiration and a renewed vision of the importance and worth whileness of their work. Would you be so good as to make the address of the evening upon that occasion? Although we shall leave the wording of your topic in your hands, might I suggest some such theme as "Social Imagination," or "The Function of Social Work in Community Life."

There will probably be between 750 and 1000 people in your audience that night. Many of them come from small communities in the state and the State Conference represents to them the one opportunity of the year to gain new ideas and inspiration for their work.

Many of the workers from Cleveland have requested that you be invited to speak and I am sure the Executive Committee of the Conference joins with them in a very cordial invitation.

The Conference will be glad to pay all your traveling expenses but unfortunately is not in a position to pay an honorarium.

Dear Madam: -

I have yours of June 17th in which you say Rabbi Silver ordinarily receives \$250 remuneration for an address. We do not question the reasonableness of this figure but it is absolutely more than we can pay.

You will recall that on March 6th you wrote me and requested me to address another letter to you early in the Fall. In your letter you advised me that you will do your best to be with us in January and that you will set a definite date for your coming to Lima.

As the Holidays are now over, the Board of my Temple requested me to write you again in the hope that it may be possible for you to come to Lima for our Annual Meeting and Celebration. We have always held these meetings on a Sunday evening at dinner in the Crystal Room of the Argonne Hotel. I have been requested to ask you if it would be possible and convenient for you to consider coming to Lima for a dinner meeting on either Sunday, January 5th, or 12th, 1941. I realize that you are in Temple at your own services until Noon. Mr. H. L. Solomon has been kind enough to say that he would gladly send his car and chauffeur to pick you up in Cleveland at any time you might designate, in order to have you here for this dinner and meeting. Lima finds Sunday evening to be an ideal time for this meeting, but we would be happy to accept any evening that you might designate, if Sunday proves to be impossible.

As I wrote you last January, our Congregation is small and our means very limited, and I hope that you will take this into consideration in naming your honorarium.

It has been seventeen years since you have been in our City, and we hope you will be able to revisit Lima and deliver the address of the occasion. My Congregation and I will take it as a great mark of personal favor if you
