



My dear Sir:

Your communication of June 1 is at hand.

We have you now tentatively assigned for an evening address at McCook, Nebraska on Wednesday, October 28. McCook is approximately two hundred fifty miles west of Lincoln, and we have checked all train schedules but find no possibility of making a connection from Minneapolis to McCook in the time available—late Tuesday evening until early Wednesday evening. There is no direct airway connection between these two cities.

In our previous correspondence with you, we have been thinking in terms of three addresses for you in Nebraska. We are not able, at this time, to state definitely, but we may be able to assign you a fourth address-the entire series of four addresses to be given within the three days which you are holding for us, October 28, 29 and 30.

I regret that the McCook-Minneapolis connection appears to be impossible. We have considered the possibility of rerouting you among our own districts, but because of other assignments, this, too, is impossible.

With a little more planning, we shall be able to forward you the specific assignments we shall have for you on October 28, 29 and 30.

My dear Rabbi Silver:

The presidents of our several Nebraska State Teachers Association districts have requested me to ascertain whether or not you might be available as a speaker for the teachers: meetings this fall. The conventions are scheduled for October 26, 27 and 28.

You will recall that we hold six district conventions simultaneously in six different conference centers scattered over the state. In contracting speakers, we usually find it possible to use a given speaker at two and sometimes three of these convention centers. This is done by careful routing among the several cities. In this case, of course, it is possible for the speaker to use the same address before the several groups.

Our convention programs are arranged on the basis of general sessions which are attended by all teachers of all levels of education, and section or division meetings which are attended by more specialized groups, depending upon the name of the section or division (such as rural division, mathematics section and so on). Addresses before the latter type of meetings are, of course, adapted in some measure to the particular interests of the group.

With this brief cutline of our convention set up, will you please quote your fees on the following bases: your fee for two days' service including, perhaps, two and not more than three appearances per day; your fee for one appearance on Wednesday evening and two or three appearances on each of the next two consecutive days; also your fee for one day's service? In each case we should appreciate having you specify whether or not your fee includes expenses.

Please understand, Rabbi Silver, that this is simply an inquiry concerning your availability and your fees. Any further developments must follow on the instructions of the district presidents, who are directly in charge of program arrangements. So that convention planning may go forward, I respectfully request your response at your earliest convenience. Thank you.
