Incidentally, if you have any suggestions for the improvement of this kind of function over those you have witnessed I would appreciate your observations. 3) In re our telephone conversation about whether or not another Reform congregation is needed in Cleveland, I am glad to say that your warning about the need to deliberate on this matter is being heeded. A meeting of representatives of the four East Side temples is being called for Thursday, March 19. I believe. Rabbi Albert G. I am very heavily committed, as it is, to out-of-town lectures, campaigns, etc. I am sorry that you found it necessary to broach the subject of a new Reform congregation in Cleveland to me over the telephone from the Airport. It is a rather unusual way to present a serious subject. Personally, I see no point in a member of your staff coming to Cleveland on March 19th to discuss it.
