

There is a train which leaves Atlanta at 9:40 A.M. and also a local around noon which does not arrive in Montgomery until 5 P.M.

I note Rabbi Silver plans to be in Montgomery Thursday, February 14th. You know of course the Service is scheduled for Friday night, February 15th at 8 P.M.
