


I am sorry to say that we have already filled the program for the 5th, 12th and 19th of January. I do wish, however, that it might be possible for you to come some time during Dr. Wise's absence. The difficulty is the uncertainty, and it is hardly fair to you or to the congregation here to sehedule you again unless your coming is positive. I do not suppose that you can secure from the members of your congregation a pledge that they will postpone all services in which you are needed until you can return.

Had you been in town, I would have gone to your office and spent part of the day with you. In your absence, I went back to the Kountryside and had a very delightful, quiet time up there.
