My dear Sir:

I am writing to you on behalf of the Youth Temple Club of Beth El Temple, of this city, with reference to engaging you to speak in Norfolk sometime during the winter.

Our organization is composed of young Jewish men and women, and has for its purpose, among other things, the promotion of better understanding between Jews and non-Jews.

We desire to engage you to speak to a mixed audience on a subject that will promote such better understanding between the Jews and non-Jews of our community.

We know that there is a great number of people in Norfolk who would like to hear you if you came to this city to speak. We desire, therefore, to fix the admission at a price that would permit the largest number of people to attend in order that we may accomplish the greatest good. This would be the first time our organization had undertaken such a program. We feel, however, that regular activity along this line will prove very fruitful, and for this reason we should like to be able to realize enough profit out of this engagement to set up a reserve for continued work along the same line. For this particular engagement it will be necessary for the organization to go to some of its friends and members and have them underwrite our obligation should we be able to arrange with you for your engagement. For these reasons we ask for most favorable terms under the circumstances. The auditorium which we have in mind will seat about 1,200 people. We intend to charge an admission of 50¢ per person, and to give the program publicity and advertising.

We shall be grateful to receive from you your terms, available dates, and suggested subjects, which we await with interest.

Dear Rabbi Silver:

I shall probably have difficulty in recalling myself to you, but I have met you on a number of occasions, both at Zionist and United Palestine Appeal conventions, and I hope to see you in Cincinnati on September 6.

As one of the national co-chairmen of the United Jewish Appeal, you probably know that Norfolk has not yet had its 1941 U.J.A. campaign. We have now decided to have it in the fall. I am one of the co-chairmen, together with Mr. David Friedman, whom you may remember, and Mr. Alan Nordlinger. A meeting of the executive committee voted unanimously to have you for our principal speaker at the banquet which will open our 1941 campaign. Last year we had your colleague, Dr. Stephen Wise. This year we have chosen you and you only.

Please consider this an invitation to be with us as principal speaker at the opening of our drive, the date to be chosen for your convenience any time from Sunday, September 28 through October 15, excluding Friday evenings, Saturdays, and all holidays. We desire to have you with us for two reasons: first, you are the only man who can awaken the community to the necessity of giving; and second, your connection with the Zionist organization. As you know, Norfolk has always been a Zionist city, and we feel that your coming to us this year may increase the interest in Zionism.



Once again I am writing you to extend an invitation to open the Beth El Men's Club forum for the 1945-46 season. I trust that this time I will have an affirmative reply.



As part of our centennial celebration, we are planning a forum which will present outstanding personalities in American and Jewish life. We would very much like to include you among the speakers.


We know that you are very busy, and that there are many claims upon your time. Yet we feel that we have a 'claim' upon you for several reasons:


1. There are few congregations that can boast of 100 years of existence




