The Men's Dinner Club here in Oklahoma City has now been functioning for more than thirty-eight years. We are beginning to plan our program for next season. This will start in October and run through May and we will have eight numbers as usual. A copy of our program for last year is enclosed so that you might see the caliber of our speakers.

During the past week we have had a pleasant visit here in Oklahoma City with Dr. Olson of your city. As a result of this visit and our discussion of you, I am writing to inquire if you would be interested in appearing upon our program some time this season and giving us a lecture upon the great Jewish problems. Our club consists of five hundred of the leading businessmen of Oklahoma City and I am sure they would be interested in a fine lecture from a fine speaker on such a timely subject. Dr. Olson says that you would meet the bill in every respect.

Of course, we would expect to pay you for the lecture just as we pay practically all of our speakers. Won't you let me hear from you at your convenience.

Dear Dr. Silver:

As chairman of the Oklahoma City Zionist Emergency Committee I should like to appeal to you to assist the organized Zionist movement of Oklahoma City in a revitalization of its program here. While from a membership point of view we are more than holding our own, we have nevertheless retrogressed from both a psychological and programmatic standpoint.

Recently we sponsored an ACPC Seminar in Oklahoma City which evoked a very fine response from the non-Jewish community and which can serve as an impetus for the development of a vital ACPC Chapter in Oklahoma City as well as a strong American Zionist Council program.

However, as you well know, prerequisite to the success of such programs in the general community is the necessity of having the Zionists of the community united in backing such programs. Unfortunately our Zionists are far from united, are confused by the trend of Zionist events the past few years, and are, therefore, poorly equipped to carry out such sustained programs. The work of the local chapter of the American Council for Judaism, now inactive, has also left its detrimental effects.

Recently Mr. Harry Steinberg of the American Zionist Council was in Oklahoma City and we discussed this situation in detail. During the course of our conversations I inquired as to the possibility of your coming here to address a meeting of the entire Jewish community to be sponsored by the General Zionist groups. Mr. Steinberg thereupon suggested that I communicate with you with regard to coming to Oklahoma City and added that the next time he saw you he would discuss it with you in detail.

I am confident that your appearance here would bring a minimum audience of 400 to 500 people, which could be augmented if non-Jews

Please pardon the delay in answering your kind letter. I have been away from the city a good deal of the time.


