My Dear Rabbi Silver;

Hardly a day has passed this Fall that I have not been asked by one or more of our people as to when I was going to make good my promise to bring Rabbi Silver to Pittsfield. I made this promise to them last year on the strengthh of our correspondence, in which, you expressed the hope that you might be able to visit Pittsfield this year.

Our Lodge is this year sponsoring the local falmud forah. We have undertaken the work of reorganizing the school along modern lines of Jewish Education. In order that we may proceed along well guided lines, we have caused to be made a complete survey of our Jewish community under the direction of the Jewish Bureau of Social Research, of New York. Their reccommendations for the Talmud Torah calls for an annual expenditure of about \$7000. Of this ammount \$4000. is pledged and we are faced with the problem of raising the balance.

I am convinced that a lecture with Rabbi Silver as the speaker, will net us a sizeable sum. May I express the hope of receiving a favorable reply from you.
