
Since I have successfully negotiated for your two appearances in Portland, I want to write a personal word to assure you how anxiously our community is awaiting your coming.

When I first projected the matter of inviting you to our Men's Club I suggested that they have an open meeting for men and women, but they rebelled because they want you all to themselves without the women present. In order therefore to silence the cry of indignation that would naturally arise, I fixed it so there would be a women's meeting in the afternoon, and the credit is to go to the Junior Council. They consider it a great feather in their caps to be presenting you to the Jewish women of the city. By the way, if you do not already know it, the fees have been fixed at \$300.00 for the men and \$150.00 for the women. The date is Thursday, February 21, 1929.

From the personal standpoint Claire and I will be delighted beyond words to have you with us, and hope the chance will be given to get together a little by ourselves. If possible, I would love to have you in my pulpit the following night, which is Friday. You know we have this gorgeous new Temple out here; and surely your agents who arrange your tour have no right to prevent you from performing such a mitzvoh as delivering some sort of a message from the pulpit. I would consider it a high privilege to have you, and I know that the people would storm the gates. If your trip permits it, Abba, please give us this treat in addition to your scheduled platform engagements. After all, you get to this far Northwestern empire so seldom that I feel you ought to give us as much of your marvelous inspiration as you can. Let me hear from you as soon as you can.


Dear Abba:


Dear Rabbi Silver:

The last week-end in June, namely the 26th, 27th and 28th, will bring to Portland for the first time in many years the Grand Lodge Convention of District Number Four B'nai B'rith. This includes nine states of the entire Pacific Coast region. You probably know that B'nai B'rith in the far west is one of the most important forces in Jewish life. The Lodge means a great deal in our western cities. In Portland Jonah Wise was President of the Lodge and later President of the District. Edgar Magnin was also President of the District. Portland Lodge has had among its leaders for many years all the outstanding Jews whose names are familiar to you. I cite these facts in order to impress you with the significance to us of the Grand Lodge Convention.

The Convention Committee met this week to lay out broad plans, and our first decision was to contact you to see if you could come to Portland to deliver the opening and keynote address. In fact you have been owing us a visit for a long time, and now the occasion has come which we feel is big enough and important enough to justify this invitation.



I am addressing you as President of the B'nai B'rith Center, the Jewish Community House of the City of Portland. This institution serves the entire Jewish community, irrespective of class or religious affiliations. It was founded by Rabbi Jonah B. Wise, the late Ben Selling, Z. Swett and others in 1910.

Recently this Community raised funds to enlarge and remodel the facilities of this institution in light of present day demands. This project is now nearing completion, and we are planning to dedicate this Community House on the evening of April 7th or 9th, 1938.

As a member of the Oregon Jewish Welfare Fund, now engaged in shaping the plans for your visit to Portland, in connection with our drive for J.D.C. and U.P.A. and other institutions, I know that you are scheduled to arrive in the City of Portland about 7:30 P. 
