

#### My dear Rabbi Silver:

Before giving you the final details concerning your appearances before our zone meetings it has been necessary for me to consult with our zone officers. The arrangements I have been able to make have made it necessary, in order that all the teachers may have the privilege of hearing you, to use in some case two or three meeting places. That, of course, means that it would be necessary for you to speak, using the same address, two or three times during the day. Experience in the past has lead us to believe that our speakers would prefer to speak two or three times in theaters or school adutioriums where the seats are comfortable and the acoustics good rather than to try to crowd an audience into large auditoriums or state armories where the seating arrangements are poor and the acoustics very bad. The following is the schedule I have worked out and I hope it will meet with your approval:

SCHENECTADY, Thursday, OCTOBER 21, at 9:30 in a theater; at 10:30 repeating the address in another theater; at 2:30 p. m. addressing the high school teachers in a high school suditorium.

LAKE PLACID, Friday, OCTOBER 22, one meeting in the Lake Placid Arena. I shall see to it that you have transportation from Schenectady to Lake Placid, and back.

NEW YORK CITY, Friday, OCTOBER 29, Madison Square Garden, one meeting at 10:30.

There is also a possibility that it can be arranged to have you speak at Rochester on Thursday, October 28. The detail on this is not complete so I cannot give you definite arrangements.

I assume that where we ask you to speak more than once at a meeting that your honorarium would be somewhat in excess of \$200. I do not interpret your letter to mean that it would be \$200 for each time that you spoke. May I hear from you at your earliest convenience whether these arrangements are satisfactory and what your revised honorarium should be to cover the arrangements as presented?

The fact that the New York meeting is a week later than the Lake Placid one will, of course, necessitate my returning to Cleveland. This will make an extra traveling expense which would be absorbed, however, in the total honorarium for the five lectures which you have scheduled.

I shall be pleased to hear from you about Rochester.



Dear Abba Silver:

As you may know, we have had unusually successful and significant interfaith programs in Rochester during the Brotherhood Week period in February. Last year we sent teams of local priests, ministers, and rabbis into every high school and parochial school in our community. There were important programs every evening on the radio and editorials in the press, etc., etc. The whole program had its climax at a great dinner meeting which filled the Chamber of Commerce on the evening of Washington's birthday.

This year we plan a different type of program and that is the reason why I am writing to you. We hope to build the entire program around a great mass meeting to be held on Thursday evening, February 20, in the Eastman Theater which is the largest and most beautiful auditorium in the city. We are inviting three speakers of national reputation and hope to present the program in such a way both through the press and the radio that it will take on a national character.

The Catholics are inviting Jim Farley, the Frotestants are inviting Robert Taft, and I am writing now to ask whether you would consent to participate in this program. I cannot begin to tell you how much it would mean to our community and to the broad purpose of this undertaking if you would agree to come.

I do hope you will appreciate that this will not be just another local good will meeting but a great community demonstration which will reach out into every area of our community life and whose repercussions will be felt, we firmly believs, throughout the land.

I wish I could write that there would be some substantial honorarium available commensurate with the service you will render, but I cannot. Our remarkable interfaith program in Rechester has been achieved entirely on a voluntary basis, and it might be embarrassing in this instance and partially defeat the purpose of the program

to raise substantial sums for speakers' fees. 

I look forward to hearing from you soon and hope that the response will be favorable.



This will be our Annual Institute for the Clergy which actually brings out more Protestant clergymen than assemble during the year this for any other purpose. They include the Rochester and area clergy as well as the faculty of the Colgate Rochester Divinity School. Our Institute speakers have been top Jewish scholars and thinkers. We attempt to provide serious fare, - not platitudinous good will.




