My dear Dr. Silver:

It is my thought that we should have a mass protest meeting in our city, similar to the one held recently at Madison Square Garden in New York.

Because of the smallness of our community, however, and the paucity of the Jewish population, some representatives of our Jewish organization groups feel that it would do more harm than good in that we are living peacefully with our Christian neighbors and are certainly not warring with the government of our country - that such a meeting would bring undesirable repercussions and create an unnecessary stir in our general community.

May I have your opinion regarding this trend of thought? Do you think that we ought to have a mass protest meeting in our city? The general population of Rock Island is 42,000. The Jewish population is 1500.

March 17, 1943 Rabbi Irving B. Faden, E xecutive Director The Tri-City Jewish Center Rock Island, Ill. My dear Rabbi Fadens It is rather difficult to advise you on the subject which you raise in your letter. Mass protest meetings are not the only way of bringing to the attention of a community the tragic plight of European Jewry today. If in your particular community a mass meeting is regarded as undesirable, other methods may be employed. Some communities have used a quarter of an hour on the local radio station with good effect -- a short account of the mass slaughter of Jewry, a statement by one of the leading citizens, and perhaps the chanting of the memorial prayer. Some communities found it advisable to see the editors of the local papers and suggest to them the inclusion, prominently displayed, of an article on the situation, and the writing of an editorial on the subject. I don't think that any Jewish community ought completely to ignore this very serious situation. It is very helpful if the organized Jewish community would send a letter, or a group of letters to the Congressmen and Senators of the State about the subject, and to the State Department.
