


Dear Dr. Silver:


Dear Dr. Silver:-

My dear Dr. Silver:

I was sorry to learn from your secretary, Mrs. Sparrow, that you were home with a cold and hope by the time you receive this you will be entirely well.

Was distressed to learn that air accommodations from Cleveland no longer connect with the flight arriving here at 5:15 P. M. I immediately called Mr. J. R. Russell informing him of my conversation with Mrs. Sparrow and he assured me that he was certain that a fine airplane would be put at your disposal by either Texas Eastern Transmission, United Gas, or the Shreveport Times, all of whom have fine all-weather aircraft in which you can have perfect confidence.

It may well be that by the time you receive this letter I shall have 'phoned or wired your office to let them know the exact arrangements. Plans are being made to have you picked up at the Cleveland Municipal Airport at either 1:30 or 1:45 P. M. thus allowing time for transportation from the Temple to the Airport. I regret the anguish that this complication seems to have caused your office but I can assure you that an increasing number of people look forward with great anticipation to hearing you and meeting you on that night.

Of course, Dr. Silver, arrangements will be made to get you back to Cleveland as soon as you must depart. I would appreciate it if you would ask Mrs. Sparrow to write us of your decision in this matter so that proper arrangements may be made at this end.

The President of my Congregation, Mr. Henry E. Cahn, is opening his home for a reception in your honor after the Religious Rally at the Fair Grounds. The prominent ministers and laymen of the community will be invited to that affair. It will not be lengthy or tax you unduly but since it has been done after the two previous annual rallies, it is considered it shall be done to honor you in some way.

Dear Dr. Silver:


Although this letter is being written while you are still in my community, I wanted to greet you upon your return home.




