My dear Friend and Colleague:




We appreciate the fact that your time is well taken but we are hoping that there might be a possibility of your giving us a date here in Sioux City around February 23rd or 24th next.


Dear Rabbi Silver:


Dear Rabbi Silver:

You may recall that I wrote you last May suggesting a speaking engagement on our program for this past season, but due to the fact that you were away, you were not able to answer my letter until June and by that time we had had to complete our contracts. I wrote you at that time sending my regrets that the program had been filled and suggested that I would again write you for this next winters season.

I sincerely hope that time time we will have the honor of your name on our program and since we are just starting consideration of speakers we can offer you almost any date that would be convenient to you. Our season starts about mid-October and if possible we would like to open with your talk. However any month from October until Mid March would be agreeable to us if a later date would be best for you. There are only one or two exceptions--we do not have meetings on Mondays, Saturdays or Sundays--any other day of the week is OK, and during the holiday season we try to space our December and January meetings so that the December meeting will not come after December 10th and the January meeting will not be before January 15th. 
We are very happy to receive your acceptance of a speaking date with us, Tuesday October 17th, 1949. You may keep this letter as your confirmation of our acceptance of this date.






Dear Rabbi Silver:




Would it be possible for you to accept a speaking engagement at our Jewish Community Center this Fall or Winter, preferably on some aspect of Israel's current problems?
