My dear Rabbi Silver:

We have a rather remarkable Forum in connection with our church and we have a great many good friends beyond the borders of our own parish. I am particularly happy to work with some of the local Rabbis from time to time and we have in mind at the moment the possibility of a Forum at which the Zionist cause might be brought to the fore. This seems a particularly opportune time to present the future status of Palestine and to draw attention to the plight of our Jewish friends in eastern Europe.

I am writing in the hope that you might be in New York or Boston sometime in the next two or three months and that you could speak for us on a Sunday evening. We are willing to pay any reasonable honorarium you might care to mention. As a matter of fact if you could not come on a Sunday evening - and it might be difficult for us to make the necessary shift or change - I see no reason why we could not arrange to have you speak on a Sunday afternoon or perhaps some evening during the week.

We are desperately concerned to bring you to Waterbury if at all possible. If there is the slightest hope of your being able to speak under our auspices, may we have a word to that effect?
