Dear Rabbi Silver:

As Dr. Bernard Martin has told you, we are considering the publication of an English edition of Israel Zinberg's HISTORY OF JEWISH LITERATURE. This project was brought to our attention by Dr. Martin, who proposes to undertake the translation of the nine volumes issued in Yiddish and also to prepare such additional material as might be needed to bring the work up to date.

The specialists whom we have consulted enthusiastically support Dr. Martin's opinion that no more authoritative work on the subject has been published and that an English edition would make a significant contribution to scholarship and to the enlightened general reader's understanding of Jewish literature and culture. We are thus persuaded that publication of an English translation under the imprint of a university press is appropriate, and we would naturally be pleased to be associated with the issuance of this classic study.

In view of our limited resources, we are, however, concerned with the economics of issuing so large and complex a work, whose preparation and publication would necessarily be costly and protracted (we are thinking in terms of bringing out one of the nine, or perhaps ten, volumes annually). Before submitting the project to the Press Committee, we are therefore exploring the possibility of outside financial assistance, and it is in this connection that we turn to you. Do you believe that the National Foundation of Jewish Culture might consider making a grant in partial support of the translation and publication of Zinberg's multivolume study? If not, could you suggest other foundations or institutions to which we might apply for a subvention?

I assure you that any advice you might give us would be most appreciated. If you can take time from your busy schedule to discuss the project more fully, Mr. Webber, the director of the Press, Dr. Martin, and I would be happy to meet with you, at your convenience.



I have invited Dr. Bernard Martin, the Abba Hillel Silver Professor of Jewish Studies at Case Western Reserve University to occupy the pulpit this Sunday morning. Dr. Martin is an old friend as well as a cherished fellow member of The Temple. He needs no introduction. I know you will be interested in keeping up with his work and his accomplishments.

His courses at Case Western Reserve University are crowded. An introductory course on Contemporary Jewish Life and Thought has an enrollment of over 120. He is Chairman of the Department of Religion and has organized a fine curriculum and increased the size of the Department three-fold.

Dr. Martin has just published an impressive new work, Judaism and Prayer. It is a beautifully printed anthology of some of the most significant prayers in our liturgy. Perhaps the most important part of the book is the highly competent introduction in which the reader is made to understand the history, the terms and the thrust of our worship. 

Dear Dan:

Following up our recent conversation I am sending along a proposed budget for research on the biography of your father.

I expect to have my book on modern Hebrew and Yiddish literature for Greenwood Press pretty much finished by September 1, and I plan to devote all of my free time during the remainder of 1980 and during 1981 to the biography. I am projecting a fairly long work, between four hundred and five hundred pages, and I expect to have it in fairly complete form by the end of 1981.

The budget I am proposing is, I think, a maximal one. Expenses should not run more than the figures I have indicated, and they may be less.

As I indicated to you I would prefer that no funds be transferred to CWRU, since the university takes a substantial amount in overhead expenses. It would be better, I think, if I could simply submit bills to your fund for my expenses and be directly reimbursed.

Let me add that the substantial amounts budgeted for secretarial help are necessitated by the fact that the university administration, in its present economy drive, provides me with only a few hours of secretarial service per week.

If you have any questions about this budget, please call me and I will be glad to join you for lunch and talk it over.




MEMO of telephone conversation with Dean Dixon Long, Wednesday, August 27.


It was good lunching with you the other day and having a chance to talk things over.



Dear Dan:

I just returned last night from a three-day drip to Boston. The few sessions of the Association for Jewish Studies that I attended were, as you can imagine, a complete waste of time. However, I had very valuable four-hour session with Harold Manson, who was there on behalf of the American Friends of the Hebrew University and spent some extremely profitable hours at the Harvard library and at the American Jewish Historical Society in Waltham.

I do not yet have a complete statement of my expenditures during this calender year for the biography, but I am sending you what I have. As you will notice, it comes to \$2389.92. There may be \$200 or so in additional expenses for which I do not yet have bills, but I will give you a final statement in January.

I am also sending you a projected budget for the first six months of 1980. By the end of June I expect to have virtually all of my research completed and a first draft finished. Memo to Daniel Jeremy Silver:

Had telephone conversation with Eldon Epp on Friday, February 13, 1981. Epp called to talk with me about relationships with Martin. They are concerned that he has been teaching only one course and he spoke of correspondence, about teaching more, and Martin's response was an esoteric course at eight A.M.

He spoke of Martin's long-standing anger against Long and wanted me to know that one of the pressures that they were using on Martin was to cancel my course for next year. The call was to indicate that it had nothing to do with me, "I'll be happy to have you teach all the courses? but they were going to "begin to use pressure."

I indicated that I had never been involved in university politics and was not about to begin. that I would be angry only if the issue became one when my good name or competence was somehow involved. He assured me that this would not be the case, and that it was, in fact, to reassure me of this that the conversation had been initiated.

The last part of the conversation centered on whether his son would enjoy being at Harvard.

Dear Danny:

There is no obvious candidate that I can think of to do the projected biography of your father. Five possibilities are the following:

1. Robert Shapiro is a graduate student at Harvard who is writing a doctoral dissertation on Stephen Wise. It should be almost complete. I have met him and been impressed favorably by his seriousness. I would suggest that you write to him to see if he is interested. If so, ask to see some chapters of his dissertation. His home address is 1918 E. 27th St., Brooklyn, NY 11229. Tel. (212) 376-8773. His address at Harvard is 121 Holden Green, Cambridge, MA 02138.

2. Aaron Berman is or was a graduate student at Columbia University. He wrote a paper entitled "Abba Hillel Silver, Zionism and the Rescue of European Jews," which appeared in the memeographed Working Papers, II, published by Columbia University in Spring 1979. It was edited by Paula Hyman (now the dean of the undergraduate program at JTS). Paula could no doubt tell you about him. I read his paper and found it competent, though not exciting. You may want to look at it.

3. It may be that Melvin Urofsky can be enticed to take on the project despite what I understand are recent interests in other areas. Urofsky certainly has the most experience, is able to work rapidly, and has a felicitous writing style. I am not sure, however, how thorough he would be or how well he could handle other aspects of the career aside from the Zionist one.

4. Here's a way out suggestion. How about David Polish, who has some scholarly credentials, certainly knows all aspects of your father's career, and I presume has some time on his hands these days?

5. Should you want to go for an Israeli, (which makes for all manner of complications, but makes a Hebrew edition easier), I have high regard for the work of Evyatar Friesel of the Hebrew University. He has written a fine book on the early phase of Zionism in America and he has some understanding of other aspects of American Jewish history as well.

Whoever you select, be sure to give that person a free hand to let the chips fall where they may. If I can be of any further assistance, don't hesitate to be in touch.

Thank you for your recent letter. I apologize for not writing to you sooner, but I have been out of town for the past few weeks and this is the first opportunity I have had to take care of my correspondence.

In answer to your question, yes, I would be interested in writing a biography of your father. While there has been some work on Abba Hillel Silver as an American Zionist leader, I think a study of Abba Hillel Silver as a Reform Rabbi is needed for a better understanding of Reform Judaism in America.

While I would be interested in writing a biography of Abba Hillel Silver, I am not at all certain that I would be the appropriate person for this particular project. You stated in your letter that you are "interviewing those who could bring off such a work within an appropriate period of time." I am not sure what you mean by that.
