Dear Rabbi Silver:

I was deeply impressed by your sermon on Dr. Freud last Sunday.

You addressed yourself to basic misconceptions and misapplications of Freudian theory to child rearing practices. In our daily business we continue to run into people in strategic positions who attempt to apply to the general population concepts derived from clinical psychiatric practice. This is undoubtedly one of the significant factors which have sanctioned the "era of the id" characterized by impulse release and by a weakening of the concept of duty.

I believe the clergy can make a powerful contribution in correcting such distortions.

As for not running to the psychiatrist for each minor bruise, I don't know how this can be stopped unless psychiatrists themselves discourage such excessive dependency. Of course, this is less of a problem for people who cannot afford to pay the psychiatrist's fee.

In the near future, our Association will be planning a conference on Religion and Mental Health. We hope to get the participation of the National Academy of Religion and Mental Health, local clergymen and psychiatrists. Would you be willing to serve on the planning committee for such a conference?


