




I am really in a dilemma, to put it mildly, and I am beginning to empathize thoroughly with our lay leadership.

Dear Mr. Barron,

A friend of mine here in Chicago who is himself an active member of the Foundation has suggested that I write to you with respect to a rather serious problem that has cropped up in the course of my current research.

While investigating historical documents from the Cairo Genizah -the area in which I do most of my work -- I have recently had the good fortune to come upon a long Hebrew letter of recommendation written by the members of a French Jewish community (probably in Arles) to their correligionists overseas, and concerning a social situation of great historical interest, This manuscript is now in the British Museum. By careful examination of photographs, I have been able to elicit the fact that it contains a description of a feudal relationship existing between a wealthy Jewish landowner of Rouen and a duke of Normandy some years before the Norman Conquest of England in 1066. A small portion of the manuscript had previously been published, but the editor had misread the crucial geographic name (along with other important words) and thus was led into giving only the slightest attention to this extremely valuable text. Not only did he wrongly identify the geographic area mentioned in the document, but also, by his few sparse statements about this text, made it clear that he did not at all understand the significance of the letter for the history of Normandic feudalism and of the Jaws of Normandy in Carolingian and pre-Conquest times.

On the basis of the recognition that the manuscript concerns a Jew of Rouen and the dispossession of his lands by a Normandic duke, and of the significance of other details in the letter, I have been able --with the aid of certain Latin and Hebrew sources -- to reconstruct the salient features in the history of the Jews of Normandy until the transference of some of their numbers to England by William the Conqueror and the anti-Jewish outbreaks at Rouen at the time of the First Crusade (on which latter event of. my remarks in PAAJR XXXIV, 1966, pp. 19 ff.). Moreover, the decipherment of the misread crucial geographic term has made it evident to me that previous scholars and readers of Hebrew manuscripts, including of course the early typesetters, may also have misread this term in still other places. I have already located approximately twenty examples in (printed) Horew texts where such a misunderstanding would appear to have been made. The result of this error has been that Jewish historiography recognizes no community of importance at Rouen in the Middle Ages, instead assuming that the readings in the printed texts point to relatively unimportant towns in northern France -- and it has, to be sure, even been assumed as a result of statements in those texts that these towns, and not Rouen, were seats of Jewish learning in the Middle Ages. All this is not

consonant with general historical information relating to Rouen; and it is a fact that in those few cases where comparison of the printed texts with manuscripts has been possible, the underlying reading has indeed proved to be the "ebrew term for Rouen, and not anything that would equal these other towns.

I have now prepared two rather lengthy essays on the British Musoum manuscript and its historical implications; but before submitting these for publication must examine all available manuscripts underlying the suspected readings of the printed texts. I believe that in the great majority of cases the manuscript readings will tend to confirm my hypothesis regarding the importance of the Jewish community of Rousa -- and of Normandy in general -- in the middle ages, something which is at all events indicated by the British Museum manuscript described a-The significance of the results may be gauged by the fact that bove scholars in the past, not having recognized the importance of Rouen for Jewish history, have assumed that Abraham ibs Esra, before arriving in England, stayed for a period of several years not in Rouen -- which even a few old printed texts in fact imply -- but rather in unimportant towas elsewhere. That he did in fact stay in Rouen and write some of his Biblical commentaries there I have hoped to show in the aforementioned essays. However, it remains for me to substantiate in greater detail both these and other results by an examination of the manuscripts comtaining the suspected readings, which are in London, Oxford, Paris, Rome and Parma, as well as in "erusalem. I find that it will be possible for me to do this during December and the first part of January, and have been granted a short leave by the University during that period. While in London I also hope to subject the British Museum manuscript described above to a new examination under ultra-violet light, as a number of orucial phrases are not legible in the photographs supplied to me. It is of course obvious that the results of this investigation have to be published at the earliest possible time. I plan to deliver at least one of the two finished essays to my publishers in "erusalem this winter, upon completion of the examination of the manuscripts.

In order to realize this venture, I must secure a travel and research grant of approximately \$900.00 (1.e. air travel in the amount of \$700.00 plus a portion of the other expenses). I had, before writing to you, applied to the American Academy of Arts and Sciences for such a grant, but in their letter to me of Nov. 14th they state: "Sadly, the Research Funds Committees have dropped their former system of making grants to individuals for research. The Academy found that it was a very difficult problem selecting a small number of recipients ... when so many requests were received .... What has happened is that in the past three or four years our research funds have been restricted to projects sponsored by a group of Fellows or jointly with another organization .... " In view of this change of policy, I now find it necessary to write to you to inquire whother a research grant in this amount might be tendered to me by the Foundation. If some aid of this kind may be forthcoming, I should of sourse welcome it; and I look forward to hearing from you regarding this possibility at your earliest convenience.

## NORMAN GOLB

Dr. Norman Golb is a specialist in Hebrew and Judaeo-Arabic studies, with particular reference to Jewish culture in medieval times.

[NOV 22, 1967

Born in Chicago in 1928, he was a student at Roosevelt College, the College of Jewish Studies, and the University of Chicago; and in 1956 he received his Ph.D. degree in Judaic and Semitic Studies from the Johns Hopkins University. He subsequently served as secretary of the Institute of Jewish Studies of the Hebrew University in Jerusalem.


During his student years he held several fellowships, including the Cyrus Adler Post-Doctoral Research Fellowship at the Dropsie College for Hebrew and Cognate Learning and the Warburg Fellowship for Research in Judaic and Semitic Studies at the Hebrew University.

In the academic year 1957-58 Dr. Golb served as Visiting Lecturer in Hebrew and Semitic Studies at the University of Wisconsin (Madion); and from 1958 until 1963 he was a faculty member of the Hebrew Union College in Cincinnati, Ohio.

Dr. Golb is the recipient of two research awards from the American Philosophical Society (1959 and 1963) and of two additional awards from the American Council of Learned Societies (1962 and 1965). He was a Guggenheim Fellow in 1964, and in this capacity conducted research at various European libraries, including those in Cambridge, Oxford, Leningrad and Budapest. He has spent a total of five summers working on the Cairo Genizah fragments of Cambridge University Library. A second Guggenheim Fellowship was awarded to him in 1966.

Dr. Golb's recent discoveries have included the identification of Obadiah the Proselyte as the author of the oldest Jewish musical manuscript (12th century); the recovery of a Genizah document describing a prominent Suropean convert to Judaism of the beginning of the 11th century; the identification of the earliest extant legal record of the Jews of Sicily; the ancovery and decipherment of an original manuscript of the Khazar Jews; and the identification of a new document dealing with the First Crusade. His essays and articles have appeared in various scholarly journals both here and abroad.

Dr. Golb is married and the father of three children, residing with his family at 5813 South Blackstone Avenue, Chicago. He is a Voting Member of the Oriental Institute, and serves at the University of Chicago as Associate Professor of Medieval Jewish Studies in the Department of Near Castern Canguages and Civilizations.




## Memo to Files Re: Washington, D.C.

In the course of the 1967 Ceneral Assembly in Cleveland, I had an extended discussion with Meyer Brissman, Executive Director of the United Jewish Appeal of Greater Washington. He wished to explain the reason for his agency's resistance to admitting the NFJC as a beneficiary agency. He pointed out that the history of the agency was different from most local Federations and Welfare Funds, having been started primarily to raise funds for overseas purposes and establishing a pattern which through the years has become highly rigid. It took many years for local service agencies to be admitted as beneficiaries, and to this day some agencies, like the Home for the Aged, are not in the "Federation", having been compelled to develop a fund-raising apparatus of its own it now prefers this to inclusion in the central organization.

For years the distribution formula remained unchanged, the National UJA receiving almost all of the campaign proceeds. It now gets 75% of the net proceeds. There have been numerous attempts to get some modification of this pattern but each effort to change the percentage by as much as a point or two has been accompanied by serious conflict and much acrimony -and usually to no avail. For some years Aaron Goldman spearheaded such efforts but finally gave up.

Mr. Brissman expressed the belief that a head-on confrontation by the MFJC to obtain inclusion would be unproductive. He counselled instead the use of an interim program of local fund-raising on behalf of the NFJC which would provide the agency with needed moneys and would also establish the image of the Foundation as a cause which can obtain local support which will pave the way for its ultimate admittance into the Washington UJA. It was his suggestion that a person like Aaron Goldman get together a few influential leaders to lend their names as signatories to a letter to selected Washington individuals requesting contributions for the NFJC. This approach would entail the least amount of campaign apparatus and follow-up and would give the Foundation some initial funds as well as visibility. Next steps could be considered following this first effort. He mentioned a David L. Kreeger (?) as one who has been much devoted to music and art and gives vast sums as well as his personal efforts to such causes.



A quick report on my contacts since our telephone conversation:

1. <u>Harry Starr</u> - The Littauer Foundation Board has not yet met although Starr had planned to have had a meeting this week. It was necessary to change the meeting date. He hopes that the meeting can be held in the next 1D days, but in any event decisions will have to be made before the end of December. He expressed interest in the material we had sent on the Foundation and repeated his former opinions about the failure of the local federations to seriously accept responsibility for supporting Jewish cultural endeavors. He was cordial and affable, and said that he might be in touch with me shortly to discuss some of the details of our proposal.

2. Rabbi Judah Nadich - I had a lengthy and rather frustrating conversation with him in which he expressed his resentment at the manner in which he was initiated into his Foundation Board service. He was offended that even before he attended his first meeting he was called upon to help raise funds and to serve as "bait" for prospective donors. He was also offended by what he regarded as hostile comments regarding the failure of rabbis to discharge their responsibilities. He will not be able to attend our Board meetingon December 11th. He is always out of town on Mondays. When I asked about the possibility of having a few people in for a session the following day (Tuesday), he said flatly that he was not prepared at this time to bring together any people in 'schalf of the Foundation. He would have to be much more convinced about the significance of the Foundation's work before undertaking any fund raising efforts on its behalf. He explained that he is already heavily committed to tapping his congregants for similar causes and he sees the Foundation as an additional competitive instrumentality for which he cannot presently assume any fund raising activity. He is taking a "wait-and-see" attitude as to whether the Foundation intends to use him in ways other than fund-raising, leaving the impression that he regards his election to the Board as related primarily to his ability to secure funds from New Yorkers.

3. Norman Golb's Request - You will note from the enclosures that I have sent the letter to Golb, but since I was somewhat uneasy about the matter I made several inquires of people who are well-informed in the particular field, (Z. Szajkowski, Arthur Zuckerman and Abraham Halkin). All three were critical of his recent article in the <u>Proceedings of the American Academy</u> for Jewish Research, and two of them were rather dubious about the significance of the document in the British museum that he refers to. There is some question about whether Golb could not secure the necessary funds from other sources and also whether the documentary verification he requires could be

obtained without his making the trip overseas. It is altogether possible that microfilming or even ultra-violet ray photography could be arranged for so that he could obviate the trip abroad. However, I gather that your receptivity to his request may be somewhat influenced by political considerations. My letter to Golb, therefore, is a bit ambiguous and if we should subsequently decide not to go through with it we would have an "out".

+. Marshall Sklare - My hunch was confirmed: he was somewhat concerned about the possibility of embarrassment in the event one of his own projects might come up for consideration by the Academic Advisory Ccuncil. I explained that the Foundation's Board had already viewed with favor the project he submitted last year so that this would probably not come before the Academic Advisory Council. He agreed to give further consideration to serving and will let me know as soon as possible. We discussed at some length possible names for directing our research study and were aware of the difficulty of finding a person possessing both the methodological skills as well as the requisite content orientation. Some of the names he suggested were Jacob Neusner, David Sidorsky (of Columbia), Milton Himmelfarb and Lucy Dawidowicz (both of the American Jewish Committee) - the latter two because of their adeptness at gathering material and writing reports. He agreed to give further thought to the matter but toward the close of our conversation he was inclined to believe that the study might require two associate directors. It occurs to me that perhaps we ought to look for somebody in a semi-retired position. Lou Kaplan of Baltimore will be retiring soon and could do this well. There is a chap at the Harvard Graduate School of Education who has an excellent Jewish background (his name escapes me).



Today we received a check for \$1,000 from Aaron Goldman (his letter to you is attached), and when we called Levinson's secretary to indicate this information we learned that Morris is away from his office all week. Please let me know whether you plan to write to Aaron Goldman and his father or whether you want us to handle the matter from this end.

There are a lot of odds and ends but I do not want to make this letter any longer than it already is. So I'll hold off until a later time.


He phoned today upon receiving my letter (copy of which I sent you). Because time is so important, he felt that an exchange of correspondence might make the matter academic. If he is to make the trip, the latest date he can leave is December 11th. He is eager, therefore, to have a determination at the earliest date possible.

He answered most of the questions raised in my letter to my general satisfaction with the exception of the matter of the urgency to get the article written immediately. Evidently, if he does not use the time now, he will not be able to get away again until next Fall, and he does believe that he needs to run this down without further delay.

The various places that he plans to visit all have manuscripts bearing on the subject which he must examine personally. In a couple of places it is impossible for him to get microfilm or other kinds of copies. He asserts that he had explored other funding possibilities prior to approaching us; that the Medieval Academy has no funds for research; that the University of Chicago has twice given him special research grants; and that he has been a Guggenheim Fellow on two occasions. He readily agreed to make an appropriate acknowledgment in his article for the assistance given him.

So, the question now is how you want to handle this. We here do not have funds for this purpose, and there might be some question about getting approval ex post facto. Golb impatiently awaits our decision. And I shall stand by until I hear from you.

Discussed with David Zeff, CJFWF Field Representative, the Washington situation vis-a-vis the Foundation. He reiterated the long-standing dissatisfaction of the Council with the professional direction of the Washington UJA and the failure of the lay leadership to develop a genuine central Jewish community organization. He pointed out that the executives of several of the local Jewish functional agencies are quite unhappy about the absence of any central planning in the community.

When I related to him Meyer Brissman's suggestion for the Foundation's securing financial support outside the framework of the Washington UJA, Mr. Z. expressed sharp disappointment and felt that if Rabbi Silver is planning to visit with Aaron Goldman to discuss the situation, he should arrange to include a few other people who are influential in the local UJA and who might also be receptive to the Foundation. He cited in particular, Dr. Seymour Alpert, President of the UJA (or perhaps immediate Past President): Charles E. Smith, former President of the Jewish Community Center and the Hebrew Home for the Aged, and a large and influential contributor; and Sanuel Roberts, President of the Hebrew Home for the Aged and one of a small group seeking to develop the UJA into a meaningful central organization; and Isidore Breslau, still a dominant figure in the local UJA.

Mr. Zeff was of the opinion that a frank discussion with these men would reveal the present situation as well as help determine what steps need to be taken to obtain a proper entree for the NFJC in Washington. He suggested that Aaron Goldman could very appropriately invite these men to meet with Rabbi Silver during his visit.



Should have a vote of approval to enable the officers to make a presentation to the Large City Budgeting Conference on January 22nd, and to submit fiscal data to local communities when we approach them for 1968 allocations.

There should be some discussion about the responsibility which the board assumes in the amount of grants to which it commits the Founfittion. The Committee on Grants needs to have some guidance as to the amount which it is to recommend on the applications it will be reviewing. As of December 10, 1967, we still owe \$30,794 on previous grants and these must be cleared away before we undertake new commitments. If we were to engage the staff assistant authorized for the past two years, we would be without funds to meet our grants obligations. Although we have estimated that \$12,000 would be contributed by individuals (meaning mostly Board members) for 1967 to our Grants Fund, thus far we have received only \$5,675 from this source and there are only 20 days left before the end of 1967. This is serious business and the Foundation cannot continue to limp along in this fashion. We must deal with this promptly.

#### PROPOSED BUDGET FOR 1968

## Prepared for Meeting of the Board of Directors December 11, 1957

## INTRODUCTION

The projection of a budget for the coming year is expected to reveal the direction and program which an agency sets for itself. There is little point in presenting an "ideal" budget, reflecting everything that an agency would like to do. Past experience and the current realities usually require a compromise between what is needed and what might be regarded as reasonably attainable.

The Proposed Budget for 1958 as submitted here is one that falls far short of "ideal". It does, however, attempt to reach out beyond the minimum level of last year's experience and to project some priorities and aspirations essential to the Foundation's healthy development. It seeks to establish a framework within which the agency can carry forward a number of major activities in pursuance of its basic purposes.

Apart from its program of grants and subventions, the Foundation's primary achievement is in the area of service -- essentially professional staff service. During 1967 the Foundation's professional staff consisted of but one person, its Executive Director. The tasks and responsibilities of the Foundation clearly cannot be discharged adequately unless the professional staff is augmented. Although the 1967 Budget provided for an Assistant, the position remained unfilled mainly because of the uncertainty whether the income would be sufficient to cover the "housekeeping" costs as well as the obligations on grants awarded. It is obvious that this practice cannot be continued.

In addition to its established and continuing fields of activity, the Foundation plans during the coming year to devote itself intensively to the following priority areas:

Academic Advisory Council -- The development of this new instrument offers much promise for the Foundation's effective work in the field of Jewish scholarship and in its relations with the growing number of Jewish academicians. Considerable effort will be required to establish a meaningful linkage that will help the Foundation's program with colleges and universities and in the interest of strengthening American Jewish scholarship. It is expected that the Council will guide the Foundation's Study of the Teaching of Judaica on the American Campus; and that it will serve in a consultative capacity in connection with applications for Foundation grants. The Academic Advisory Council will probably submit specific program suggestions from time to time for consideration by the Board for future Foundation activity. Working closely with the Council, particularly during its formative period, will be of critical importance, and adequate provision of staff time is essential.

an early start could be made in 1968 to obtain grants contributions prior to the time of awards so that there can be a better basis for determining the aggregate amount to be granted for the 1968-69 academic year.

<u>General Operating Fund</u> -- It will be noted that the cost of operating the Foundation was considerably below the amount budgeted, due primarily to the unfilled Assistant's position and the consequent inability to carry out various tasks as planned. It was, therefore, possible to transfer some of these unspent funds to the Grants Fund Account to meet current obligations to grantees. It also permitted the reduction of the long-standing bank loan as well as to put into effect the Administrative Working Fund intended as a cushion to offset the lag in cash payments cn welfare fund allocations.

#### 1968 BUDGET: EXPENDITURES

<u>Scholarships, Fellowships, Grants-in-Aid, and Publication Subventions--</u> It is hoped that during 1968 the Foundation will be able to increase its Grants Program measurably to permit awards to a larger proportion of the meritorious applications from individuals and cultural agencies and thus more adequately discharge one of the Foundation's primary responsibilities. The projected goal for 1968 is an expenditure of \$70,000 for grants - approximately \$32,000 more than was awarded in 1967. It is understood that this will be done only to the extent that the Board of the Foundation obtains the funds in advance or underwrites the securing of the amount to be granted.

<u>Special Research Project</u> -- The Foundation has undertaken to sponsor a comprehensive study of the Teaching of Judaica in American Colleges and Universities, a project that is estimated will require approximately  $l_2^1$  years and cost about \$80,000. It is a project which is basic to sound planning for future development of this important field. In submitting proposals to other foundations for funding the project, the NFJC has indicated that the study will be conducted by a Study Director under the supervision of the newly created Academic Advisory Council. It has also been stipulated that the NFJC staff and facilities will be available for occasional assistance to the enterprise, and provision has been included in the project's budget for reimbursement to the NFJC for space and administrative service.

Internal Administrative Costs -- The projected expenditures in the proposed budget for 1968 with regard to the basic operation of the agency are predicated on the employment of an Assistant to the Executive Director, permitting a more comprehensive and intensified program of activity generated by the staff. The figures reflect adjustments anticipated in such matters as possible increases in postage rates and Social Security taxes, as well as a general rise in the cost of supplies and services. Modest salary increments are provided for. In general, the total amount projected is less than the approved 1967 Budget.

### 1968 BUDGET: INCOME

Welfare Funds -- It is projected that some \$15,000 more than received this year from welfare funds will be required in 1968 to balance the budget. This should be within the range of possibility, particularly if in the course of the year the Foundation can become a beneficiary agency in one or more of the three major cities which do not include the NFJC (St. Louis, Denver Extension of Grants Program -- One of the Foundation's major contributions thus far has been its Grants Program which has played a significant role in the encouragement of young Jewish scholars and the assistance of established scholars in their creative efforts. This program, however, is much too limited due to insufficient financial resources, and many promising talents are being lost to the Jewish field because of the Foundation's inability to help them at a crucial period in their development. It is vital that the Grants Program be expanded to provide for additional fellowships and grants-in-aid.

<u>Augmented Financing</u> -- To make possible the fulfillment of its basic responsibilities as a foundation -- funding needed and important cultural endeavors -- it is necessary that a sustained program be undertaken to obtain significant finances outside the Jewish welfare fund framework. It is clear that the kinds of funds required cannot be expected from the annual Jewish welfare fund campaigns. Accordingly, the Foundation must initiate immediately some fund-raising efforts not only in New York City, but in a number of other cities where there are possibilities for persuading individuals and foundations to make substantial contributions to the Foundation's Fellowship and Endowment Program. Spurred by an initial gift of \$50,000 toward a \$1,000,000 Fellowship Endowment Fund, the Foundation needs to devote itself energetically during 1968 to reach this goal.

## 1967 EXPERIENCE: INCOME

Welfare Funds -- Support from local Jewish welfare funds continued to grow in 1967, both in numbers and in dollars. Eighty-three communities now include the Foundation as a beneficiary agency, and it is anticipated that allocations from this scurce in 1967 will reach \$93,000 - a new high. During the year two more communities made earmarked allotments for the Foundation's Grants Program in addition to their regular allocation. While the cash lag on allocations payments has continued, a considerable part of the previous years' balances have been paid up in 1967, and there are now virtually no significant arrearages prior to 1965.

Other Sources of Income -- The development of income sources other than the welfare funds failed to materialize during the early part of the year, and as a result the Foundation fell far short of its hoped-for goal. Contributions from organizations fell off in 1967 since neither the National Council of Jewish Women nor Hadassah participated in the current year's fellowship grants. Contributions from individuals were limited largely to members of the Foundation's Board.

## 1967 EXPERIENCE: EXPENDITURES

<u>Grants</u> -- Inasmuch as at the time when grants had to be awarded in late Spring it was apparent that the funds would not be available in the amount previously projected, the Board restricted the amount of awards to \$37,480 for the academic year 1967-1968. It was recognized that provision would have to be made for these amounts to be secured by the end of the calendar year so that and Washington). There is also the possibility of reinstatement by Montreal. Efforts are being made in each of these communities to effectuate a favorable decision in behalf of the Foundation. Also, continued efforts will be exerted to persuade more welfare funds to make additional allotments to the Foundation for its Grants Program. The net results of these activities should realize some material improvement in the aggregate allocations from welfare funds.

<u>Individuals</u> -- It is anticipated that solicitation of individuals for contributions to the Foundation's Grants Program will yield \$40,000. Plans are under way for several approaches in New York City - a virgin territory thus far for the NFJC - to bring together some prospective donors for fellowships and endowment gifts. There are also some plans for selective solicitation in several other communities (following proper clearance with the local federation).

<u>Fcundations</u> -- As has already been indicated elsewhere, the NFJC is applying to a number of specialized foundations for assistance in funding the Study of the Teaching of Judaica on the American Campus. It is hoped that from among the several approaches the nacessary financing will be secured to permit the study to be undertaken early in 1968.

<u>Organizations</u> -- The Foundation will continue to maintain a close relationship with the two national women's organizations (National Council of Jewish Women and Hadassah) which have committed themselves to programs of sponsorship of scholarly work under the auspices of the NFJC. It is anticipated that one or both of them will select projects during 1968. In addition, the Foundation will be approaching a number of other organizations which have evinced some interest in associating themselves with the Foundation's Grants Program. The projected sum of \$10,000 from organizations would appear to be realistic.





Enclosed is the letter from Rabbi Seligson. How do you want to handle it? I would certainly prefer his making the first contact with these people, but I will defer to your judgment on this.

The letter to Mrs. Berger is self-explanatory. I shall call her next week and shall let you know as soon as I get the word.

In searching our files of the numerous Neusner letters, the closest we come to the kind of item you referred to is the excerpt from a letter from him dated October 31, 1967:

"I do want you to know that I am going ahead to organize a permanent, standing sub-group in the American Academy of Religion on the theme of Judaic studies, and I am appcinting a standing (two-year) chairman to develop a suitable program. We have our own funds, and do not need any from anyone else. We shall simply move ahead on our own, and meet the fairly limited need to provide some sort of placement and guidance in the development of new programs, if the AAR members indicate they wish to avail themselves of the sub-group for that purpose. I strongly suspect they will, since we are, so to speak, right on the spot, are known, and are knowledgeable. Anyone is free to join the AAR, and the sub-group on Judaism is of course open to all. Whatever others do, if anything, is of no further interest to me personally."

## PROPOSED STUDY OF THE TEACHING OF JUDAICA AT AMERICAN COLLEGES AND UNIVERSITIES

[Dec 1967]

## Background

The past decade has witnessed a remarkable growth in the field of advanced Jewish Study. Prior to 1955 there were fewer than ten full-time scholars teaching in the fields of Jewish thought and history in American colleges and universities. Today more than seventy-five full-time academicians are so engaged and perhaps an additional two hundred offer special courses in various Departments of Religion, Philosophy, History, etc. In most instances, this proliferation of Jewish Studies at institutions of higher learning is motivated by an increased awareness of the significance of the Jewish component in Western civilization by university leaders, and a readiness to enrich the curriculum by its inclusion. At the same time there is a desire within the Jewish community to place authentic Jewish thought alongside the great intellectual systems of mankind. Implicit also in the Jewish community's position is the hope that young Jewish students might gain a more competent understanding of their tradition. A further element in the consideration of some Jews is the public relations value in these programs, conveying a better understanding among non-Jews of the contributions of the Judaic heritage. Student registration in these courses is high.

Despite the rapid growth of these programs of academic Jewish studies, the development has been unplanned for the most part, and an examination of the existing situation will reveal that the variations among the

schools are greater than the similarities. The variety reflects the sponsor-

ship of the schools, their geographic setting, their fields of specialization,

their history, and not least, particular personalities. All these are important

influences on the definitions of Jewish studies at particular schools. The

curricular setting for such courses range through departments of religion,

language, history, area studies, philosophy, social science, and humanities. There is the further prospect that as inter-disciplinary curricula are developed (e.g., "History of Ideas") Jewish studies will be expected to relate to the wide range of academic studies rather than to be separate offerings.

Crucial to all existing and prospective programs of Jewish studies is the availability of qualified personnel. While the number of professorial posts has multiplied, there has been no comparable development in the training of people to fill these positions. The National Foundation for Jewish Culture, in anticipation of the general trend in this field, has been giving this matter its highest priority. The record shows the comparatively high number of its Fellows who have gained academic eligibility through assistance by the Foundation to complete their doctoral degrees. It is also known that a significant number of these individuals are now teaching in colleges and universities throughout the courtry. But the need for qualified teaching personnel far outstrips the supply, and it is necessary that there be an assessment not only of what the foreseeable requirements are likely to be but also how the gap between the supply and the demand can be narrowed.

An important aspect of this problem relates to the inadequate training facilities among the Departments of Jewish Studies. Many of these departments lack the specialized faculty members to be able to provide graduate students with the broad preparation needed, and careful planning is required to determine the feasibility of coordinating the programs of several institutions of higher learning in a particular geographic area to provide the kind of balance and depth

which will equip those preparing for a career of Judaic teaching at the university

level. It is clear that the various rabbinical seminaries are not in a position to

meet the manpower gap: they are confronted with some of the same problems

in their primary area of responsibility - the training of rabbis.

The National Foundation for Jewish Culture has been called upon with

increasing frequency to provide guidance and assistance on a wide variety of

matters in this area. College officials seek help with curricula, available teachers, financial assistance in the creation of Judaic Chairs, etc. Professors want information about programs in other institutions, or desire help in expanding libraries or the preparation of textbooks. Jewish individuals and communities ask for guidance in connection with the setting up of Chairs of Jewish Studies. Parents inquire about institutions providing Judaic courses of high quality. Students seek information as to where they can secure the kind of training that will equip them to enter upon a career of teaching Jewish studies at the college level. And, of course, many requests are received about scholarships, fellowships and grants-in-aid.

Sound planning for the future development of Jewish studies in American institutions of higher learning requires that a comprehensive, in-depth survey of the field be undertaken as soon as possible. The National Foundation for Jewish Culture is prepared to conduct such a study if it can obtain the necessary funds. Such a survey should assess the present situation: facilities, manpower, course offerings, library resources, fiscal arrangements, student enrollment, etc. Information would be solicited from college and university administrators, professors, students, Jewish community leaders, and others. A developmental picture of the past history, current programs and future plans would be presented. A delineation would be made of the situation in institutions under private auspices, in government-supported universities, in graduate programs under Jewish auspices (Dropsie, Brandeis, rabbinical seminaries, etc.) The relationship of colleges of Jewish studies and the Hillel

Foundations to the broad university scene would be explored, and an effort

would be made to determine the possibilities for evaluating and coordinating the

complex of existing programs. Attention will be given to the potential role of

professional societies of academicians teaching Jewish studies and the ways

in which opportunities can be developed for intercommunication of ideas, the presentation of scholarly papers, and the informal exchange of information.

The proposed study will seek data to answer such questions as:

- \* What is the field of Jewish Studies? What competence should be expected of persons to qualify for teaching posts in institutions of higher learning? What kinds of accreditation appear desirable?
- \* How can colleges and universities be helped to obtain an adequate supply of well-trained scholars in Jewish thought, history, linguistics, etc.? What are the projected manpower needs in this field for the next 10-20 years?
- \* How can future scholars receive a competent education in the general as well as the particular aspects of Judaica? Where?
- \* How should undergraduate courses in Jewish Studies be offered? What should be the objectives and expectations at the undergraduate level?
- \* What postgraduate training should be provided for those now teaching on a part-time basis at the college level? How should it be financed?
- \* What guidelines and criteria can be developed for the establishment of Chairs of Jewish Studies?
- \* What criteria can be formulated for Jewish financial support of institutions seeking to expand their Judaica program

\* What funds are required for scholarships and fellowships to attract talented young students to the field of Jewish scholarship? How should such funds be distributed?

- \* Is it desirable to establish close relations between American centers of Jewish Studies and the Hebrew University's Center for the Study of Contemporary Jewish History and its Department of Jewish Studies? How should this be undertaken?
- \* What provisions are currently available for professors of Jewish Studies to undertake extended research and distraction-free study? What financial grants would be required? What procedures and criteria are required for equitable distribution of such funds?
- \* What kind of process and structure is needed to deal with such matters as accreditation and qualification of professors of Jewish Studies, preparation of textbooks, curriculum construction, etc.?

## Plan of Study

The proposed investigation will be conducted by a full-time Study Director under the general guidance of the Academic Advisory Council of the National Foundation for Jewish Culture. It is estimated that the study will require about one and one-half years to complete. Staff and records will be

housed in the offices of the NFJC, and the Foundation's staff and ancillary

services will be available as required. The active cooperation of academic

institutions, faculty members, and related organizations is assured. The final report of the Study will be distributed by the NFJC to institutions of higher

learning, to academicians and to interested organizations.

## NATIONAL FOUNDATION FOR JEWISH CULTURE

The NFJC needs \$35,000 to \$40,000 more from Welfare Funds in 1968:

1. This should be broken down into community quotas. It will require from \$500 to \$7,500 more from each city in the LCBC -and small amounts from other cities. These are tiny fractions of what each city budgets -- the LCBC cities budget \$1 to \$8 million each. The problem therefore is not the ability or capacity of each such city to allocate this additional fraction of one per cent of what it allocates. The problem is the conviction regarding the urgency and priority of the need; even more, the convincing presentation of an exciting program; even more, the taking of the time in a budget meeting to deal with the question seriously; and even more, the presence of articulate and influential spokesmen in the budget committee who will strongly support the change in allocation to the NFJC.

The NFJC should be understood by each Welfare Fund as its rescurce in planning for this field -- not just as a detached applicant.

2. The presentation of an exciting program to the LCBC meeting in January, 1968, will be important. This must be in the perspective of the totality of the cultural field -- with the sense of dynamism and bigness, instead of a presentation of poverty and failure which has been the mistake in the past.

3. Crucial will be the selection of the people in each city who must be depended upon to handle this in the budget committee.

4. The NFJC should assign its key leaders specifically to contact these community leaders initially to get their commitment to handle the matter in their cities; and to follow up with each one sufficiently before the date of decision to make sure that this will be done.




