Dear Milton:

This will confirm my speaking at the Synagogue Council of Detroit meeting on Monday evening, April 19. I am enclosing a glossy, a bio and a copy of a recent piece on Zionism which I hope you will enjoy. May I suggest as a title: "What Lies Ahead: The Jew In America" and a subtitle: What Was and What Is Yet To Be.

As you know from my visit last year, the two-volume A History of Judaism which Bernie Martin and I published a year ago is now available. It has been my experience that a dozen to twenty copies can be sold after a lecture and, obviously, I am interested in promoting the book.

You can order the book directly, but since Basic Books has a complicated procedure before they will mail out books, I can have our Temple librarian, Miss Leikind, send up as many copies as you want. The set retails now for \$38. It costs us \$24. I will be happy to send as many at our cost plus postage as you want, you can sell them for full price and your Council can make a few dollars. If any remain unsold we will be happy to take them back. It would mean simply a good announcement and a table with a sign.

Thanks so much for your letter of March 4 which enclosed a glossy, a bio and your very fine article on Zionism as well as your suggested lecture topic.

I am delighted that you have agreed to accept this invitation from the Synagogue Council of Detroit and the Rabbinical Commission of Detroit to address a community meeting which will be held at Congregation Bnai Moshe, Oak Park, Michigan on Monday evening, April 19, 1976 at 8:00 P.M. I am hopeful also that the Cantor's Association of Detroit will be associated with us also in this sponsorship. As a matter of formality, I wish to confirm further that we have agreed that you shall receive a fee of \$500.00 plus your expenses in payment in connection with this presentation to the Detroit community.



Thank you for your letter of April 5 concerning Rabbi Silver's arrival and departure arrangements.


Reservation has been made for Rabbi Silver at the Michigan Inn, Southfield, where Rabbi Silver stayed last year. In view of Rabbi Silver's tight arrangements, I believe he would find it more convenient to rent a car so that he can make the necessary connections more conveniently. The Michigan Inn is located at J. L. Hudson Drive and Northwestern Highway, Southfield.

To get to the Michigan Inn from Detroit City Airport, Rabbi Silver should go south on Conner to the Edsel Ford Freeway (I-94), then go west on the Ford Freeway to the John Lodge Expressway. Turning north on the Lodge Expressway, he should go approximately 9 miles north and leave the Lodge Expressway at the Northland exit. Continuing north on the service drive approximately 1/4 mile to the first light he will be at the Michigan Inn.
