The reform movement rarely has faced up to the issue of particularism. We have talked a lot about being both/and-ers, and most of us are deeply involved in the politics of survival, but you would not know this from the daily routines of the synagogue where universalist themes remain dominant. I propose to take the Centenary Perspective as a base line and place various Task Force studies of synagogue practice against its general statements. This exercise highlights the gap between theory and practice, and forces us to ask, 'why the falloff between word and practice?' There are many answers. I plan to examine the one which most concerns rabbis: reform's theological stance as expressed in such favorite terms as "prophetic Judaism" and "the mission of Israel. " The bottom line is that our heart seems to be in the right place, but we still have some bad habits. I look forward to seeing you on November 9. Sincerely, Daniel Jeremy Silver DJS:mp
