# PROVISIONAL CONSTITUTION of the Cleveland Zionist Federation

The name shall be the Cleveland Zionist Federation which is affiliated with the American Zionist Federation.

### I. Aims and Purposes

- A. To motivate American Jews to accept the Zionist principles that the Jews the world over are one people, united by a common history, heritage, and destiny, with Israel as the center of Jewish life everywhere;
- B. To foster Zionist and Jewish ideals among Jews in the United States and engage in activities on behalf of the Zionist Movement in the United States;
- C. To interpret the history, social and cultural life, achievements and problems of American Jevry and Zioniam to Jevish communities throughout the world;
- D. To collect and disseminate such information as may help safeguard the Jevish homeland and protect Jevish rights everywhere;
- E. To cooperate with ogencies assisting Jews who need or want to settle in Israel;
- F. To encourage the development of institutions and data for education in Judaism, Hebrer and the culture of the Jerish people;
- G. To promote research, study and discussion of Zionist ideas and aims;
- H. To foster and support programs which will involve American Jewish youth in Zionist activities, and to encourage their participation in the work of the organization nationally and locally;
- I. To further the efforts of the United Jewish Appeal, the United Israel Appeal, the Jewish National Fund, Jewish welfare funds and federations, and other fund-raising agencies supporting Jewish education and youth programs and advancing Jewish welfare.

### II. Hembership

- A. The Federation shall consist of three types of membership:
  - 1. The Constituent Zionist Organizations (including the aliyah, youth and student movements). Individuals belonging to such organizations are automatically members of the Zionist Federation without additional dues obligations.
  - 2. Members-at-large are individuals who accept the Zionist program and elect to affiliate and pay dues to the American Zionist Federation directly.

3. Corporate Affiliates are Jewish membership organizations which accept the program of the Federation on a corporate basis. The minimum annual dues of local Corporate Affiliates is \$100. Individuals who belong to these organizations are not automatically members of the Federation.

#### B. Dues Structure

- 1. Adult Constituent Zionist Organizations shall pay on a per member basis per year. The youth organizations shall be subsidized by the adult sponsoring group.
- 2. Members-at-large shall pay \$20 per year.
- 3. Corporate Affiliates shall pay dues according to the following:
  - (a) 10 499 members \$ 100
  - (b) 500 999 members \$ 200
  - (c) 1000 1999 members \$ 400
  - (a) 2000 2999 members \$ 700
  - (f) 3000 5000 members \$1000

#### LLL. Covernment

- A. The Board of Trustees shall be elected from the general membership and shall consist of the following:
  - 1. At least 50% shall come from the Constituent Zionist Organizations.
  - The remaining 50% shall be made up of representatiaves from Members at-large and Corporate Affiliates. Members-at-large will have a minimum of 5% of the Board and the balance of 45% from the Corporate affiliates.
- B. The Board shall consist of at least 100 members who shall serve a term of three (3) years.
- C. Representation from each constitutent Zionist organization shall be established by formula, to be based on per capita membership, i.e. each constituent Zionist organization shall be represented on the Board by a number equivalent to the percentage of the total constituent membership contributed by the organization.

#### IV. Officers

- A. A Nominating Committee shall be appointed by the President, consisting of four (4) from the Board and a Chairman from the Board, one (1) from Corporate Affiliates, one (1) from Members-at-large and two (2) from Constituency-at-large.
- B. The Nominating Committee shall present a slate of nominees for Board membership and officers to be elected at the annual meeting and to be put in writing and sent to the membership sixty (60) days prior to election.

- C. Any group obtaining 100 signatures of members in good standing, may submit an alternate slate to the membership thirty (30) days prior to election.
- D. The officers to be elected shall be as follows:
  - 1. President
  - 2. Vice President of Program
  - 3. Vice President of Membership
  - 4. Vice President of Information
  - 5. Recording Secretary
  - 6. Corresponding Secretary
  - 7. Tressurer
- E. Term of office shall be for two (2) years, with the officers limited to
- F. Chairmen of standing committees shall be appointed by the Previount and approved by the Board. The standing committees shall be
  - 1. Aliyah committee
  - 2. Budget committee
  - 3. Constitution and legal committee
  - 4. Information and public affairs committee
  - 5. Jewish communal offairs committee
  - 6. Jewish education committee
  - 7. Nominating committee
  - 8. Organization and membership committee
  - 9. Youth committee
  - 10. Ad hoc committees as needed
- G. Duties of officers shall follow ROBERT'S RULES OF ORDER.
- H. There shall be an Executive Committee, consisting of officers, National Board representatives and Committee Chairman with ex officio membership of Presidents of Constituent organizations. The Executive Committee Board approval.

#### V. Meetings

- purposes of electing officers, reporting the financial status of lifer organization and reviewing the program achievements.
- B. The entire Board shall meet at least four (4) times per year and more fraquently as determined by the Executive Committee or on petition by 25% of the existing Board.
- C. The Executive Committee shall meet monthly to carry out business of the Federation. Special meetings may be called by the President as needed.

IV. National Board Representatives.

National Board representatives shall consist of the President, or his designee, and others appointed by the Executive Committee and approved by the Board.

Footnotes to Provisional Constitution

### irticle III, Section B

During the organizational period the percentage of the Constituent Organization representatives on the Board will necessarily be above 50% and the total number may be less than 100 members.

### Article IV

Provisional National Board representatives shall be elected for the first two (2) year term by the membership of the Cleveland Zionist Council.

Cleveland, Ohio Dear Daniel: As you know I have undertaken to resume active service nationally in the Zionist Organization of America, because I am convinced that the ZOA has an important role to play, both in relation to Israel and to American Jewish life. One of the things which I hope to achieve is to revive the interest and perhaps the activity of my friends in the Reform Rabbinate. This letter is meant to be a personal and informal invitation to you to send me some of your reactions and comments. Can I impose on you to give the matter a little of your thought along the following lines. 1. I believe that Zionist education and programming in the future must depart from some of the conventional lines of the past and strike out boldly and imaginatively on new paths. Among other things, it should deal with current problems and the future shape of the society emerging in Israel, frankly discussing such matters as Freedom of Religion, Individual Enterprise vs. Socialism, the future of the Collectives, Jewish Values in a Jewish State, etc. working on the possibility of holding a two-day seminar to discuss these matters openly and frankly, perhaps on a University campus like Brandeis, and inviting to participate a limited group of Rabbis, (Conservative and Orthodox, as well as Reform), writers, educators, university teachers, etc. Would you be interested in attending and participating in such a program? 2. Assuming that ZOA were to launch a programmatic effort to revitalize the intellectual interest and concern of American Jews along the lines suggested above, would you be willing to accept at least a limited number of speaking engagements for Zionist District or Regional meetings? 3. Do you have suggestions along these and other lines? I should very much like to hear them. If you will take a few minutes to think about the above and write to me, I shall deeply appreciate it. Perhaps, a camp such as you vision might reawaken some of the rabbis to the necessity of discussing current and philosophic issues in their adult education programs, but frankly, I feel that any attempt samply to encourage the Ziomist districts to ingather would fail and would also tend to divert people's basic allegiance from the synagogue where such subjects might equally well be explained. The Manhattan Region was the first Jewish organization to recognize the importance of memorializing the Warsaw Ghetto Uprising. For the past several years the Manhattan Region has arranged large public meetings with attendance in excess of 1,000 people at each meeting.

Last year, in addition to the Mayor of the City of New York, Senator Keating of the State of New York and the Consul-General of the State of Israel addressed our meeting.

In previous years we had Judge Michael Musmanno of Pennsylvania State Court who was also one of the judges presiding at the Nuremberg Trial address such memorial meeting.

This year we are planning a large public neeting for this occasion to be held either on April 8 or April 9, 1964 in the Borough of Manhattan, City of New York.

Hon. Robert F. Wagner, the Mayor of the City of New York, already has proclaimed the week of April 5th as Warsaw Ghetto Memorial Week and during that week Times Square will be renamed Warsaw Ghetto Square and appropriate ceremonies will be held at Times Square memorializing the galant fight of the Warsaw Ghetto martyrs. This will be held under the auspices of the Manhattan Region together with the Public Events Department of the City of New York, with appropriate television and radio coverage.

Dear Max:

I have been mulling over our phone conversation of yesterday. It would appear to me that such an undertaking requires several commitments on the part of the ZOA, and I should like to share my thinking in this area with you.

- 1) Any political activity requires funds. Can the ZOA provide a suitable budget? Frankly, I would not be prepared to stump the country to raise these monies.
- 2) Has the ZOA in mind a program which is designed to promote Zionist public relations or those which are narrowly and peculiarly those of the ZOA? In brief, is it your idea that we would involve ourselves in Congressional contact, newspaper releases, work at the various party conventions the type of work the American Zionist Council used to do or is it your intention that we stump for unique ZOA projects in Israel? I would be interested in undertaking the former, not the latter.
- 3) There must, of course, be coordination to these activities. To whom would the chairman be responsible? What would be his relationships with existing political energies?
- 4) What would be the relationship of the present publishing enterprises of the ZOA to this committee? Would their political policies and the direction of their interests reflect the new ZOA concern for the priority of the political?
- 5) Who would do the leg work and the office work? Is there a qualified person in the present ZOA structure? Is the ZOA repared to bring in such a man and to give the committee

Rabbi Max Nussbaum January 20, 1964 necessary secretarial help, etc.? Finally, a minor point. Would the ZOA undertake secretarial provisions such as there might be for the work here in Cleveland? You will understand from the foregoing the direction in which my mind is running. I am willing to undertake that which will be of service to the Zionist cause. If the ZOA is fully determined to take advantage of the present reshuffling to move back into the political area -- because Zionism is meaningless without a political dimension -- I would be pleased to speak of it further with you. But I would hope that at our meeting these questions I have now raised would be answered. Except for a few months during 1947 and 1948, I have been essentially a Zionist bystander. I have no essential interest in organisational promotion. I have a firm and fundamental concern for Israel and for Zionism. I seek your advice and clarification. Needless to say that you are entitled to definite answers. To the best of my knowledge, Harold Carmely plans to be in Cleveland in the next couple of days and I asked him to sit down with you and spend as much time as necessary in order to clarify the position of the Administration. I also remind you that you were kind enough to promise to come to New York and discuss the whole matter with me orally. I am, therefore, informing you that I will be speaking for the Bonds of Israel in St. Louis on the 5th of February and will continue on the 6th, to New York where I will be staying for almost a week. If it is at all possible, we could meet either in St. Louis or -- which I would prefer -- in New York. Please let me know whether you can make one or the other. In the meantime, let me say to you that about \$26,000 or \$27,000 were pledged at an NEC meeting for the Public Relations Department. Of this pledged sum, approximately \$8,000 are in a special account in the bank which we have not touched in order to make sure that we have a financial basis for operation. Secondly, our intention is that the Public Relations Department should involve itself in the type of political work you have in mind and not in the projects in Israel. They are handled by an entirely different Committee. The Chairman of the Public Relations Department would be responsible to the President of the ZOA and the Administration. I agree with you that such a Department needs a man in the ZOA office in New York, and as soon as you and we have come to an agreement, we will go before the NEC, asking for cash of the pledges and for the fulfillment of the Resolution that every member of the NEC ought to give \$100 a year above his AZF contribution, for the special fund for the Public Relations Department.

January 28, 1964 2. Rabbi Daniel Jeremy Silver I don't think you will need special secretarial work because you can probably handle it with the secretaries in your Temple. But, should this be necessary, we will, of course, pay the expenses involved. I would greatly appreciate your conveying the above information to those concerned.



#### Silver Memorial Fund

In connection with your forthcoming trip to Cleveland, I wish to recapitulate the bare outline of the proposal I made some time ago regarding the Silver Memorial Fund:

- Our fund raising goal should be \$1,000,000 and it is immaterial whether
  we will raise this amount or a couple of hundred thousand dollars less.
  The idea is to set our nights high and to raise a big amount of money;
  otherwise it does not pay to start it.
- This amount should be raised over a period of two years (1964-65 and 1965-66).
- 3. Our AZF Department will handle the job. Perhaps we will need to engage an additional person to help Alex Weinstein for this particular purpose.
- 4. A high caliber National Committee would have to be established in New York, with similar committees in at least several large Jewish communities. The name of Mr. Rattner of Claveland was mentioned for the office of National Chairman.
- 5. This ought to be a fund raising drive based on an individual approach for contributions of \$500 or more. It can only succeed if conducted in this manner. Whatever will come from Regions and Districts in smaller contributions in the latter stages of the drive will supplement the funds collected from individuals.
- 6. The Silver Hemorial Pund is, of course, a very wide unbrella and you can place under it many goals. I am sure many people would come up with many different ideas. My own suggestions are as follows:
  - a) One third of the money raised chould go towards a Kfar Silver Nemorial Scholarship Fund,
  - b) One third for the establishment of an academic high school and teachers' seminary in Kfar Silver. As you know, Kfar Silver has already opened this month, on an experimental basis, a one-year course for immigrant teachers who need some training in Hebrew subjects. Thirty-three teachers have enrolled for this academic year; according to a report received today from Chaim Danieli, Chairman of the Kfar Silver Board in Israel.
  - e) The last third of the funds raised should go towards the establishment of an Abba Hillel Silver 20A House in New York to house 20A National Headquasters. It can also have an auditorium for meetings, etc.



It is important that America take vigorous action to secure the opening of international waters and to preclude the spread of communism in the MidHle East. Dear Rabbi:

Here are the facts in regard to the issue you raise in your letter of June 15. Sanford Markey, our Public Relations Director, came to me several days ago to say that Allen Douglas, who runs a controversial, open ended radio show late at night, had determined on a "debate" on the Mid-East situation and requested that Sandy furnish two speakers to represent the Israeli point of view. I expressed strong objections, for all the reasons very well known to you that I do not have to repeat here.

Sandy informed me that under any circumstances, Douglas was going ahead with his show, that he had pointed out all the objections in the procedure as he had outlined it, but that if we did not furnish spokesmen, there was no doubt at all that Douglas could get two Jews from one place or another to represent "a viewpoint". Time was of the essence, since the show was going on within 24 hours and, all things considered, it seemed better in this particular case, despite all the reservations that we recognize, to furnish qualified spocesmen rather than the type that would otherwise appear. Therefore, Bennet Kleinman and Billy Goldfarb appeared on the show, with results that were unhappy, but would have been even more unhappy with other kinds of spokesmen.

There is absolutely no difference of opinion between us as to the dangers of engaging in debate, and we will never do so of our own choice. I very much hope it will be possible to quash any program of this kind in the future, but I think the conditions require sufficient flexibility so that we must judge each issue as it arises. I might add that the CRC as such was not involved in this procedure at all, and would undoubtedly take the same stand that we both agree is proper not to engage in debate if that is achievable.

Dear Rabbi Silver:

I have waited until this last moment to be in contact with you hoping to receive more concrete information to present to you with regard to the six month program (or more) in Israel which will follow the recently cancelled volunteer program in which you so strongly cooperated. Our offices in New York are still awaiting, momentarily, written instructions from Israel about the urgency of such a program.

I am sure you are aware of the impact made by Mrs. Golda Maier on the great meeting in New York this past week, in which she emphasized the need for young people to come to Israel for longer lengths of time than just three months to help Israel in her immediate and future needs. I am confident, dear Rabbi, that you will agree that we should capitalize on this great rennaissance of feeling among our Jewish youth which manifested itself in their selfless and spontaneous volunteering to aid Israel in her hour of need. I feel, as I am sure you will also, that this can be done nobly with this six month program.

To repeat, I am awaiting specific information at this time about the urgency and other new directives which will be forthcoming, but are not yet at the moment here. In general, the Kibbutz-Ulpan program is one in which the candidate works on the kibbutz one-half day, contributing his physical efforts to the existence of the kibbutz. He studies Hebrew, the history and culture of Israel the other half-day. It becomes thus, a mutually beneficial program, one in which the candidate gives to Israel and by so doing is rewarded with a fulfilling and spiritual experience. At the same time Israel benefits by the candidate's physical efforts on the kibbutz and by the tie which he has developed with the Land upon his return to the United States. I am enclosing a pamphlet which we have distributed that gives a good general description of the program as it existed before the current situation.

May I tell you of the experience I have had today which have greatly encouraged me and the prospects for this program. I have spoken to many, many young people during this past day, no less than 25 who came to my office and to many who have made appointments to talk further to me this Sunday. With few exceptions, they are ready to re-schedule their work plans and school schedules in order to go to Israel for this 6-month program.

Of course, I am well aware of the difficulties that arise for many who wish to participate. 1) If we can convince local draft boards of the educational value of this experience, perhaps they will be more liberal with their releases.

2) If the Jewish Community Federation will be ready to help these young people get to Israel, another obstacle will be overcome.

We understand during the present surge of emotions and good will it is extremely difficult to suggest what kind of help the State of Israel really needs from this Jewish Community. However, things are beginning to slowly settle and a realistic appraisale of the situation seems possible. All indications point today toward the fact that Israel will be forced to maintain in a mobilized state at least part of her military reserves for the forseeable future. It is conceivable that this situation will create serious voids in Israels industrial manpower. We cannot estimate how much this will be true for skilled professions and in particular for engineers, but we are sure that skilled professionals can never be replaced by untrained people. We also believe it will be very doubtful if Israeli officials will make requests for skilled manpower from the American Jewish Community. Similar requests have met with little response during the past years unless, for Israeli standards, exhorbitant salaries were offered to American Jewish engineers who had neither the means nor the will to except employment in Israel.

The Refugee Issue
Daniel Jeremy Silver

Three Arab-Israeli wars have bred their share of human misery.

For many this tragedy is wrapped up in the phrase: "The Arab Refugee".

That his lct is a tragic one is a simple statement of fact, but it does not exhaust all the facts on which a humane and just solution to this human problem must be based.

It is too often forgotten that the Arab refugee is the victim of Arab aggression. Had the Arab High Command not resolved to destroy the Yishuw before it could establish itself as a state, there would have been no refugee problem. Israel sought peace. Peace does not create refugees. Had the Partition Flan gone into effect naturally and normally, the repatriation of those Jews and Arabs who would have preferred to live in their own culture and could esaily have been effected.

Even when the Arabs launched their attack, neither the Government nore the Army of Israel required the Arabs to leave his home. 140,000 did not. They remained in possession of their homes and secure in their property. The Arabs of Israel have grown ever since in number and they have prospered. Today they enjoy representation in the Knesset and a standard of living unparalled in any Arab state.

In their occasional moments of honesty, Arab leaders have ecknowledged these facts. In 1948, Emile Ghoury, then Secretary of the Arab-Palestine Higher Committee, wrote:

Jerselmin the World

7 ...

At the time of the first truce the number of Arabarefugees was 200,000. By the time the second truce began this number had risen to 300,000. It is impossible to foretell how many more refugees there will be if the hostilities are renewed and there is a third truce. I do not want to impugn anyone, but only to help the refugees. The fact that there are these refugees is the direct consequence of the act of the Arab states in opposing partition and the Jewish state. The Arab states agreed upon this policy unanimously and they must share in the solution of the problem.

Early the next year, a Jordanian Daily printed the following paragraph:

The Arab states, which had encouraged the Palestine Arabs to leave their homes temporarily in order to be out of the way of the Arab invasion armies, have failed to keep their promises to help these refugees.

This does not mitigate his misery but does help to place the burden of responsibility of his rehabilitation. The Arab states have done little to integrate the refugee into their economy. It is one of the sad facts of recent Middle-East history, by and large, Arab leaders have treated their fellow-Arabs callously, have kept them in separate poverty-ridden compounds as political pawns in their continuing battle against Israel.

Concern with the Arab refugee is well publicized; so much so that many have forgotten that these Arabs are not the only people who have been displaced by Middle-Eastern tension. In the last nineteen years, somewhere second 500,000 Jews have been forced to flee their homes in Arab lands. They left countries where their ancestors have lived for centuries because they were stripped of their rights and subject to all manner of personal indignity. In many cases, their property was expropriated. In most cases, what little they had was confiscated. The number of Jews who have been forced out of their homes in

Israel in the World

Arab lands is roughly equivalent to the number of Arabs displaced by Arab aggression against Israel. Why do we not hear of their plight? Because no one was penned in as a convenient piece of propaganda. The Jewish people took care of their own. Israel welcomed these exiles into full citizenship.

Despite demands that Israel accept back the displaced Arabs, no Arab state has shown a willingness either to take back its own Jewish citizens, or to recompense them for the millions of dollars of property of which they were disembarrassed. Nevertheless, Israel has offered to take back some of the refugees, has freed their bank and saving accounts, and has offered to make restitution for land and valuables which they left behind. When Israel demands that the Arab refugee problem be considered within the context of a total peace settlement, her demand has merit. Israel has already accepted a mejor part of the cause of numer distress in the Middle-East. She has her own claims to press and most critically.

Israel recognizes that apart from a peace settlement, the demand for repatriation represents part of the strategy for her destruction. The Arab states envision the refugees as an intolerable financial burden upon Israel and as an effective fifth column. The President of Lebanon put it bluntly a year ago:

The day of the relations of the Arab hopes for the return of the refugees to Palestine means the liquidation of Israel."

With the end of this June's brief battle, Israel finds many of these Arab refugees within her boundaries. Projects to clothe them and feed them properly are afoot. Plans are being made to educate them, to offer them employment to a degree which they had not enjoyed before. Israel has never been callous to the

simple plight of these people. Had the Arab states been similarly concerned,

these people would long since have been integrated into their economies even
as the Oriental Jew has been integrated into Israel. The problem of the Arab
refugee requires a solution. Israel has offered financial aid in that solution.

Today she adds to that offer tentetime promises for their immediate relief and
rehabilition in the areas she controls. Repatriation is not a solution to the
refugee problem but a strategy of Arab beligerency. In Germany, Austria, India,
Pakistan and Finland, we have seen the effective integration of displaced. Only
in the Arab Middle-East has a people kept its own people apart. This is an outrage.

It is this sequestration which needs to be ended.

Ample time has been set aside for Delegates to participate in the discussions at all the above sessions and in the formulation of resolutions to be adopted by the Convention on the issues covered by the agenda.

#### Decication of Wall of Remembrance of the ZOA Foundation

The Wall of Remembrance of the ZOA Foundation will be dedicated at solemn ceremonies at the ZOA House on Monday, July 24. On the Wall will be inscribed the names of all ZOA members who have made wills and bequests to our organization and its projects in Israel.

Dedication of rooms at the ZOA House will be part of the Convention program the preceding day.

#### Music and Dance Festival Under the Stars in Caesarea Amphitheater

On Sunday evening, July 23, the Delegates will travel to Caesarea on the Mediterranean shore where, in the old Roman amphitheater seating 2,000, an artistic program of music and dance will be presented by Israel's two top ensembles: the famous Yemenite Inbal Dance Ensemble which toured the United States a few years ago and the Druze Dance Twoup which scored a hit at the Israel International Festival.

#### Presentation of ZOA Awards to Take Place at Caesarea

The traditional presentation of coveted ZOA awards for best membership and AZF achievements during the year to Regions, Districts and individual members will take place during the music festival in the Caesarea Amphitheater - a most fitting tribute to ZOA leaders for distinguished service to the organization.

#### Ben Gurion and Goldmann to Address Convention

Dr. Nahum Goldmann, president of the World Zionist Organization, will be among the principal speakers at the big plenary session in the Grand Ballroom of the Tel Aviv Hilton Hotel on Monday evening, July 24. The international political situation and Israel-Diaspora relations will be the subject of this meeting. It is expected that the session will be under the chairmanship of Dr. Max Nussbaum, past-president of the ZOA. Names of other speakers at this session will be announced shortly.

You will be happy to learn that former Prime Minister of Israel David Ben Gurion accepted our invitation and will address the National Convention.

#### Reception and Fashion Show for Woman Delegates

A special treat is awaiting our women Delegates and wives of Delegates for whom a reception and Israel Fashion Show will be arranged at the ZOA House on Tuesday morning, July 25.

#### Convention Day in Kfar Silver

The same day, Tuesday, July 25, the entire Convention will move from Tel Aviv to Kfar Silver. Buses will leave from the hotels in the afternoon. Convention events on the Kfar Silver campus are scheduled to start around 5 PM with the dedication ceremonies of the Mollie Goodman Academic High School which will open for the first group of American students in September. This will be followed by simultaneous dedication ceremonies of new projects in Kfar Silver by Regions, District and individual contributors.

An open air supper will be served to the Delegates on the Kfar Silver grounds.

#### Foreign Minister Eban and Congressman Taft

#### Principal Speakers at Kfar Silver

An open air session under the lights will be addressed that same evening in Kfar Silver by the Foreign Minister of Israel Abba Eban and by Congressman Robert Taft, Jr., who will be coming especially from Washington, D.C. to participate in the cornerstone laying ceremonies of the library which will be built in Kfar Silver in memory of his great father, Senator Robert A. Taft. The ceremonies for the Taft Memorial Library will be held as part of the evening session on the campus.

Kfar Silver students and American high school students at the ZOA Teen-Age Summer Camp in Kfar Silver will participate in the program.

Delegates will return to Tel Aviv that same evening.

#### Committee Reports, Resolutions and Elections at Final Business Session

The Convention will discuss reports by its committees, will adopt resolutions and elect the new national ZOA Administration at the last business session to take place at the ZOA House in Tel Aviv on Wednesday, July 26, in the morning.

The newly-elected National Executive Committee will meet at the ZOA House immediately thereafter.

The entire afternoon will be kept free for the Delegates to rest up in preparation for the gala Convention Banquet that evening.

#### ZOA Herzl Award to be Presented to President Shazar at Convention Banquet

The Convention will adjourn at a glittering banquet in the Grand Ballroom of the Sheraton Hotel in Tel Aviv on Wednesday night, July 26, with President of Israel Zalman Shazar as guest of honor. President Shazar will be presented at the Banquet with the ZOA Theodor Herzl Award. Previous recipients of the award were President of Israel Itzhak Ben Zvi, Lord James Balfour (posthumously presented to his family), Dr. Abba Hillel Silver, Louis Lipsky, Dr. Emanuel Neumann, Sir Winston Churchill, President Harry S. Truman.

It is expected that Prime Minister Eshkol will be the principal speaker at the Banquet to be attended by the highest representatives of the Israel and U. S. Governments and diplomatic representatives of many nations accredited to Israel.

Dear Rabbi:

The question of the propriety of debating or discussing the Mid-East situation has not, I think, been resolved to the satisfaction of our Community Relations Committee which would like to examine in a bit more detail the agreements we reached during the summer.

In your letter of June 15 to Sidney Vincent, speaking for the Zionist Emergency Council, the CRC and member agencies were requested not to send community speakers to take part in public debate with Arab nationals. This position is one on which I think we all can find agreement although temptations will be placed in our way, particularly from neighboring communities during this season.

You go on in your letter to question the validity of debates generally, and this does put us in a quandary. When is a debate a debate, a discussion a discussion, and an interpetive meeting what its name implies?

For example, the chairman of the Zionist Emergency Council Speakers' Bureau has declined to share the platform with an American graduate student of political science at a meeting of high school students convened by the Junior Council on World Affairs.

Even though you may wish to paddle me a bit, I myself have decided to accept this engagement in pursuit of what I consider to be the traditional responsibility of the CRC to interpret issues of concern to Jews and all other Americans.

For years members of the CRC, staff and lay alike, have appeared before student groups, church adult groups, Sunday school classes and civic organizations, with or without other panel members, for educational and informational purposes where we have something to say. We do not conceive of these appearances either as partisan or as "debates" and I have no doubt that we shall continue to serve the purposes indicated.

I would like to think that in carrying out our program, we are working in harmony with other Jewish communal organizations and are furthering the mutual interests of the entire Jewish community.

Our CRC would like to consider this subject at a meeting in the near future and I wonder if you would care to be present to take part in the discussion. We are likely

to meet again on the evening of October 31 and you will be most welcome. If the time is not convenient, would you care to set forth your views in writing so that we may be quite clear as to your understanding of the situation?

I look forward to hearing from you.

Yom Atzmaut
The Celebration will be held Tuesday, April 22, 1969, erev Yom Atzmaut. This date is already reserved on the community calendar. It was recommended to reserve Park Synagogue's new hall for the evening. If not available, Fairmount Temple will be reserved. Leonard Narrow will arrange a joint committee meeting with J.C.C. It was felt that Council should invite Federation to the initial committee meeting. This year Council wants to have a gala celebration, with the accent on youth. Rabbi Silver will be asked to be the chairman of the evening.

It was recommended that Council write a leeter to the educational directors of the religious schools urging them to have assemblies to celebrate Yom Atzmaut.

Hillel is having an Israeli Night on November 24, 1968, at Hillel House. At the request of Dr. Baum it was moved and seconded to allocate \$100 for Israeli night. Passed unanimously.

It was felt Council should sponsor an Aliyah Sunday again this year. It should be
