

2 Edward J. Logue is a native of Philadelphia, a graduate of Yale College in 1942, and of the Yale Law School in 1947. He is a combat veteran of World War II. He served on the staff of Chester Bowles when the latter was Governor of Connecticut and later Ambassador to India. He is a Fellow of the American Academy of Arts and Sciences, and an honorary member of the American Institute of Architects.

3 Mr. Logue came to Boston in 1960 as Administrator of the Re-development Authority to head up a program he developed at Mayor John F. Collins' request. Prior to his coming to Boston, Mr. Logue had spent six years as Administrator of the Development Program for New Haven, Connecticut, in the administration of Mayor Richard C. Lee. Robert Weaver, Secretary of the Department of Housing and Urban Development, recently described the New Haven program as "coming closest to our dream of a slumless city."

3 Boston's urban renewal program involves ten approved major projects. It includes the planning and execution, now underway, of three large residential rehabilitation projects, three major downtown projects combining clearance and rehabilitation, and a downtown neighborhood rehabilitation project.

4 Recently, Mr. Logue served as Chairman of a Task Force on Housing and Neighborhood Improvements for New York City at the request of

Mayor John V. Lindsay. The group's report has been submitted to the Mayor and published.

Mr. Logue resigned his post as Development Administrator to run, unsuccessfully, for Mayor of the City of Boston.

Mr. Logue is presently Visiting Maxwell Professor of Government at Boston University, and Consultant to the Metrocenter at Boston University. He is also a Research Associate at the Institute of Politics at Harvard University.

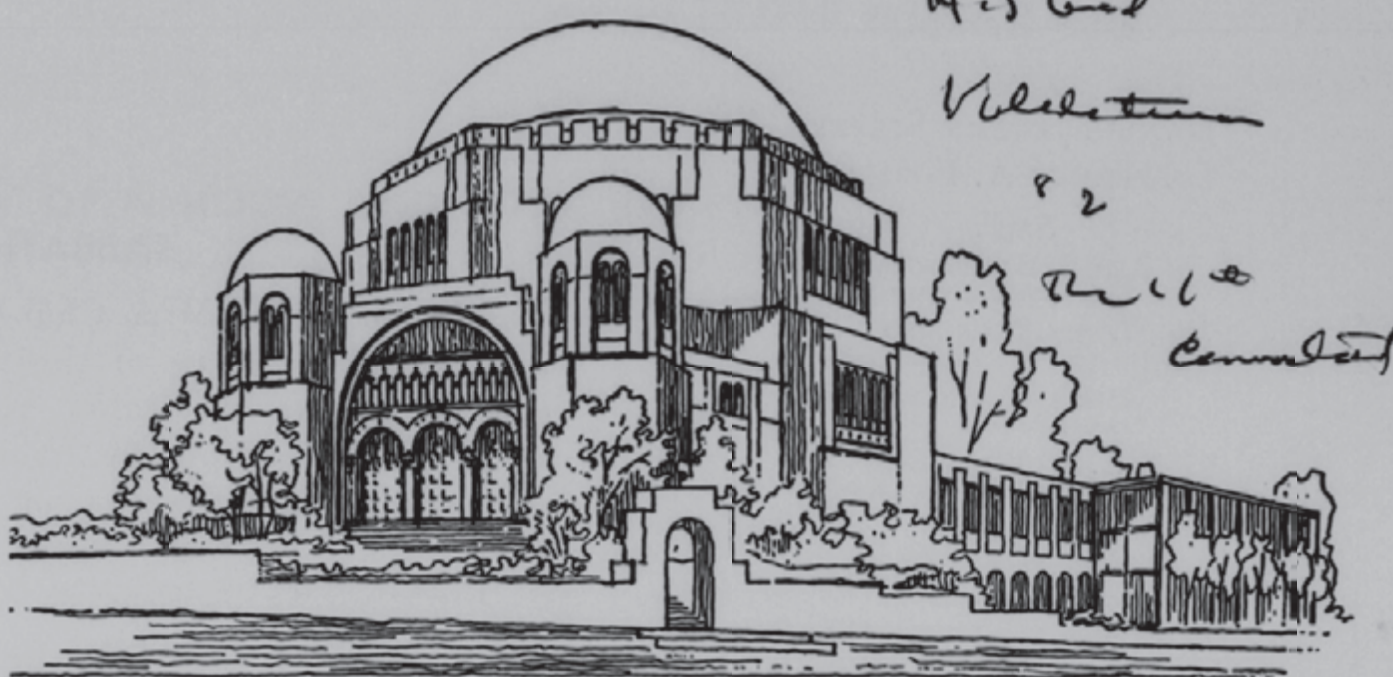

Logue Chides Industry on Urban Involvement

Until Cleveland business and industry become more deeply involved, problems of the inner city will continue to multiply.

This was the warning yes-

terday of Edward J. Logue, a nationally recognized expert on city problems. He has also been a consultant on urban problems for Mayor Carl B. Stokes.

"I'M convinced the new administration wants and has the determination to get Cleveland moving," said Logue. "But it won't get off the ground until there is leadership from the private business community."

Logue spoke at the annual Harry D. and Lillian P. Koblitz lecture, presented at The Temple in memory of the late Mr. and Mrs. Koblitz, members of the congregation.

Logue said Cleveland and almost all other major cities in the country face an era of great difficulty.

"I CAN SEE increasing concern about urban ills and awareness in many sectors, but I have yet to see the commitment necessary to change our cities," Logue added. "I never thought in my adult life that the problem would be as bad as it is today."

terday of Edward J. Logue, a nationally recognized expert on city problems. He has also been a consultant on urban problems for Mayor Carl B. Stokes.

"I'M convinced the new administration wants and has the determination to get Cleveland moving," said Logue. "But it won't get off the ground until there is leadership from the private business community."

Logue spoke at the annual Harry D. and Lillian P. Koblitz lecture, presented at The Temple in memory of the late Mr. and Mrs. Koblitz, members of the congregation.

Logue said Cleveland and almost all other major cities in the country face an era of great difficulty.

"I CAN SEE increasing concern about urban ills and awareness in many sectors, but I have yet to see the commitment necessary to change our cities," Logue added. "I never thought in my adult life that the problem would be as bad as it is today."

As an example, Logue asked his listeners to think of Hough, the other areas of Cleveland and the metropolitan suburban ring.

"Of the three locations, where are the best housing, best educational facilities and the best city services?" asked Logue. "Where are you safer on the streets."

LOGUE SAID everyone knows the problems are worst in Hough.

Cleveland's urban renewal program, although one of the largest in the nation, is still too small compared with the problems of the city, he said.

LOGUE suggested a massive reorganization of the federal tax program to offer incentives for private industry to become involved in urban affairs.

"By making it profitable to be in the city rebuilding process, we could get business to invest in Hough and other areas," he said. "In all probability, the private sector would be more efficient in the rebuilding than local government."

IN THE FUTURE, Cleveland and other cities could start a "fair share" policy in relationship to employment of ghetto residents, he suggested. If ghetto residents had higher incomes,

Since last fall he has been in the private renewal consulting business and is a visiting professor in government at Boston University.

ON SATURDAY, Logue was named by New York Gov. Nelson A. Rockefeller to head the state's recently created Urban Development Corp.

The corporation, with a \$1-billion fund, is expected to generate an additional \$5 billion in private money for rebuilding slum areas throughout the state.

With massive statewide powers, the corporation can override local regulations, such as zoning codes, when it feels this is necessary to rebuild ghetto areas.



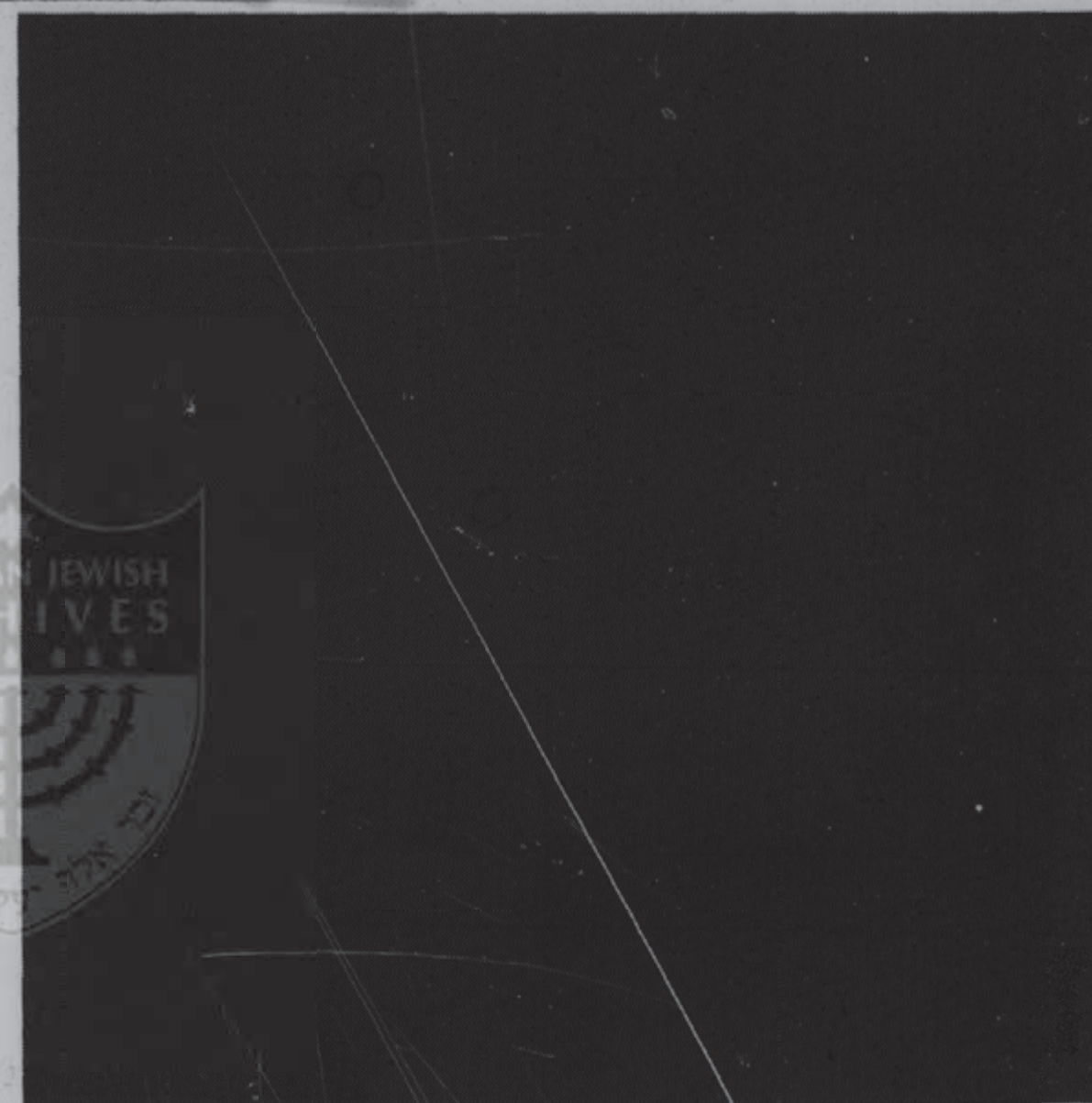
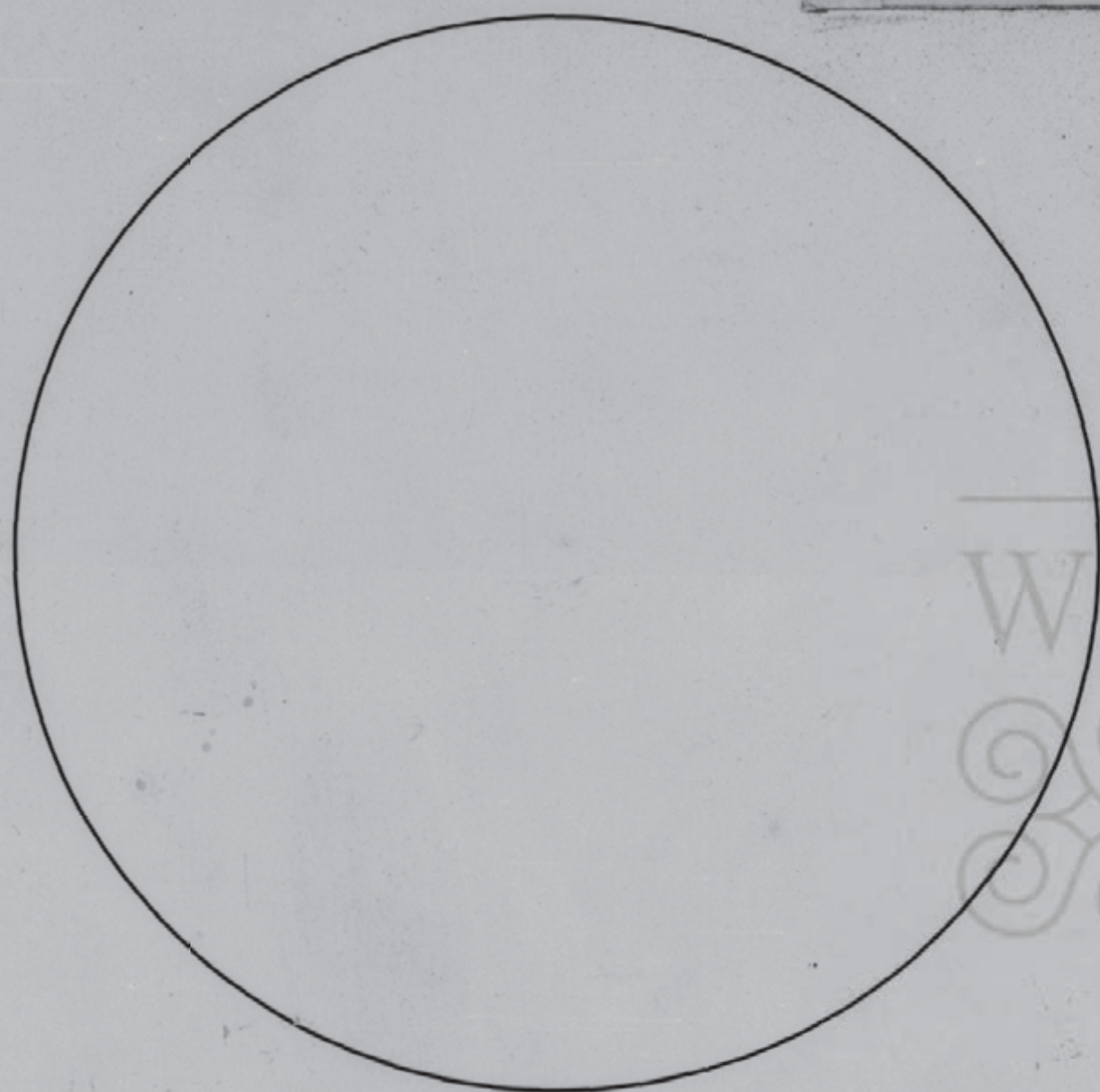
