Dear Rabbi Silver:

As I told you on the phone, my friend, Paul Shetler, and I hope to be in Israel the first week of January and we are interested in the possibility of meeting Father Marcel Dubois, head of the Philosphy Department of Hebrew University. We learned about him from a book review of "In the Land of Israel" by Amos Oz.

Paul, a Clevelander, attends Columbia University (he is much younger than I). He was raised as a Catholic but wandered far from the Church during his teens and early twenties. Then, last summer when he and I were in Rome, he had a series of long talks with Father Orlando Prosperi, an American priest who is stationed there. As a result he seriously considered going into the priesthood and Father Prosperi recommended him/the noted Jesuit theologian, Father John Hardon, in New York. Paul decided not to go any further at this time but he remains interested. I might add that he has one of the finest intellects I have ever encountered and he seems to have read almost everything.

I am sure Father Dubois would find Paul of greater interest than me (based on what I have written), but I, too, have been going through some kind of religious or spiritual quest or at least questioning.

The best days for us to be in Jerusalem are January 4th and 5th.

On Friday, January 6th we hope to go Saint Catherine"s Monastery in the Sinai for the Christmas Eve services--if we can find a way of getting there and the procedure for getting permission to stay in the Monastery overnight. I know two Israeli who have stayed there, but that was under

very different circumstances.

It was good to talk with you. Thank you for your help. And I look forward to seeing you after the trip.







I have enclose reference forms provided by the universities. The University of Denver only asks that I list the names and addresses of persons who will write references if the University feels they are necessary. I have also enclosed a copy of my resume which had been printed prior to my beginning work with the City Prosecutor. Please excuse the handwritten additions; it did not seem necessary to re-draft the entire resume.

My resume obviously shows that my experiences have been varied, a fact which has given me some difficulty in writing responses to the questions asked in the applications. I cannot impose an overall order on a career path which has not followed such a plan. (A good friend, and a journalist, has admonished that to do so would only be contrived.) I cannot say that each of my jobs has moved me inexorably toward an ultimate decision to apply to MSW programs. Since leaving college, however, each of those experiences has given me greater exposure to people and to the range of problems they suffer.

I began law school with the goal of helping people through the legal process. I found the study of law extremely discouraging: it was tedious, excessively formalistic and academic. Above all, I was frustrated by the reliance on precedent as the theoretical basis for all lawmaking, making it loathe to change. Notwithstanding the wisdom and farsightedness of many judicial decisions, it seems to me that there is also a need for more individualized, practical solutions to everyday problems.

Working in the Prosecutor's office has given me the opportunity to see firsthand how the legal system operates, how the theory is put into practice. I don't need to elaborate on how imperfect is our system of justice, especially criminal justice. What troubles me is not so much those imperfections, but the extreme limitations of the justice system as a means through which people can solve their problems. Social work seems to offer greater creative latitude in solving those problems; it is not, for example, constrained by "burdens of proof" or statutes of limitations or overcrowded jails and dockets. There are, of course, problems inherent in social work practice, perhaps the greatest being a lack of sufficient funds. I would like the opportunity to work in a field which includes, broadly, law, social and public policy, and as a social worker to contribute my experience and the expertise I cultivate to help other people better their lives.

Again, I truly appreciate your taking the time to write recommendations for me. I'll let you know the results.
